Public Forum

Pokeno Public Realm Plan

Introduced by Clive Morgan and presented by Donna Tracey and Taljit Heera.

Comprehensive plan for Pokeno for the next 25 years some of which is underway now. The plan includes Pokeno identity, connectivity including future possible rail station, growth, town centre enhancement including Market Square and Pokeno Hub, stream loop, active modes connectivity including cycle tracks and pedestrian access, transport and roading, and economy. The ongoing discussion of the truck stop is still continuing

There were a variety of questions from the 35 members of the public regarding various aspects of the Plan, in particular the spelling of Pookeno as name is gazetted as Pokeno. PCC was advised that name change to spelling of Pokeno is may be applied for by Manu Whenua representatives. The speed limit was also discussed in view of the plan to increase pedestrian access in town Centre and danger from speeding trucks to families

Update on SH1 between Papakura and Drury

Presented by Jenny Wild (Waka Kotahi)

Short update showing upgrading and extending 2 to 3 lanes and allowing for future bus lanes and walking/biking strips and difficulties regarding places (Opaheke) around the stream which are of significant importance. She also advised increasing height of overbridge at Drury to allow electrification of railway lines and widening to allow another 2 lines. She discussed closing SH1 under Park Estate Road to install new bridge. This is easier and safer to close SH1 between Papakura and Drury than do lane changes, etc

Question regarding feral cats and rodents alongside the railway line – advised to phone WDC 0800 number and get an order number or ask for Animal Control

After storm a couple of weeks ago, there is a large pond at the bottom of Hitchen Road which is filled with rubbish. Advised to contact council 0800 number and get an order number

Pokeno Tennis Courts

The concept design has been accepted by Pokeno Tennis Club, and communications shared to Pokeno Committee and Pokeno School.

Pokeno Sports Park - New Stream Commissioning

Works on enlivening the new stream have seen a collaborative effort between the Contractor, WRC, and WDC to ensure great environmental, ecological, and project outcomes are met. McKenzie and Parma have completed the works at the downstream end connecting the new alignment with the existing stream and stabilising the ground both below and above the expected water table. The upstream tie in has also undergone and continues extensive work, filling the existing stream for the first 50m. The remainder of the stream to be made redundant will be completed starting October during Phase 2 of the earthworks. Over pumping is being carried out to ensure continual flow downstream of the

works and the cut-off bund at the upstream tie in has had a channel dug down just above the water level creating and emergency spillway in the event of any heavy rain fall.

Once filling the existing stream for the first 50m is complete the Contractor will progress removing the upstream bund, shaping the channel to final design levels, and placing rock erosion protection below the expected water level. It is expected that all earthworks to shape the final tie in of the new stream is completed before 30 April. Only final rock placement above the water level is to be placed in May under a Winter Works consent.






