PUBLIC FORUM

Laura Kellaway – Strategic Advisor – Heritage (Verbal Presentation)

Ms Kellaway addressed the Board and introduced herself in her role as the first Heritage Advisor to be employed at Waikato District Council. She made the following points:

- Ms Kellaway gave a brief overview of her history with Heritage work in NZ, the previous roles she had prior to joining Waikato District Council.
- Additionally, Ms Kellaway outlined what her role with Waikato District Council was going to be and where she fit within the organisation.

Questions/Discussion

- Ms Kellaway responded to queries regarding her level of understanding of Taupiri Heritage information followed by discussion on the history of Maaoridom and sensitivity of how the Heritage information would be managed.
- It was noted that the Board were yet to discuss how to utilise the information and caretaking over that history taonga.

Wel Green Boxes/Chorus Building/Mural Painting

- Ms Lovell and Mr T George spoke to the Board about the proposed mural (printed copy provided to the Board).
- The Board would like to acknowledge the work of Mr T Turner and expresses their appreciation for the work he has done on this project.

Chorus Building:

- Pictures of the different murals were presented along with the written history.
- Chorus have advised that they would be happy to pay for the mural to be implemented and completed onto their building.

Wel Box

• A further image was presented to the Board for the Wel Boxes.

Proposal for Walkway and Cycle Track in Taupiri

• A further update with be provided to the Board at the next meeting following the meeting that is to be held next week.

Emergency Procedures

• Due to illness, there have been delays, further discussion with the Marae was required. The Chairperson would provide an update at the next meeting.

Neighbourhood Support

• No further discussion was held.

<u>Picnic Tables</u>

- It was noted that this has taken nine (9) months to date, and this was considered too long as it was supposed to be delivered three (3) months ago. There was still no delivery date proposed.
- As advised at the latest Citycare meeting, there was an ongoing delay in installation from October 2022, then February 2023 and to date.
- **ACTION:** The Strategic Planning Manager, Community Growth to follow up with the Open Spaces Team to get a further confirmed date of delivery/installation and come back to the Board.

Ngaruawahia, Hopuhopu & Taupiri Structure Plan/Ngaruawahia Town Centre Plan Update

• There was extensive discussion regarding the Structure Plan and development, including reporting of impacts from the recent development of Button Lane and the potential significant implications of future developments, in particular, around the Bowling Club that had possible cultural implications as a possible Pa site.

- It was noted that the most recent work by Waikato District Council on this has been the cultural assessment that had been done and transport assessment that was currently underway.
- Ms D Tracey, WDC Strategic Planning Manager had been asked to provide an inperson update at the next meeting.
- The Community Board had queries regarding the Development vs the Structure Plan and if any future development was required to adhere to the Structure Plan. How could the community and the Board ensure that these processes were done with the Council? For any development that comes into Council should the community and board not be part of the process and have input into these things?
- **ACTION:** Planning & Policy Manager to come back to the Board with further information re: Taupiri Bowling Club and the potential Development that could be happening behind the club and to confirm whether this is a site of significant.
- **ACTION:** The Board to have an out of cycle workshop in 2 weeks' time (Monday, 24 July) or another alternative date to discuss the Structure Plan further along with marae representatives and Council staff.

- Need to workshop this idea further and look at doing this on the 24 July as per the previous workshop item or organise to have a further workshop on this topic only.
- There was also discussion on the Rugby Club and an information sheet (plans for the Taupiri Rugby Club Changing Sheds) was handed out by the Chairperson. It was agreed to workshop this together with the Recreation Centre/Netball Courts.
