PUBLIC FORUM

Allen Grainger suggested that the public discussion regarding the renaming (spelling) of Pokeno take place at the beginning of the meeting out of the order of the agenda

Moved Allen Grainger

Seconded Ginny Bullock

A large number of the public attending the meeting voiced their concerns that Pokeno has been renamed Pookeno by WDC without any consultation with the residents of "Our Town". It appears that WDC has arbitrarily changed the name without local advice in their publications and on their website.

A lively discussion took place with the majority of attendees against any change to the name spelling. A lot of discussion took place regarding the fact that local Maori were displaced during the 1850's wars and lost their lands as a result. It was recommended that the public should visit the Queen's Redoubt for full information on this subject

Worldwide there are many dialects which pronounce place names slightly differently but this does not necessitate a name change.

Education in pronunciation is important and if Pokeno is pronounced correctly a name change might not be necessary ie Pookeno, Pookino, Pawkeno, or Pokeno with a macron over the "o", etc.

Haupai Montgomery of Ngatai Tamaoho stated that they are happy with Pokeno spelling not being changed and it was agreed that they should have a say in the spelling.

Cr Raumati spoke on both sides of the conversation and agreed that mana whenua should be the decision makers in consultation with the wider community.

Mayor Jacqui responded that the change was made in consultation with Waikato Tainui and the decision was based on discussions back in 2014

Name changes are gazetted by the Geographic Board and this has not happened

Perhaps putting a macron over the "o" would be acceptable to everyone

WDC to come back in the new year with some answers to the public's concerns

OTHER BUSINESS

Helen Clotworthy reminded the public that the AGM and election of new officers will be taking place on Monday 13 February and asked that people think about joining the committee

Brenda Roberts mentioned that the markets are closing after 22 years at the end of December and asked whether it will be possible to use the Hall and car parks. She was advised that the hall is almost fully booked now. However it was suggested that the WDC-owned land in Market Street could be a venue in the short term

There are two entries a top one and the bottom one. The entrances are hard to see. Roading / WDA	February 2024: The current 'No Exit' signs are standard, a sign of a different colour would be non-standard. As Ford Street is a public road, a Residents Only sign cannot be erected.

Capital Projects Update (January 2023)

Playgrounds and Sports Parks

Pookeno Sports Park - Bulk Earth Works and Carpark Construction

Bulk earthworks are complete with minor tidying up of the landscape fill area, the only outstanding item onsite and for consent compliance close out inclusive of the geotechnical completion report.

The carpark and swale drain construction is now underway. February will focus on kerbing, final pavement construction and landscaping and all works are scheduled for completion by the end of February 2024.

Roading

Munro Road Resilience Improvement

This involves upgrading the culverts beneath Munro Road between Pokeno Rd and Huia Rd, and raising the road to enhance its resilience against potential floods. Also, we are adding a footpath to provide walking/cycling access to the adjacent park.

The consent application has been under evaluation for the past five months, and the works have been tendered.

Physical works are scheduled to start in late February, where the road will be closed off in its entirety.

Pookeno Main Street Re-development

The Main Street project is starting this week, with substantial works underway after Waitangi Day as requested by local businesses. Targeting completion by end of July 2024.

Helenslee Road Minor Improvements

Pavement construction design and stormwater design is completed. We are working towards the resource consent application and are looking to submit the application by mid-February. We are aiming to start drainage works by mid-February and then following on to the earthworks and pavement work following the completion of drainage work and getting the approval of the resource consent.

Pookeno Road - Bridge to Munro Rd

The project has split into two parts and is prioritising to deliver the first part of the project in the current 2023-24 construction season, and are waiting for resource consent to be submitted and approved. First part of the project is half the length of the roading section, and the footpath alongside as well as shoulder widening to improve the safety.

For the second stage the design for the main bridge, pedestrian bridge, and remaining half of the roading will be done with the aim to complete the physical works of the bridges in the year 2024-2025, subject to the design outcome.

Great South Road and Pookeno Road Intersection Upgrade

A new roundabout is set to be constructed at the intersection of Pookeno Road and Great South Road as part of an upgrade project. Originally programmed to commence by the end of January, the project faced a delay due to budgetary constraints prompting a review of its design. Presently, the project is on hold pending resolution of the budget issue.

The project is being delivered by WDA, and the project awaits instructions to commence work. However, the shortfall in the budget has necessitated a pause in proceedings. Following the design review, it was determined that the estimated cost exceeds the allocated budget by approximately 1.7M. Consequently, efforts are underway to draft a report for the Council, seeking additional funding to enable project completion.

Pookeno Toilet Replacement

Offsite construction of the toilet block is complete. Site works will commence once building consent has issued, likely to be February - March 2024.
