Te Kauwhata Works & Issues Report: July 2021

The report was received [TKCC2108/02 refers] and the following discussion was held:

- Mr Hinton advised that the installation of the dog agility equipment and park benches have been delayed due to wet ground conditions.
- The Blunt Road walkway will be constructed between October 2021 and April 2022(weather dependent).
- The Travers Road walkway loop has been completed.
- The Council's Community Facilities team was developing a draft Domain Plan for consideration by the Community Committee, noting\$20,000 has been provided for this in 2021/22 (Year I) of the Long Term Plan 2021-2031.
- Feedback on the Te Kauwhata Innovating Street project has been extended from 6 August to 13 August 2021.
- Works on the Rangiriri Cemetery have been delayed due to the wet weather.

<u>Discretionary Fund Report to 20 July 2021</u> Agenda Item 7.2

• Three Waters Reform — Council has till the end of September to advise Government of whether it is formally 'in' or 'out' of the proposed reform framework.

 Update on Representation Review - The initial proposal for the representation review was adopted by Council on Wednesday 7 July 2021. The consultation period opened to the public on Wednesday 14 July 2021 and closes on Friday, 20 August 2021. Committee members will consider making a submission.
