- Cr Patterson Acknowledged Ms Kirkwood's involvement with Manatanga Mana Maungai Wananga. There had been a heavy workload of workshops during lockdown.

Consultation process for the representation review were robust and the result was constructive and positive. Thanked the Ngaruawahia Community House for their work during the Super Saturday vaccination drive.

- Ms Rice, Mr Ayres, Ms Firth, Ms Kirkwood Noted the success of the Ngaruawahia drive-through vaccination station on Super Saturday.
- Mr Ayres Noted the need for discretionary fund applications.
- Ms Morgan Thanked the Ngaruawahia Community House for their help on Super Saturday vaccination drive. Questions raised regarding whether the board will provide a subsidy for the Ngaruawahia Pool. The board was supportive for the ongoing subsidy for the pool.

Turangawaewae Kohanga Reo and Nga Miro Medical Centre were working together for processes to keep staff and children safe. Staff will be tested weekly until they are vaccinated. Services were working quickly to adhere to the Government mandate for vaccinations for kohanga reo staff.

 Ms Kirkwood – Had been involved in Manatanga Mana Maungai Wananga which is a kaupapa looking at civic education for Maaori. They support potential candidates for local government elections in 2022, and campaign support teams. Wananga series will start in November 2021 and finish in October 2022.

Also been involved with the Comfort Homes Charitable Trust. They were wanting to create and support a kaupapa to look at the entrance ways to Ngaruawahia. Comfort Homes Charitable Trust will attend a Community Board workshop or meeting in the future. Noted they can get involved in the Ngaruawahia High School project to create welcome signs for the town.

# Estimate | Wifi & Camera Upgrades Inc ANPR to VIBE

#### Work Summary:

Following the recent upgrade of the CCTV Recorder at the Ngaruawahia Police Station we have found the oldest PTZ cameras are not able to be upgraded to a version of firmware that is compatible with modern recording systems. As such these 3 cameras will now need to be upgraded. This is inline with expected product life as these cameras have been in place for the past 13 or 14 years.

In addition to this parts of the original wifi network also need upgrade and as these parts are of minimal cost we recommend performing this work now also. This will bring the entire network into line with the Ubiquiti wifi equipment that has been used to replace other parts of the original equipment that has failed to date.

Once the wifi system is upgraded we will then be able to see if the 4 other existing cameras can be connected to the new recorder.

Some of these cameras were installed in 2012 so may not be compatible and the most recent camera was installed in 2015 which should be compatible







# I. EXECUTIVE SUMMARY

The purpose of this report is to seek the Board's approval to the proposed schedule of Board meetings for 2022.
