Report title Objection to Menacing Dog Classification -

Caine Smart

1. Purpose of the report Te Take moo te puurongo

Providing the Regulatory Sub-Committee background on the classification of a menacing dog to enable them to hear the objection received and subsequently determine whether to uphold the classification.

2. Executive summary Whakaraapopototanga matua

Section 33A of the Dog Control Act 1996 ("the Act") allows Waikato District Council ("Council") to classify a dog as menacing if the dog is considered to pose a threat to a person or other animal due to observed or reported behaviour (sections 33A and 33B of the Act annexed as Appendix 1).

"Luna-May", a female black and tan, Rottweiler, aged 4 years 7 months, at the time owned by Caine Mason-Kelehe Smart (Mr Smart), and known as Luna, was involved in an incident on 25 November 2021 where Luna rushed Haley Broughton (Ms Broughton), her son and her nephew.

Luna was free to leave her property and the rushing happened on Jellicoe Avenue, Tuakau in a public place. As a result of this, an infringement and a menacing classification were issued.

In accordance with section 33B of the Act, Mr Smart has objected in writing to the menacing classification within the statutory time frame.

Council believes the behaviour displayed by Luna during the reported incident is concerning and without substantial behavioural correction poses an ongoing risk to the safety of the public.

Council also acknowledges the desire of Mr Smart to have the dog re-homed to a more experienced owner, which is commendable. Council has been advised that since the incident and whilst awaiting the hearing, Luna has now been rehomed.

Council submits that regardless of rehoming, Luna should remain classified as menacing. The menacing classification is the only means by which Council can make any future owners throughout the country aware of the current behaviours, noting further adoptions could happen at any time or stage outside of our district, with no way to be sure any required training would be provided, or indeed if provided, be successful in reducing the risk Luna poses.

3. Staff recommendations Tuutohu-aa-kaimahi

That the Regulatory Sub-Committee confirms that, having considered the objection and all the evidence provided, the Classification of Luna under section 33(A)(I) of the Dog Control Act 1996 be upheld.

4. Background Koorero whaimaarama

On 25 November 2021, Council After Hours service received a complaint from a member of the public, Ms Broughton. Ms Broughton was walking with two children when a black/brown Rottweiler chased the children from behind. Ms Broughton was on a public footpath at the time of the incident. (Service Request annexed as Appendix 2).

Ms Broughton screamed and shooed the dog away from the children. The call centre operator who took the call, could hear the children in the background and has recorded into the Service Request what she could hear in the background at the time of the call (in Appendix 2, page 2).

Officer Moore received the job from the call centre. Officer Moore's statement and pocketbook notes relating to this matter are annexed as Appendix 11. Officer Moore rang and spoke with the complainant to confirm what had happened. Officer Moore then attended the property she suspected the Rottweiler had come from, 11 Jellicoe Avenue Tuakau. This dog owner explained that his dog had been inside the house all evening. Officer Moore explained that she was following up on a rushing complaint and was gathering information. She then returned home.

The next day on 26 November 2021, Officer Moore contacted Ms Broughton and compared the description of the attacking dog with the dog at 11 Jellicoe Avenue Tuakau. Officer Moore concluded that the Rottweiler at 11 Jellicoe Avenue did not commit the offence. Officer Moore then visited 31C Jellicoe Avenue, Tuakau and the dog owner, Mr Smart admitted that it was his dog that had committed the offence.

On 29 November 2021 Officer Moore obtained a Witness Statement from Mr Smart regarding the incident. (Witness Statement annexed as Appendix 3). Mr Smart explains the behaviour exhibited by Luna as play behaviour. Mr Smart believes the behaviour of Ms Broughton led to Luna playing a game of chase.

On 7 December 2021 Officer Twiss took a witness statement from Ms Broughton. (Witness Statement annexed as Appendix 4). In this statement Ms Broughton describes the behaviour exhibited by Luna that led to her feeling the children were threatened.

On 21 December 2021, Officer Moore referred the incident to the Team Leader of Animal Control, who holds delegation to make decisions around enforcement action, including classifying a dog menacing under the Act (Decision Making Criteria annexed as Appendix 5)

The decision was made to classify Luna as menacing, and Council issued a notice of menacing classification dated 21 December 2021 and posted the notice to the dog owner Mr Smart. (Classification annexed as Appendix 6). A section 52(A) infringement was also issued on 21 December 2021 (Infringement annexed as Appendix 7).

Following receipt of the notice of menacing classification, on 23 December 2021 Mr Smart lodged a written objection to the dangerous classification with Council. (Objection annexed as Appendix 8). Council received the written objection within the prescribed 14-day objection period.

Having received Mr Smart's written objection to the menacing classification, the objection now needs to be determined in accordance with section 33B of the Act (sections 33A and 33B of the Act annexed as Appendix 1).

Discussion and analysisTaataritanga me ngaa tohutohu

The evidence provided by Ms Broughton by way of witness statement confirms that the dog showed aggressive rushing behaviour towards Ms Broughton and the two children while they were on a public footpath. Council considers that this behaviour is a danger to the public.

In Mr Smart's objection, he argues that Luna was being playful, but he does admit the incident took place. Mr Smart has taken responsibility for the situation and is clear that he does not believe that Luna would exhibit any aggressive behaviour towards people.

Council commends the actions of Mr Smart to ensure that Luna is rehomed to an owner in a better position to provide for Luna's requirements. Mr Smart has confirmed with Officer Moore that Luna has already been rehomed out of Mr Smart's care into the Auckland City Council area (Appendices 9 and 10). The concern held that a menacing classification would prevent rehoming appears on the face of it to no longer be accurate.

Council also notes that in his objection, Mr Smart explains that he had always made it a priority to have Luna muzzled when walking on a lead, due to Luna's anxiety and her not being good around other dogs.

Council notes that the legal effect of the menacing classification (refer Appendix 6) is simply to formalise the wearing of a muzzle as a legal requirement whilst in a public place, and to require Luna to be desexed.

Another benefit of the menacing classification is also to inform any future adoptive owners, in other territorial authority jurisdictions, of the history of Luna, to ensure appropriate precautions are taken wherever in the country Luna might be.

On balance, Council believes that the menacing classification remains appropriate for Luna.

5.1 Options

Ngaa koowhiringa

The Committee has two options in considering the objection to the menacing classification:

- 1. Uphold the classification of the dog as menacing; or
- 2. Rescind the classification.

This menacing classification will reduce the risk posed to any member of the public by requiring Luna to be muzzled when in public. The position of the Animal Control Team on behalf of the Council is that the evidence substantiates the classification of Luna as menacing under the Act. *Option 1 is recommended*.

If the Regulatory Subcommittee rescinds the classification, there is a risk that further breaches of the Act will occur, and members of the public could be further threatened or even harmed. *Option 2 is not recommended.*

Menacing dogs

Heading: inserted, on 1 December 2003, by section 21 of the Dog Control Amendment Act 2003 (2003 No 119).

33A Territorial authority may classify dog as menacing

- (1) This section applies to a dog that-
 - (a) has not been classified as a dangerous dog under section 31; but
 - a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of—
 - (i) any observed or reported behaviour of the dog; or
 - any characteristics typically associated with the dog's breed or type.
- (2) A territorial authority may, for the purposes of section 33E(1)(a), classify a dog to which this section applies as a menacing dog.
- (3) If a dog is classified as a menacing dog under subsection (2), the territorial authority must immediately give written notice in the prescribed form to the owner of—
 - (a) the classification; and
 - (b) the provisions of section 33E (which relates to the effect of classification as a menacing dog); and
 - (c) the right to object to the classification under section 33B; and
 - (d) if the territorial authority's policy is not to require the neutering of menacing dogs (or would not require the neutering of the dog concerned), the effect of sections 33EA and 33EB if the owner does not object to the classification and the dog is moved to the district of another territorial authority.

Section 33A(3): amended, on 1 November 2004, by section 10 of the Dog Control Amendment Act 2004 (2004 No 61).

Section 33A(3)(c): amended, on 28 June 2006, by section 13 of the Dog Control Amendment Act 2006 (2006 No 23).

Section 33A(3)(d): added, on 28 June 2006, by section 13 of the Dog Control Amendment Act 2006 (2006 No 23).

33B Objection to classification of dog under section 33A

- (1) If a dog is classified under section 33A as a menacing dog, the owner-
 - may, within 14 days of receiving notice of the classification, object in writing to the territorial authority in regard to the classification; and
 - (b) has the right to be heard in support of the objection.
- (2) The territorial authority considering an objection under subsection (1) may uphold or rescind the classification, and in making its determination must have regard to—
 - (a) the evidence which formed the basis for the classification; and
 - (b) any steps taken by the owner to prevent any threat to the safety of persons or animals; and
 - (c) the matters relied on in support of the objection; and
 - (d) any other relevant matters.
- (3) The territorial authority must, as soon as practicable, give written notice to the owner of-
 - (a) its determination of the objection; and
 - (b) the reasons for its determination.

Hayley and kids were walking when a black/brown rotti chased the kids from behind. Hayley screamed and shooed the dog away. Neighbours went out and taken the dog away but not sure where it belongs. Hayley sad it maybe from the property on the bend of Jellicoe Avenue, near 17 so looking at the map probably 28 Jellicoe Avenue. No injury, no bite, the kids are traumatized, crying on the background and i can hear the kid say "he could have died" so Hayley is doing her best to comfort her 8 and 7yo kids chased by this dog. What were you doing? And who were you with? (Walking running cycling etc) My partner and I were taking our I year old daughter out to the front property to play on her remote control ride on car. Unfortunately, as we opened the gate and Luna took the opportunity to bolt out. I quickly tried to grab Luna but she had already gone. She first went to my neighbours house however quickly swung around up our long driveway - Once I got to the top of the driveway she saw me and again bolted. Absolutely lost all focus and ran. I was running to but could not keep up. I saw on the corner 3 kids walking (at the time I thought it was children, mostly due to the way they all reacted) Luna would have actually ran passed them all – she did run past them all for a moment but when the children screamed she almost U turned around and went back to them. For a moment while screaming they ran. Of course Luna thought it was a game and to chase. I could see her from where I was, her getting down on her two front legs with her backside up. Known as the play stance. By this time I had got there (Note that it would have been less than 10 seconds from when Luna had reached them that I got there). One boy was terrified hiding behind the powerline foundation crying calling for me to help. I got to the mother who had her younger son between her body shielding him. I said "it's okay, she's excited, calm down". Again, thinking they were children. This was this moment I realised one of them was an adult when she replied to me "don't tell me to calm down". By this point 3 or 4 of the neighbours had come out. It was when a neighbour close came out her gate that Luna got distracted and ran to her. Whilst this was happening the mother was yelling "Somebody control your dog". Over and over in a panic. When Luna ran towards the neighbour coming out the gate it was now that I managed to catch Luna. **It's a bit fuzzy what was said exactly by the lady with her children because as you could imagine it's not a really nice memory to have** While I had Luna the mother was walking in circles back and forward pointing at Luna "Someone come get your dog, this dog needs to be restrained" Etc Etc. I admitted instantly and said she was mine and how sorry I was. She replied "Not cool man, not cool". I asked her "Did she get them". "She said no, but she would have". Now it's at this moment that one of the neighbours started talking to me about "you have to be careful" etc etc - I wasn't really paying attention to her. There was a Rotty across the road being walked and Luna was hard to hold onto at this point — specially with all

the people around etc — another neighbour came out and approached the mother asking what was
happening and she was still yelling etc. At this moment I thought it was best to get Luna out of the
situation. Because she is a small Rotty X I picked her up and just walked her home.
Where/when did you first notice the dog? (Where was it? What was it doing? How far away
from you was it?) Luna came up behind them as they were walking in the same direction. They
only noticed her once she was running past them.
What was the dog doing when you first noticed it? (What was its attitude like?)
They would have noticed her when she ran past - she would have been excited to be free.
Running from me.
How/When/Where did the dog approach you?
The dog approached them when they screamed when she was running past - Luna swung
around.
Was it wearing a muzzle? No. Usually she is always in a muzzle due to her anxiety
and aggression with other dogs.
What was the dogs behaviour? (Barking, snarling, growling, lunging, attempting to bite etc)
From what I could see from the distance when she first reached them. And noting I was only 10
seconds or even less behind her. She swung around and thought it was a game when they ran
for that moment. She was getting down on her two front legs (play stance). Obviously I wasn't
close enough to hear if she was growling etc. But I don't doubt she was growling. When Luna is

at home playing with our other Rottie Cleo they growl and nip eachother. Also anyone who
owns a Rotty knows you do not play rough house with them because they are super rough. If
Luna thought this was an invite to rough house with her she could have nipped - but as the
owner has admitted Luna (allegedly) only got clothing - now I don't know if that was through
biting, from what I could see, I could only see her jumping on them so it could have been
through claws.
Did the dog make contact? Who/what did it make contact?
She allegedly made contact with one of the child's clothing.

If the dog has made contact - Where on the body? What injuries were caused? Was
medical or veterinary treatment sought and if so what was done?
Unsure
Was it with its owner? Was it on a lead or not under control? What action did they
take?

Not on lead or muzzled due to her getting out by surpirise. Action taken was to get her back by
hand and deal with the situation calmly. I.e there was no abuse or fighting on my half.
What action did you take? (During and after the incident?)
She eventually told her child to stop running. She put her younger boy between her and began
to yell for help and shoo Luna away while yelling at her.
What impact has this arrest had an your mantal wallbaing?
What impact has this event had on your mental wellbeing?
I could imagine the children are very upset. They looked terrified and I feel awful about that. I'm
sure they will have a long time until they can trust dogs.
Are you concerned for your safety or the safety of the community because of the
actions of this dog? -
Luna is no threat to society – we have learnt the lesson to be more careful so she doesn't get
out. Even so – no aggression towards people.

Any further detail you would like to add?

What happened was not nice for the children and I am truly sorry to those boys. I really hope in time they will heal and trust animals. I've come to the conclusion that either the mother has no experience with dogs or she has had an incident with a dog when she was younger. I say this because I don't think she dealt with the situation very well at all.

The anger towards me I understand – I have my own young daughter and I would feel the same way. However, if a stray dog had run passed me with my daughter it would have never come to the fiasco that it did, I would have dealt with it much different but also I understand that not everyone has the knowledge of what to do, and I also understand that it was completely our fault that she was out in the first place.

Luna is currently in training with Jess Beer – a certified trainer. The reason why we put her in training is obedience problems (being a young dog) and she has had issues with aggression towards other dogs. NOTE: Other dogs only. I have plenty of nieces, nephews and my own daughter and she has NEVER shown aggression towards them. Even people – she has never ever shown aggression towards people. Our trainer has let us know that Luna shows signs of anxiety and the idea was if the training didn't work that she was actually going to be medicated.

Since this situation has happened my partner and I have decided that Luna is unfortunately too much for us to handle – we love her and want to give her the best chance she can have with someone who has more experience with her breed.

We have submitted her to Rottweiler Rescue however they won't take her on if she has a "danger to society" certificate on her.

We are pleading that Luna be given a second chance to be rehomed and loved – the mistake of us leaving a gate open, she shouldn't have to suffer for that mistake but also the HUGE misunderstanding of her behaviour been mistaken for aggression by a stranger.

A detailed description of the dog(s) -

- Colour (include any patches etc.).
- Size small, medium, large.
- Gender (if known).
- If the dog was wearing a collar/tag.
- Length of coat smooth, medium, longhaired.
- Breed an option is to say what type of dog it is like if you are unsure of the exact breed.
- Body type stocky, skinny, tall, short.
- Face shape pointed or floppy ears, long or short nose, floppy jowls etc.
- Any other distinctive details you noticed.

Also, in your account of the incident include -

- The location of the incident.
- How the incident came about.
- How you came to be in contact with the dog When and how did you first notice it?
 Where was the dog?
- The dog's behaviour Was it growling, barking, lunging, attempting to bite?
- If the dog has bitten Where? When? What the injuries are. Was medical or veterinary treatment sought and if so what was done??
- Was the owner of the dog or anyone else present? If so, what action did they take regarding the incident?
- Was anything said by anyone?
- What action you took What did you do during and after the incident?
- Where did you last see the dog? Did it run off? If so, in what direction?
- How did the incident come to a conclusion?

It is important that you initial or sign each page of the statement, and date it.

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with all of the matters in paragraphs (a) to (c) above.

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c) above.

If the dog is in the possession of another person for a period not exceeding 72 hours, you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. To whom it may concern,

I have recently received a letter from the Waikato District Council in regards to our family dog Luna. A notice to classify her as a menacing dog. I would like to dispute this title.

Luna has been with us since she was a puppy – when we got Luna my partner was 6 months pregnant, and we already had a 2-year-old Rottweiler with us. So as you can imaging Luna only had 3 months or so training with us until baby was born and then on most of the attention was put on to our baby. Because of this Luna has had lack of training – and still been under 2 she is still considered a puppy in regards to her rottweiler breed. She gets over excited and is a jumper.

Luna isn't the best with other dogs, because of this we always made it a priority to have her muzzled when walking her on lead – just in case other dogs off lead would approach her. She is very wary of other animals and in fear sometimes snaps. The only other animal that she is generally okay with is our other Rotty (her sister).

We decided to get a personal trainer in a couple of months ago to help us out a bit – the training was coming along well and Luna has seemed to calm down. I have a full report explaining Luna – in the report it does tell us that Luna could be possibly suffering from anxiety. When she is off the property at times she becomes quite anxious and sketchy of her surroundings. Again this is something that we were working on which was coming along quite well – Luna began to focus more on her surroundings, enjoying her walks – not so anxious.

The unfortunate day that Luna slipped passed us through our gate was myself and my partner's mistake. When she got out the gate all progress with her training, we had done had gone out the window. She completely lost focus and just ran. I chased her a good while down the street and had her in my view the whole time. When I saw the mother with her 2 children up ahead for a moment, I was relieved because I thought perhaps Luna would get distracted by them. For a moment Luna looked as though she was going to run directly past but swung around when one of the children got a fright and screamed. Now from this moment – what I could see was Luna trying to be playful. She was getting down on her two front legs and jumping up at them (the play stance). One of the boys ran behind a pole while Luna focused on the mother and her other son. She was yelling and waving her hands etc to get her away. Luna thought this was a big game. Now allegedly Luna ripped a hole in one of the boys clothing. If she did this, it would have been because Luna was jumping up on them, not because she was biting. I have no doubt in my mind that if a Rottweiler wanted to aggressively bite a person, it would without hesitation. Luna has NEVER EVER been aggressive to any child. I have a one-year-old daughter at home and she is gentle. I have nieces and nephews all under the age of 8, the worst she will do is jump up on them out of excitement.

From there I eventually got Luna – I apologised sincerely to the mother, I felt awful that Luna had terrified her children and I really do hope in time the children will again trust dogs. The mother wasn't having it – which I understood, I would be angry as well in the same position. Having dogs and a child I can see from both perspectives. HOWEVER. I must say I do think that the mother escalated the situation. I understand that not everyone has the knowledge on dogs and what to do if one approaches you. I am approached by dogs quite often on the street with my daughter and never have reacted the way she did, in panic. I also have to ask the question – would she have reacted the


same if a fluffy Labrador ran passed – Luna being the breed she is, I think unfair judgement is passed on her all the time.

Since the incident happened. My partner and I have decided that Luna needs a new forever home, perhaps a family with no other animals, and a person who has experience with the breed, someone who has plenty of time to put the training in. We were going to pass her onto Rotty Rescue to rehome her but they will not take her if she has this menacing title. We have found it very difficult to find her a home with the obedience issues let alone a menacing title. We are pleading that Luna doesn't get given this title so that she can have the second chance she deserves with a new family. Luna shouldn't suffer from consequences of our honest mistake. I truly believe she is a good, gentle dog that has slight issues that can be altered in training. None of those issues being aggression towards people — I can't stress this enough!

I have contacts that can be almost like a character reference for Luna – plenty of family members and friends who frequently I visit with Luna and they visit us. The trainer – who can give the full report on Luna's behaviour, the breeder... Who owns Luna's mother and knows the father – they both hold no aggression in their family line and out of all the litters, there have never been any aggressive dogs.

Lastly I think it is also worth noting that while walking my other dog Cleo on the 08.12 the mother of the children drove past me in her car yelling abuse. "F**k you, still walking that dog after what it did". She said a couple other things, but I couldn't really hear what she was saying. I just stood there, listening. The last thing she said was "I hear you have a baby, I hope you dog f**ken gets it". When she said this I walked towards the car to talk to her she then again swore at me and drove off. How a mother can say that to another parent about their child I have no idea, given any situation this is not okay. A police report was filed as I fear that she will approach my partner while walking my other Rotty and baby on the street. I genuinely believe, based on that this isn't a mother who is wanting an "unsafe" dog off the street, this is a person who is angry and is wanting to get some sort of revenge. She does not care about the safety of others.

I look forward to meeting with whoever I need to and will happily answer any further questions and read this letter. I would also like to say – even if we were given the terms of the menacing title being removed if Luna is passed on to her new forever home to a much more suitable person. We would be okay with that, that's all we want is Luna to have her new home.







I would like to report something - not sure if it at all matters to Animal Control or Waikato Council.

I was walking my dog Cleo (our other rotty) today just now and the lady drove past and recognized me. She stopped the car in the middle of the road about 8 meters ahead. Cleo was sniffing so I had stopped and was just standing there. I couldn't understand most of what she was saying "F**k this and f**k that". What i did hear was "You still walking that f**king dog after what happend". Then she said something about kids and said "I see you have a baby, I hope it F**king gets it". As well as Rotty Rescue awaiting an update we have the breeder looking for a new home for her.



Officers Statement – ACO 25, Officer Moore

On the 25th of November 2021 a service request DOGS1160/22 was logged via the Waikato District Council After Hours Call Centre. This request was assigned to me ACO 25. The request was logged as a Current attack. This is **Appendix 2** of the committee agenda.

On the 25th of November 2021 I called the victim Haley Broughton (Hayley), she did not answer her phone so I left a voice message. I called a second time, still no answer so I left another voice message. I called a third time and Hayley answered her phone.

Haley explained that her and her two kids had been rushed by a Rottweiler on Jellicoe Ave. The Rottweiler did make contact with one of her kids clothes but didn't make contact with their skin.

I asked Haley if she knew where the Rottweiler had come from, she believed it had come from a property on the bend on Jellicoe Ave. I told Haley Broughton I would be visiting the property tonight to seize the dog and conduct an investigation. I called ACO23 who was the on-call officer for South to attend the property with me. As I was waiting for ACO 23 to pick me up from my house I had a look on the Council PnR system by searching for "Rottweiler on Jellicoe Ave". I found a Rottweiler at number 11 Jellicoe Ave and I wrote the address, rottweiler details and dog owners' name in my pocketbook. All of my pocketbook notes on this matter are **attached** to this statement.

ACO 23 arrived to pick me up we drove up to Jellicoe Ave in Tuakau. We arrived at number 11 Jellicoe Ave and parked at the front gate, it was dark at this stage. I couldn't see a Rottweiler on the property or hear any dogs barking. ACO 23 and I didn't want to enter the property in the dark as there was very poor lighting, we could see the house was to the back of the property and a second gate in front of the house. ACO 23 tooted the horn, no one came out. I looked on NDD for the dog owners contact phone number and I called both Dog owners phone numbers numerous times but no one answered. A male came out and greeted ACO 23 and me at the gate. I got out of the truck and introduced myself and ACO 23 I then explained that a Rottweiler had rushed out of a property at a lady and her two kids near this address 11 Jellicoe Ave. The male was adamant it wasn't his dog. His Rottweiler had been inside all night. I explained that I am just following up on the details provided to me by the victim. I told the male at this stage I am conducting an investigation and if it does turn out to be his Rottweiler that rushed at the lady and 2 kids then I will be taking some sort of enforcement action infringement and possibly menacing classification. The male understood and was happy to comply. He asked if we wanted to see his Rottweiler I said yes, and he bought him out to the front gate he was as big male with a tail and a brown leather collar on.

On the 26th of November 11.02am I called Haley to check on her and the kids and to gather some more information. Haley said both the kids are still very upset and scared it was a rough night trying to console them. I asked Haley Broughton if she could describe what the Rottweiler looked like. Haley said it was young, male, big head and had a tail I asked if the dog had a collar on Haley said yes, the collar had 2 colours possibly white/ blue. I asked Haley if there were any distinctive landmarks from where the Rottweiler had come from. Haley said yes, a tall back fence and a green sign saying "Abby way" in the carport. I took notes in my pocketbook. I asked Haley if the Rottweiler had come form number 11 Jellicoe Ave, she said no that dog was behind the fence. I asked Haley if she would like to do a witness statement so that I can take some sort of enforcement action, she agreed. I asked ACO 11 to take the witness statement for me ACO 11 agreed. I ACO 25 searched on google maps street view on Jellicoe Ave for a property with a black fence and a property with a carport to identify the property number I found a carport at 44 Jellicoe Ave and a black fence at 46 Jellicoe Ave and wrote it in my pocketbook. I looked up both addresses in PnR but both addresses

didn't have a Rottweiler on the property. I then Searched for a Rottweiler on Jellicoe Ave in PnR 4 entries came up. I eliminated two of the entries and the last two entries were for 31c which recorded two female Rottweilers on the property. I attended 31c Jellicoe Ave with ACO 23 we arrived at the property at 12.44pm. Knocked on the door, a male answered I introduced myself and ACO 23. I explained that a Rottweiler had rushed at a lady and her kids last night, 25 November 2021 the male Caine Smart (Caine) confirmed that yes it was one of his Female Rottweilers called Luna-May that had gotten out of their property and chased a lady and her kids. Caine understood the seriousness of the situation and took full responsibility for what had happened. I told him at his stage I am conducting an investigation and he could be receiving infringements and possibly menacing classification. Caine Smart told me Luna has been going to behaviour training as they have had issues with her and there other Rottweiler fighting. They are also looking at possibly rehoming Luna-May. Caine has asked if he can do a witness statement, I said absolutely I will email one through to you. I have put notes in my pocketbook of our conversation. Visited 11 Jellicoe Ave with ACO 23 and talked with Male advised his Rottweiler does not match the description and I will be taking no further action. Male very happy.

- 29 November 2021 emailed Caine a witness statement to fill out. Received witness statement back from Caine, which is at **Appendix 3** of the committee agenda.
- 31 November 2021 Haley did witness Statement with ACO 11. This is at **Appendix 4** of the committee agenda.
- 3rd December 2021 received email form Caine asking for an update and letting me know that he has reached out to Rottweiler rescue to take Luna- May. I emailed back explaining it can be a long process and I will be in contact once a decision has been made. This correspondence can be seen in **Appendix 10** of the committee agenda.
- 8th December 2021 received an email from Caine letting me know he had, had a confrontation with a female on Jellicoe Ave when he was out walking Luna-May he believes it's the female victim that his dog Luna-May had rushed at. I advised him to contact the police. This correspondence is included in **Appendix 10** of the committee agenda.
- 20th December 2021 I called Caine to advise that I will be issuing Luna- May with a Menacing Classification and an infringement. This is recorded in my pocketbook notes.
- 21 December 2021 received an email from Caine asking if he can contest the Menacing Classification. I emailed him back and said yes you can contest the menacing classification within 14 days of receiving the menacing classification. Menacing classification for Luna- May issued and sent via tracked mail. A copy of this classification is included as **Appendix 6** of the committee agenda.
- 23 December 2021 received an email form Caine with a menacing dispute letter which is at **Appendix 8** of the committee agenda.

5th of January 2022 I forwarded the dispute letter for Luna- Mays menacing classification to Tracey Oakes and Amanda Davis.

10th January 2022 received an email from Caine following up that I had received the Menacing classification dispute letter and updating me that Luna-May has been rehomed to a farm in Waimauku and that the new owner is aware of everything and understands that he is disputing the menacing title. This chain of correspondence is at **Appendix 10** of the committee agenda.

 11^{th} January 2022 I emailed Caine back saying yes, I have received the dispute letter and I have forward it on to my Team Leader.

On 4 March 2022 I spoke with Caine to confirm Luna's microchip details and the new owner's details. See pocketbook notes in the committee agenda at **appendix 9.**
