PUBLIC FORUM

Community Presentation

Mr Grainger discussed Munro Park. He advised that the proposed plan is a concept at this stage. WDC had \$5.5million set aside for the project, but we would need at least another \$0.5million to complete which would have to be fundraised. Development had been delayed due to the pandemic and various contracts had to be re-tendered as developers had insufficient staff to complete the work. Skatepark was approved and should be completed by 2025. He handed out copies of the proposal to the attendant members of the public.

Waka Kotahi

As Jenni Wild from NZTA sent her apologies (due to a family matter) there was no presentation. However, committee members had been sent a copy of her Powerpoint presentation.

COUNCILLOR'S REPORT

From Cr Church

• There would be a meeting shortly to introduce candidates for the upcoming elections. Anyone can be a candidate for all posts.

- Tree disease (Dutch elm, canker, etc) has moved south from the Auckland area and to keep an eye out for sick trees and advise WDC immediately.
- Future swimming pool for Pokeno is in Long Term Plan
- Whangarata Cemetery is open for dog walkers, picnickers, etc for next four or so years until use is started as a cemetery.
- Street lighting if erratic or no service PCC advised to contact WDC and get order number. Ms Bullock said she had done this on 25 May regarding the lights at Pokeno/GSR intersection and nothing had been done
- Satellite for Dog Control and Transfer Station to be built in Bollard Road Tuakau. WDC has land now.
- No inorganic collections any more. WDC to communicate this to rate payers
- Lights/cameras added to rubbish trucks to reinforce collections to check on complaints etc.
- QR codes to be added to all council facilities which will connect to information regarding the facility.
- Pataka are to be re-introduced at Mark Ball Drive, Hitchen Road and Kowhai Downs.
 Council are preparing weather proof storage
- Pokeno Tennis Club. She referred the recent sudden death of Trevor Armstrong who was
 the representative of the club to WDC and confirmed that Bronwyn Heath is now the "go
 to" person. Ms Bullock asked about the entrance to the dog park from the Tennis Club
 which was being investigated pre-Covid lockdown due to safety on Avon Road and Jacqui
 said to liaise with Bronwyn.
- Dines/Fulton Hogan had only used \$7M of the 20/21 budget due to Covid and employment issues which has caused some projects to be deferred.

Works and Issues Report

The report was received and the following discussion was held:

- The General Manager Community Growth went through the points in the latest Works and Issues report.
- There was an audit taking place for the Pokeno Road layby.
- It was planned for 8 toilet pans to be installed in the next few months to replace temporary toilets.
- Regarding Easements from Munro Park, conversations were taking place with relevant parties. This was discussed and it seems that the easement from Munro Park to

Helenslee Road is already in jeopardy due to building already taking place on the subdivision at 21 and 55 Helenslee Road and the fact that the bottom area of the easement is a bog and will need extra drainage before being able to be used. Blair Johnson said there has been no conversation with him from anyone regarding easement access between Pokeno School and Munro Park. The General Manager Community Growth also said that the easement to Pokeno Road should not travel through school grounds as he is concerned about public access through the school due to possible crime, graffiti, general misbehaviour, etc.

- Pokeno Main Street concept plan deferred until August/September due to resourcing issues within the team.
- Conversations were taking place between WDC and Gull Service Station regarding signage, access to trucks and to ensure all conditions are compliant. A plan is to come regarding roading. PCC expressed their issues with the Gull Station and that trucks are already using it.
- Staff were investigating whether crossbars can be placed on lights for flags (Christmas Parade, Anzac Day, etc)
- No movement on changing meeting dates to four weekly as this does impact on staff at WDC regarding preparation of agenda etc. The Chair said we would keep to six weekly public meetings in the interim with 3 weekly "mini" meetings.

Subcommittee Reports

- Mr Odom advised he had written to WDC in response to their alcohol outlets in Pokeno request stating that there are 3 including Countdown in the main street alone and that Pokeno does not want or need any more outlets in any other part of the district where shops may be built in the future.
- The committee was advised that there were 66 direct and 85 appeals under 274's to the District Plan. Mayor Allen Sanson described the process to the committee and advised that some of the appeals may end up at the Environment Court which will be expensive and take a long time to resolve.

Finance

Ms Clotworthy advised that there is a delay due to change of signatories for the trust.

Events

 Mr Grainger advised that no events had been organised since the last meeting. Cr Church suggested that the Gardening Club be approached to do planting again, similar to that done pre-Covid on the gully behind Helenslee Road.

Communications

 Ms Clotworthy advised that there is great progress with the PCC website. It is almost ready, easy to use and should be up and running by 27 July. It will be self-funding to start with and will put up points of interest in the community. She wanted a mission statement and asked the committee for suggestions.

Facilities

• Ms Clotworthy discussed cameras in the main street. ANPR is extremely expensive and it was suggested that the police be involved with the monitoring of cameras, The Courts do not accept private camera evidence. A lady from Papakura advised that installing the cameras there has reduced crime immensely. The police advised her that they consider Pokeno a low crime area.

Neighbouring Committees/Boards

• No communications from Onewhero or Mercer Boards.

OTHER BUSINESS:

Community Patrol

• Doug Rowe advised the new patrol car is fitted with police radio and is waiting decals. The other cars will follow and old car will be returned to Ebbetts. Roads are extremely narrow, particularly when cars are parked on both sides of the road. 3 patrols a week. It is difficult to catch those committing car theft as often the perpetrators wait until the patrol has passed before stealing cars. The patrol may extend to cover Tuakau too. His advice is to lock your car.

Pokeno Marae

• Mr Grainger and Ms Clotworthy are attending a meeting on 21 June in Ngaruawahia regarding the Marae and will report back to the committee at the next meeting

Great South Road Signage

• A request was made that all advertising signs opposite Market Square on Great South Road be removed as these are an impediment to pedestrians and are not safe. Bronwyn Heath suggested that all signs in the township also be looked at as they may be safety hazards. Staff advised they would look at this.

Speed Limits

 Some speed limits across the district changed on 02 June. These can be seen at the WDC website. Will take place immediately new signage goes up on the roads which may take some time as there are approximately 320 to be changed

Mayor's Statement

Mayor Sanson advised the following:

Park'n'Ride has been approved between Pokeno and Papakura Railway Station. This
will consist of a 12 seater bus, 100% funded by WDC, one journey each way for the

next 12 months. If usage warrants it, this will be increased. Commencement 2nd quarter 2022.

- He discussed the District Plan. Sleepyhead build starts shortly.
- 3 Waters. He advised costs of building/updating water infrastructure and how it is not cost-effective for number of residents.
- Local Government review after 08 October and released 20 October.
- He is retiring this year and as many as 5-6 new councillors out of 14 are retiring.
- He described what he calls "Better Off Funding" whereby government will borrow up to \$31.53M against council assets.

Statement from Blair Johnson from Pokeno School

• The school currently has 484 pupils and expects growth to 700-800 pupils. Ministry of Educations wants to cap this to 600 pupils but he finds this unlikely. The MOE is looking at land for a second primary school to cater for extra growth. Pick up/drop off layby on Helenslee Road to be permanent. Stage one improvements are nearly complete. He explained about teaching spaces, rather that actual classes and said that Stage 2 will allow 2 extra teaching spaces

COMMUNITY PROJECTS TEAM UPDATE (As at 14 July 2022)

Pokeno Tennis Courts

HEB Construction have provided the pricing for the proposed works, and this is currently being reviewed.

Pokeno Sports Park - Northern Fill and Carpark Construction

The contract is being written for the importing of cleanfill and construction of the Munro Sports Park up to the final field level, and construction of the carpark.

Construction is scheduled from October 2022 to April 2023.

Pokeno Toilet Replacement

The Community Projects team (Moyra Coutts and Regan Powell) will be presenting to the meeting the options for the replacement toilets (roof option, cladding and colour options) as well as confirming the toilet module layouts and any modifications needed such as for little library and bike racks.

The extent of consultation for the options is also to be discussed.

The standard toilet module design is complete and working its way through the building consent process. It is intended to have the modules constructed at the contractor's construction yard, then transported to the individual sites for installation. The contract for this construction will go out to the market with an extended tendering timeframe to reflect the additional time needed by contractors to receive pricing from subcontractors and material availability in this current restricted market.







