of the draft document. The next step is our roadshows which will be held during October and November. They are an opportunity to find out more about the key issues and

How do I report a blocked pipe, dog matter or roading issue to Council?

It's easy. Visit our website www.waikatodistrict.govt.nz and click on the 'Request for service' tab on the home page. There you will be able to lodge your request which will come through to our Council staff to action.

You can even register for status updates so you can follow the progress of your request for service.

For noise control issues, it is still best to contact us directly on

0800 492 452. By calling us right away, we can get someone to follow up as soon as possible.

How do I apply for a rates rebate?

The purpose of the Rates Rebate Scheme is to provide a subsidy to low-income homeowners and ratepayers on the cost of their rates. The maximum rebate is \$605.00.

To qualify, you must be the homeowner, living at the property and paying the rates as at 1 July 2014. The income

eligibility for a rebate is \$24,250 but if you earn more than this a year, you could still be entitled to a rebate depending on the total cost of your rates and the number of dependants.

To apply, wait until you receive your rates assessments from both the Waikato District Council and Waikato Regional Council, then come in and see us. Bring both assessments, and information about your income for the tax year ended 31 March 2014. Applications can be made at any of our offices.

We encourage you to get in early and apply so that the rebate can be credited to your rates account.

The close off date for rates rebates is 30 June 2015.




Get ready for

inorganic refuse collections

Planning is underway for the 2014 inorganic refuse collection. This year, collections will be completed in line with your normal rubbish collection day but we'll provide more information about specific weeks closer to the date. In the meantime, to help you prepare for what will and won't be picked up, here's a checklist.



- √ Furniture eg chairs, tables, cabinets
- √ Lawnmowers and bikes
- √ Televisions
- √ Carpet
- √ Metal items from household renovations, (eg corrugated iron, pipes up to 2m long)
- √ Appliances (eg washing machines, stoves, fridges)



- X Any standard bagged rubbish
- X Glass windows and windscreens
- X Garden waste, tree trimmings and soil
- X Commercial and farm waste
- X Bricks and broken concrete
- X Oil, paint and chemicals
- X Fibrolite or asbestos
- X Car bodies or car engines
- X Builder's waste
- X Household renovation materials (eg timber)
- X Batteries and gas cylinders/gas bottles
- X Wire of any description
- X Tyres



From post and banking to books and rates, 7 Bow Street has always been in the business of serving the Raglan Community.

It's the hub of Raglan and has housed Waikato District Council for the past two decades but what was 7 Bow Street before that?

We all know it as the Raglan Library and Council Office, but prior to Council purchasing the building in 1994 it was home to another key community facility, the Post Office.

For 12 years New Zealand Post operated out of the site which was built in 1982.

In 1990 the Post Office was joined by Post Bank and the two operated as a dual facility until 1 July 1994, when the then Mayor, Angus MacDonald, officially opened the facility as Council's Raglan base and it has been our Raglan home ever since.

Fast forward to 2014 and we have just given the building a makeover.

On 28 July the refreshed Raglan Library and Council Office was revealed to the public after being closed since March 2014 for the renovations.

The works saw the building receive a brand new roof, window seals, guttering and flashings, new counters, and a new toilet for the disabled.

More space was also created by moving the shop front out and removing an interior wall and an old safe previously used by the Post Office.

A team of enthusiastic Raglan Placemakers then went to work on the interior, creating a vibrant and creative new space for library users.

The Raglan Placemaking committee put their heads together and came up with some fabulous concepts which

they then turned into reality with a little hard work.

Bright bean bag chairs were created from kite fabric; furniture was constructed from pallets and old book covers were used to decorate tables. And the best part is all of the items were created from donated, recycled materials.

The finished product is a warm, inviting and environmentally-friendly space with a distinctive Raglan flavour. It was a great example of the Council and community working together to achieve a fantastic outcome.

Council wishes to thank everyone for their patience throughout the renovations and to all those who contributed ideas towards the look and feel of the internal space.

We hope you love your refreshed library and office as much as we do.

Making civil defence strides

This time last year we profiled our Local Civil Defence Emergency Management Co-ordinator, Kelly Newell. Fast forward 12 months and Kelly has made exciting progress in the civil defence space.

Since coming on board in July 2013 Kelly has been busy working on improving Council's ability to respond to a civil defence emergency. This has included establishing a functioning Emergency Operations Centre (EOC) at our Ngaruawahia Office.

The centre is a dedicated facility with communications equipment and resources required to respond to an emergency at short notice. The Local Controller decides if and when the EOC needs to be activated.

Kelly has also been busy rallying the troops and has succeeded in putting 93 Council staff through a foundation civil defence course. Some staff members have also been designated to key roles such as Welfare Manager and Recovery Manager.

"The staff have put their hands up as volunteers, so to get such a great response has been really heartening," Kelly said.

The next step is the intermediate level Civil Defence Emergency Management training for staff required to work in the EOC. Kelly's current focus is on developing a local civil defence plan which will be completed by the end of the year.

The local plan will determine the priorities and goals for civil defence emergency management across the Waikato district over the next three years. "The aim of this plan is to build and strengthen our capability and resilience for a disaster in our district." Kelly has also begun looking to our communities.

When disaster strikes it is ordinary members of the public, not emergency services, who will be first to respond and as a Council we recognise that no-one knows the community better than the people that live and work within it, which is where community response planning comes in.

A Community Response Plan is a plan that is activated by the community in a civil defence emergency and is to ensure people are self-sufficient for the first 72 hours and is tailored to the needs of the specific community.

It is Council's goal to ensure all of our communities are equipped with their own Community Response Plan.

In August you will receive your rates assessment and first instalment notice. Sign up to pay by direct debit during I August - 23 September 2014 to enter the draw to win a \$500 credit on your rates.

Paying by direct debit is definitely the way to go. Payments from your chosen bank account will automatically be made on time to Council, which means no dates to remember. If your rates or water charges increase or decrease, Council will automatically amend the payments in agreement with you.

Note: The prize draw is available to new direct debit customers only. Direct debits are only available from New Zealand bank accounts and not via credit card.





Supporting whitebait fishing



In late July, a series of wellattended community meetings were held to discuss aspects of the whitebait fishery between Tuakau and Port Waikato.

These came after the release, earlier this year, of a combined Waikato Raupatu River Trust and Waikato Regional Council report identifying a range of matters relating to fishery and environmental health, as well as the safety of stands and baches on that part of the Waikato River.

The meetings introduced the different agencies involved in the work and their roles, information about rules and regulations around the fishery, and advice about what is required of those fishing for whitebait.

With a common goal of a sustainable fishery, agencies are keen to work with whitebaiters, initially improving a database to know what is out there and taking a gradual approach to give people time to make their own improvements.


Short-term goals over the next 18–24 months are for our council to work with people to ensure safe buildings and structures, and for the regional council to eliminate raw sewage discharge into the river. Information on building rules is available at www.buildwaikato.co.nz or from our offices.

The Huakina Development Trust, Land Information New Zealand, the Department of Conservation and the Ministry of Primary Industries are working alongside the trust, regional council and our council on this project.

Wiremu Tamihana Drive

Tamahere's new road linking Devine and Airport Roads will be known as Wiremu Tamihana Drive. Council's Infrastructure Committee voted unanimously in favour of the name further acknowledging Wiremu's contribution to the community.

Work is well underway on the road which is designed to reduce through traffic using Newell Road between State Highway I and Airport Road (SH2I). It should also direct mainstream traffic to use the new Waikato Expressway system. Congestion will be reduced at the SHI-Airport Road intersection and could contribute to future development options providing access to a proposed village hub on Devine Road.

Fulton Hogan is at the end of phase one working from Devine Road north of Tamahere School to Airport Road, near Regal Haulage. The final 25 metre wide corridor will include a two-lane road plus berms, plus a parking and manoeuvring area.

Spotlight COUNCIL

Our Roading team is responsible for 2,444kms of road in the Waikato district including the 25.7kms of the former State Highway I. Roading Manager, Chris Clarke explains some of the day-to-day jobs his team is responsible for.

Who manages what?

We're responsible for urban and rural roads, sealed and unsealed, while NZ Transport Agency maintains the State Highways. Recently, ownership of State Highway I North (near Taupiri) and State Highway 39 (near Ngaruawahia) was transferred from NZ Transport Agency to Waikato District Council and that's a result of the Ngaruawahia Waikato Expressway stage opening last year. Now we have full responsibility of maintenance and incident response for these additional corridors.

We facilitate the safety of all road users on every road across our district. To do this we work closely with other agencies including NZ Transport Agency and Waikato Regional Council

What we fix and when

Our roading programme is developed as part of the Long Term Plan (LTP) process which means any significant projects that get underway are planned well in advance. This long-term works programme includes major work, for example, the permanent repair to Wainui Road due to slip damage, Tamahere's new link road or major improvements.

At the start of each financial year we're also allocated a shortterm works programme budget which is what we use to fix the pot holes and temporary slip repairs. These items are entered into a priority list and completed as staff resource allows. "Each year we'll spend an average of \$2,943 per kilometre for sealed roads".

The other stuff we do

We oversee other bits and pieces around our roads like drainage, vegetation, signs, stock crossings, bridge maintenance



and street lighting. That's because these issues can affect road access. We also work closely with our Animal Control team when we have reports of wandering stock. Now's a good time to remind farmers to check their boundary fences as wandering stock can be catastrophic for drivers and their passengers.

Please drive to the road conditions

Drivers in the Tuakau Bridge - Port Waikato Road area are being asked to drive to the road conditions as Council completes significant maintenance work in the area.

Road Safety Co-ordinator, Megan Jolly (pictured) says drivers need to remember this is a rural road which can present a number of issues. "With next to no

What's happening in Pokeno?




