Brenda wants barriers narrowed on temporary walkway on Pokeno Road to prevent motorcycles using it as a quick way to/from Great South Road. Tony said he would look into this.

Helen Clothworthy needs a timeline for two options for Great South Road as discussed at earlier meeting. Tony to advise on where these are at. Once again, this is COVID delayed. Specific maps to be advised to Pokeno Community Committee.

Totara Park

Tony to check with Megan, as barbeques not connected and park still does not have rubbish bins or the agreed playground equipment. Improved lighting needs to be installed. Cr Church gave her report which included:

• Wanting to know about \$20,000 held by Council for Pokeno. What is it for? Agreed by meeting to remove the word 'planting' from remit.

Moved by Allen Grainger Seconded by Kris Hines

- A community working bee planted 300 plants on the wetlands walkway by Galston Court, some of which have already been stolen.
- Funding came from Momentum and a private donor for Pokeno Lions and Catholic community to provide pataka (food banks) around Pokeno. Allen Grainger felt that Pokeno Community Committee should have been advised in advance, as there are several different agencies around the district which would have been interested in assisting with this and Pokeno Community Committee is invested in representing Pokeno.

OTHER BUSINESS

Agenda Item 7.10

Street Names

Helen Clotworthy has a list of street names for Council to review. She is getting histories of local Pokeno people to put forward to Council. It is not easy as many suggestions are rejected by Council.

James McRobbie wants to know criteria for street names. Helen advised that often names are rejected if there are similar or the same names within the Waikato area. Two extra names, Cyril Martin and Percy Harris were put forward by Allen Grainger on behalf of Doug Rowe. Ginny Bullock suggested native trees or bird names.

Cr Church suggested Norman Watson who attended Whangarata School in 1920's. She suggested QR Codes be posted to poles in Pokeno to give details of local history and historical people of interest. There is a process for Maori names. List of current names in north Waikato sent to Committee members by email.

Ric Odom wants Council to advise Committee on the reason for rejection of names put forward.

Kowhai Downs

Allen Grainger asked Council about who is responsible for maintenance in Kowhai Downs. It has been divested to Council and nothing has been done since. Storm water drainage is a major issue, as some reeds (which are integral part of this) have been removed, cut down by new residents. Ditches are the responsibility of Watercare. Berms to be mown by residents. Tony said to log this with Council and copy both himself and Cr Church to be followed up.

Speed restrictions

Ideas sent to Ric who passed these on to Cr Church. Cr Church to send map of North Waikato limits to Committee members. Most Pokeno Community Committee members thought 40 kms in residential areas and 50 kms in rest of district including central business district. However, James McRobbie felt that 50 kms, at roundabout at Dean Road, might be problematic for trucks coming from State Highway I.

Communications

Website

Helen has found original web designer who is happy to continue for a fee. There is a website building tool which is relatively simple to use. It was thought an annual fee of \$500 to set up and maintain a reliable website might be all that is needed.

Tony advised Council has \$500 to assist setting up Pokeno Community Committee website, but this has to be maintained by Pokeno Community Committee and needs someone experienced in websites to keep it updated.

An overview of roading projects is being prepared for the community and is scheduled to be distributed in August. The whakairo/waharoa/tomokanga (entrance carving) was an item discussed between the community and the developer. The developer is still in discussion with the carver who is very busy with NZTA work.

COMMUNITY PROJECTS TEAM UPDATE (As at 30 September 2021)

Parks - Munro Road Sports Park

Following discussions and pricing for the effects of the Covid-19 border crossing for trucks bringing in imported fill, and alternative options for supply within the border, as well as risks around health and safety under Alert Level 3, it has been decided to suspend works at this stage. Once the alert level drops down and the boundary opens, the situation can be reviewed, and ideally contractors Gleeson and Cox can then establish the sediment controls and start the importing of fill.

Work was originally planned to commence Monday, 4 October 2021 and expected to take 16 weeks. All works were to be completed by 4 March 2022. The delay from this will be dependent on the time from the end of September when the Contractor was programmed to establish, through to the reduction in alert levels allowing work to commence.

Cemeteries - Whangarata Cemetery Development (Watermain Repair)

The contract to repair the watermain damaged by Counties Power contractors during the installation of buried power transmission cables has been delayed due to the Covid lockdown. Works will be rescheduled once the lockdown reduces sufficiently to enable contractor access.

Pokeno Toilet Replacement

Design work is being finalised, with the review completed and resulting amendments being organised. Renderings of the roof outline, and cladding options are being prepared for consultation, to enable the community to determine the roof shape, external cladding, and colour. These renderings are expected to be completed at end of October.

The location and orientation of the proposed toilets are being considered in conjunction with the preliminary design for the Main Street upgrade in Pokeno. This is to ensure the two projects compliment each other. The community will be provided with a proposed location within the Main St upgrade design with options, for review.

Pokeno Main Street Upgrade

The preliminary designs are being further refined following prior discussions to provide a base design, with various options for crossing types, kerb treatment, and integration with adjacent works (public toilet replacement, and Wellington St carpark). This will be presented to the committee for review and discussion and will feed into the detailed construction drawings.

Existing services are being reviewed and discussions with service authorities are being carried out to identify any future upgrades that can be brought forward, or ducting installed to futureproof to avoid significant disruption in the years immediately after the Main Street upgrade.


Roading Design Works

Design will also get underway for the roading works planned in the next few years, including:

- Pokeno Rd Pokeno Bridge to Munro Rd Corridor Upgrade
- Munro Rd / Pokeno Rd Intersection this is the scheme design phase.
- Great South Road / Pokeno Rd Intersection design
- Helenslee Rd Munro Rd to SH1 Interchange upgrade design

- Munro Rd One Lane Bridge (construction currently scheduled for 2024/25)
- Culvert upgrades are scheduled for this summer construction season on Munro Rd (aligns with new stream alignment), and works on Ford Rd culvert.

Designs will be provided for review as they develop.
