5. PUBLIC FORUM

The following items were discussed under Public Forum:

- Jenny Kelly spoke about literature resources relating to the area's local history and advocated for the Te Kauwhata Historical Museum society to hold a special general meeting to resolve issues around the museum not being opened.
- Cr Noel Smith of the Waikato Regional Council (WRC) spoke about the impact of Cyclone Gabrielle on the Whangamarino Wetland and clarified that it is not WRC but Fish and Game who needed to have responded to the death of fauna in the wetland. He indicated that a plan was being put together with the assistance of WRC to deal with future such events. He also indicated that WRC was establishing sub-committees to oversee waterways. In response to a question from Liz Tupuhi about mana whenua representation on these sub-committees he indicated that this matter is being pursued through Waikato-Tainui. Cr Raumati suggested that Cr Smith reach out to Jaedyn Falwasser, Waikato-Tainui's Taiao Manager, for further guidance on this matter.
- Paul Murray spoke about the Para Kore relationship with schools to resolve the food
 waste into landfills issue through hot composting and involving more environmentally
 friendly means without contributing to carbon emissions. There is a plan to install a 4 box
 unit at Te Kauwhata Primary School, which will have public access. Cr Raumati suggested
 that Mr. Murray get in touch with Council's Solid Waste Team Leader, Phil Ellis, to see
 how there could be mutual benefit from the work he is doing.

6. REPORTS

6.1. Discretionary Fund Report

Discussion:

It was noted that the following sentence at the top of page 14 in Council's Support Accountant's report may be an error and would need to be removed "Commitments from Committee Meeting Minutes and Other Information". It was also noted that, with the Committee now approving the minutes of the meeting of 2 August 2023, the resolution to uncommit the \$5,000 for the security cameras and re-allocate it back to the Discretionary Fund can now be actioned by Council.

With regards to the North Waikato Development Fund Support Accountant's report, staff were requested to clarify if the income interest earned (\$40,6222.38) was included in the carry forward total from 2021/2022 and if the net funding remaining amount (\$88,894.22) was correct.

6.2. Te Kauwhata Works and Issues Report

The report was received [TKCC2309/02 refers] and the following discussion was held:

Discussion:

- It was suggested that staff clarify the costs (amount spent) on the Saleyard Road walkway project, particularly the breakdown of the \$50,000 previously spent.
- It was noted that the cleanup of the walkway has been completed and that this will be paid for by Council from their operational budget.
- There was discussion about the intent of the Community Identity Strategy and whether
 there is a risk about creating community expectations through projects that may be
 identified for which there is no funding. It was suggested that the project managers
 (Courtney Howells and Estelle Jonathan) relook at the project narrative contained in the
 Works and Issues report to ascertain if this is indeed what the community wants for
 example 'shaping regional strategy'.

6.3 Upper Northern Waikato Railway Station Indicative Business Case

The report was received [TKCC2309/02 refers] and the following discussion was held:

Discussion:

- Vishal Ramduny presented the report and indicated that the Council, on 28 August 2023, endorsed an Indicative Business Case (IBC). The IBC recommends the provision of a railway station in Tūākau within three to five years. The IBC, put together in association with Waikato Regional Council and KiwiRail, also suggests that a railway station could be provided in Pōkeno within the same timeframe. For those a bit further south, the IBC does not rule out a station in Te Kauwhata within six or more years after a station is built in Tuakau and/or Pokeno.
- Vishal emphasized that whilst the endorsement of the IBC is welcomed, we must not get ahead of ourselves. The IBC is just a step in the process. It is not a guarantee of funding approval. The next step is for a Detailed Business Case to be carried out and this is subject to funding from both Council and Waka Kotahi (which is something that Council will be considering through the deliberations for the 2024-2034 Long Term Plan process).
- The DBC would also need to analyze time-saving measures for the Hamilton-Auckland Te Huia train service.
- The DBC will go further into the case for funding and delve into the confirmation of the costs and benefits of having more than one station in the northern Waikato, as well as investigating platform layout and the staging of delivery.
- All these are subject to a decision being made on the continuation of Te Huia before the trial period ends in June 2024 as well as the development of a strategic case for interregional rail between Auckland and the Waikato. Any future station construction will be subject to government funding and the priorities of the government of the day.
- The Committee suggested that a commuter bus that connects TK with the train would be useful . The bus could connect to rail at Pokeno or Drury.

6.4 Councillor's report

The report was received [TKCC2309/02 refers] and the following discussion was held:

Discussion:

• Cr Marlene Raumati's report was taken as read.

6.5 Chairperson's report

Discussion:

- Pedestrian crossing at Aparangi between office and the church. Cr Raumati indicated Council's traffic safety engineer is investigating safety improvements.
- Funding request for the rugby club for the kitchen upgrade. Unsure as to the value yet. Good community feature and is used by more than just for rugby functions.
- Council Long Term Plan 2024-2034 workshops coming up. John Cunningham indicated that he would try and attend these as best as he can.

7. ANY OTHER BUSINESS

Discussion:

- Tim Hinton noted that there is a Te Kauwhata Domain user group meeting coming up.
- John Cunningham advised that there is no meeting of the Committee in October. Interactions can happen via email.

View response

The Waikare Golf Club is situated in the township of Te Kauwhata which is halfway between Hamilton and Auckland. Total member numbers are currently 230 consisting of 175 men and 45 women. Members are from all ethnic groups living in the greater North Waikato. We average approx 60 players each week, through Twilight golf, tournaments and green fee players over and above our members.

Twilight golf is organised for members and non-members specializing in family groups. Last year we printed 15,000 cards to play a round of golf. The course is very well laid out and beautifully groomed to a very high standard. Hence this is why it is attractive to players from out of town. We need these players to help finance the costs of maintaining the high standard of the course that members and visitors expect.

Our present greens mower is needing constant repairs and maintenance plus it was purchased in 2010. This was a John Deere machine which has been an influence on us to purchase another of this model. The mower is used 3 times weekly to mow 18 greens plus the practise green in times of high growth and usually twice weekly in lower growth. We will keep the old mower to use in case of emergencies.

We have large numbers of 65 plus players both women & men in our club. They are very willing to help with working bees, cutting back trees, gardening and the general maintenance around the course. Voluntary labour is very precious to the overall running of the club. Women help with catering and run bring and buys to help with finances. Men run a raffle each Saturday.

Being adjacent to the Te Kauwhata College, often the sports period is learning to play golf. We regularly have Grandparents playing with and enjoying teaching their Grandchildren to play golf.

The club gives back to the local community. We run tournaments to help the local services, Fire Brigade, St Johns Ambulance and Lions Club, The community house, The Cancer Society through running a Pink Ribbon Breakfast. Supporting all people living in the greater Te Kauwhata district, plus we make the clubhouse available for the Te Kauwhata College to use for end of year functions etc. Many weddings and funerals are held at the Clubhouse.

In March 2023, We held a fund-raising tournament to help the Napier community after the devastation of cyclone Gabrielle. We donated \$13,100.00.

We hope you will look favourably at our request for a grant as we do serve the wider community around Te Kauwhata.

Project Summary

The TK dog park will be revamped to include a dog agility course and a fenced-off area for the more timid small dogs to play and exercise without fear of being encroached upon by larger dogs. Additionally, the dog park will also benefit from the development of two shaded picnic areas with picnic tables in them so members of the community can enjoy the area more with their families.

Please note that parking for overflow of the rugby club events has been fully considered.

PHASE I: Dog Agility Area Dog agility equipment were cleaned in a working bee on Saturday 29th April 2023 as planned. Dog Agility course proposed to be located between points ② and ③ of the dog park shown in the diagram above to minimise parking impact due to TK Domain event overflow. Meeting was had with Dog Agility course designer Denise Ireland on Wednesday 8 May 2023 and the course has been designed in two parts within a figure of 8 formation as shown in the dog park diagram on the previous page. Proposed course layout is shown below: ③ Dog Tunnel ② Dog Weaving Posts ③ Dog Hurdles ③ ⑤ ② Dog Jump Platforms ⑤ Dog Seesaw According to Kennel Club H Regulation H(1)(B)1a.(3) — Design: • The course should require a dog to traverse 10 obstacles, but not more than 20 and all jump obstacles should be the same height • All agility obstacles will be laid out 4-5 metres apart between centres of consecutive obstacles using the straight line centre-to-centre method to ensure dog jump safety • The height of all obstacles will be knee height catering for midi dogs There are two courses, A and B. Similar to a golf course with a 9 hole vs. 18 hole golf course, advanced dogs can do both courses A and B together, whereas beginner dogs can just work on one of the courses without interfering with another dog on the other course.	Tim Hinton has agreed this plan with Waikato District Council. Funding to hire equipment to place this equipment on the course has been achieved. PHASE 2: Picnic areas I and 2

Location of the picnic and shaded areas as well as small dog park area confirmed in the diagram above.

Specifications as follows:

PROJECT INSTALLATION STAGE 1

To kick off the project, we need to install the steel poles as follows. We will source 4 galvanised steel poles per shade sail (2 poles will be lower and 2 higher) The height of the lower poles will be 2.5m above ground with 1m in the ground and the higher poles will be 3.5m above ground with 1.5m in the ground). We need to decide if we want to do a working bee to install the poles.

- 8 x 125mm medium galvanised steel pipe poles with 4 x 3.5m long and 4 x 5m long fitted with caps
- Excavator and auger drill at \$115per hour
- Concrete I.8m3

Anticipated timeframe = 1-2 working days
Anticipated cost = Poles 2,484.80 + Auger drill \$276
+ Concrete \$805 → \$3,565.80 incl. GST

PROJECT INSTALLATION STAGE II

- Once the poles are in the ground, Peter Fletcher will come to measure the shadesail measurements exactly although it's anticipated that the final shadesail sizing will be approximately 6.5x6.5 = 42.25m2 for each area.
- He is ordering the Monotec 37015-year fabric warranty in Graphite Charcoal Shade
 Gaphite Charcoal
- He will then make the shadesails with no joins, including stainless steel hardware, d-shackles and chain links. =. A deposit for making the material is not required as we are known to the maker. Takes 2 weeks to make and install once the 8 Poles are in the ground and ready.

Anticipated timeframe = 2 working weeks to make and install

Anticipated cost = \$4,172.20 incl. GST - Price includes making and fitting the dog park shade

Tim will source some mulch for the areas under the trees and Jeff will source half rounds to keep mulch/metal all in the area – effort and cost TBD

Right now the ground is too wet to install the poles. Tim has ordered the poles with Dale Barrakat and once the weather dries a bit, we can proceed with getting the poles in the ground. Once in the ground, Peter will measure the shadesail and completion of installation will be 3 weeks later

STAGE III

Picnic tables have been completed.

Keep an eye on weather and once drier, the poles can be installed and Peter can complete the shadesails.

Project Status

The Project Team would like to emphasise the purpose of this project which is to develop a strategy towards an aspirational future for Te Kauwhata and Districts. While there is consensus on the Project Team that the Strategy will be informed by two central pillars – our unique environmental and historic sites and stories – we believe it is paramount that our communities and stakeholders have a real opportunity to contribute to this vision and shape the short, medium and long term projects and goals that will be written into the Strategy as steps towards the vision. We cannot preempt these projects and goals. As such the next steps for our team are:

- 1) To develop a visual tool to introduce the project to the public and stakeholders. Our preference was originally to commission a high end video that showcases those important features pertaining to our central pillars. This has been costed and will require a budget of \$10,000+GST via Nimbus Media, or there is a possibility of a collaboration with Ngaa Muka who are also creating some new media over the coming months. If the budget is not available our Plan B is to create our own visual slide show which Lauren Hughes has volunteered to coordinate.
- 2) Plan and carry out a round of consultation that will take place between Mar-May 2024. The stakeholder groups we have identified for the first round of consultation are as follows. We welcome the Community Committee's addition of anyone we may have neglected:
 - Te Kauwhata Community Committee

- Meremere Community Committee as courtesy
- Ngaa Muka
- Rangiriri Paa
- Schools in the defined area
- Businesses in the defined area
- Community organisations in the defined area
- Aparangi
- The general public

We expect that the projects and goals raised in this round of consultation will fall into these key areas:

- IDENTIFY what are those important features under our pillars?
- CONNECT what infrastructure do we need to connect them eg walkways, cycle ways, roads, maps, websites
- ACCESS how else can we create access for the public to enjoy these sites? Tourism businesses, accommodation, disability access, public events, media, online resources, educational resources
- PROTECT & DEVELOP if we want to be proud of these sites what are our responsibilities to them and what regulations do we need to advocate for to ensure that others working, living, visiting, doing business in the area cares for them too.
- CELEBRATE how do we keep stakeholders and the community united around our identity and this vision for the next 50 yrs? How do we celebrate each milestone along the way?

We have updated the Project Plan below and you will see there is a second and third round of consultation planned. The second round is for specific people or groups who will be directly impacted by projects and goals that may fall out of the Strategy. For example if the public tell us that they want a walkway to connect site A to site B we will then have a specific set of stakeholders to consult around that project including landowners, neighbours, kaitiaki of the historic or ecological sites etc.

The third round of consultation will come after our Draft Strategy has been drawn up and it will include all those we have consulted with previously. At this point we will just be seeking to refine the Draft Plan and ensure we have not misrepresented any of our stakeholders.

We are still finalising the first round of consultation and will present the Committee with further information as it is available.

Project Summary

- A subcommittee drawn from Te Kauwhata Community Committee members and invited stakeholders has formed and meets regularly towards the development of an Identity Strategy. The purpose of the Strategy is to articulate those things that make our region unique and create a tool for planning and advocacy that will focus future investment and development in Te Kauwhata and Districts in such a way that it connects, protects and celebrates those central pillars:
 - Our unique environment (wetlands, waterways and associated wildlife)
 - Our unique culture and history (Rangiriri pa and other sites and stories of historic significance)
- The Strategy will be a guiding document stating a 50 year vision and the associated social, economic, environmental and cultural outcomes sought for Te Kauwhata over the next 50 years. It will also include the short, medium and long term projects and goals required to achieve that vision.
- The Strategy will broadly cover the geographic area between the five Nga Muka marae –
 Hora Hora, Maurea, Waikare, Taniwha and Okaerea. There is aknowledgement that this is a
 soft border and important environmental and cultural features such as the Whangamarino
 Wetlands and connection between Rangiriri and Meremere may require a flexible, inclusive
 approach.

- The Strategy will record aspirational, community led, long term goals for our region that will be used to:
 - Advocate and inform the planning of other stakeholders in our region including local and regional council
 - o Identify and drive key projects that will realise the goals of the Strategy and cement the Identity of the region internally and nationally
 - o Provide a strategic focus for the development of other community led amenities
- Prior to the writing of the strategy the Project Team will lead community and stakeholder
 consultation. The team would like to commission a video as visual tool to engage the
 community in the visioning process. If there are insufficient funds to acheive this they will
 create their own visual aid in the form of a slide show. For consistency and efficacy it is vital
 that the project team use the same information and tools when speaking to each
 stakeholder group.
- The project team will collate the community contributions, drawing out common themes and ideas to progress further with relevant stakeholders. Once the direction and goals are identified the team will write, or commission the writing of the draft Strategy.
- The draft strategy will be taken back to the community for feedback before a final Strategy is produced.
- The final Strategy will include mechanisms for how it will be implemented, monitored and used. The Project Team will continue to take a key role in these matters and up date this document to detail Phase 2 in due course.


Supporting documents


REGIONAL CONTEXT

Project Summary

The mural project is designed to be erected on the Te Kauwhata Squash Court. It will be focused on capturing the essence of the TK Domain which has a history as a war memorial but is primarily used as a sports club and community meeting place for events and leisure. The mural will be visible from anyone driving down Mahi Road or walking their dogs at the Te Kauwhata dog park. The Te Kauwhata Squash club currently has 2 courts but the vision in the future is to extend the club to have another 3 courts, making it a 5-court establishment. We would love to create a mural which really captures all the amazing images summarising the TK Domain up as a whole. If we can interlace some TK cultural, community and sporting history into this, it would be wonderful too. The TK Squash club engaged with Graham Hoete (who did the Ngāruawāhia Squash Club mural) and Claire Dubosky (a renowned artist who has completed many murals across north Waikato) to see about designing a mural. Graham has not responded whilst Claire has been actively involved and gone ahead and designed a series of 6 murals already.

How the elements of the mural were decided upon

Extensive study was done into the history of Te Kauwhata (see addendum) including reading all the historical artifacts, reviewing images of the Settlers Museum and consulting widely with the Te Kauwhata historical society (Wayne Beaver and Stuart Mendals), Nga Muka Development Trust (Nga Muka), key members of the Domain project, Morris West, Frank Green as well as the committee of the Te Kauwhata Rugby Club and Te Kauwhata Squash club, the overall imagery was agreed upon.

An active discussion was had about the reference to the Domain being the site for the old war memorial. Everyone agreed that the Te Kauwhata Domain shall be called the Te Kauwhata Domain. All references to the history of the Domain being a war memorial was not considered pertinent to the future of the Domain or Te Kauwhata as a town in general. It was felt that the mural should include elements of this history (the poppy and the war memorial stone) as a reverent nod to an important historical moment BUT it was considered important that the Domain is a positive and enlivening place which brings the community together and the mural is to be uplifting and inspirational representing the best elements of Te Kauwhata's past and future.

The Te Kauwhata Squash club currently has two courts and feasibility studies are underway to commission the building of 3 further courts given the growth in the club and community over the past 3 years. There will be 15 panels to design and the first 6 need to be standalone as the next 9 panels will be years away. The first 6 panels for the existing courts (which should represent things already existing within the TK Domain) and 9 future panels which incorporate proposed changes we are working on for the TK Domain. The current courts vs. future courts cuts this project into 2 phases.

Phase I needs to be standalone as it will be some years before phase 2 takes effect.



Addendum: Te Kauwhata History

Te Kauwhata refers to an ancient settlement on an island (Punikanae Island) in the middle of a lake in the area, Lake Waikare. Punikanae island has a silica sinter-depositing spring located on it. This is the only sinter depositing spring known outside the Taupo Volcanic Zone. Te Kauwhata (originally named Tā Kauwhata meaning empty storehouses back in the day) refers to the empty store houses (pātaka kai) that stood on this settlement, protecting food from pests on the mainland. The story goes that during the war, Māori would harvest kai (vegetables like kumura and potatoes) and bundle it up onto waka (boats) which would then get ferried across to Punikanae island to keep safe till winter. The little storehouses were on stilts and as the pests couldn't swim across the lake, pests could not destroy this valuable kai. In the winter, the Māori would row the wakas across the lake to fetch the kai again and returned to the maraes to feed the people. This kai sustained people during the war and were a lifeblood to the locals. Despite the battle of Rangiriri, Māori even fed the British this way during the war, so were the kind ways of the people.

If you look at the TK primary school and college emblems, you will see image of the storehouse.

The first home of the New Zealand wine industry, the Viticultural Research Station was the site of an experimental farm, growing Syrah, Chardonnay, Pinot Noir, Cabernet Sauvignon and Riesling grapes. International viticulturalist Romeo Bragato took over the running of this station in 1901 and five wines produced here won gold medals.

Just south of Te Kauwhata, is the site of one of the fiercest battles of the New Zealand land wars, fought at Rangiriri on 20 November 1863. Māori built an exceptionally strong paa there, and when the British forces attacked many men lost their lives. Part of the paa site is now a historic reserve. Te Kauwhata's natural features include Lake Waikare and the Whangamarino wetlands, a significant environmental feature in the north Waikato. Located just north of the township, the Whangamarino wetlands area is the second largest peat bog and swamp complex in the North Island. The Whangamarino Wetland encompasses peat bog, swampland and river systems. The dominant vegetation is mānuka and wire rush, with moss and lichen species. Threatened plants include water milfoil, the swamp helmet orchid (*Anzybas carsei*), and clubmoss.

Threatened bird species, including the grey teal, the spotless crake, the North Island fernbird and around 25% of New Zealand's population of Australasian bitterns live in the wetland. Eighteen species of fish include the black mudfish.

In 1961 the lower Waikato–Waipā flood protection scheme caused water levels to drop by more than 1.5 metres. As part of wetland restoration, a weir was constructed on the Whangamarino River in 1989 to maintain minimum water levels. The Department of Conservation controls animal and plant pests, which include the highly invasive alligator weed. Established as a Ramsar site in 1989, this wetlands area has been developed further since the late 1990s. It is managed by the Department of Conservation it is the site of the first National Wetland Trail established in New Zealand. Te Kauwhata, a village of over 1,500 residents (1,617 – Census 2018). The township is surrounded by dairy farms, drystock holdings and horticulture. Its newest building is its Waikato District Council library. Originally known as airangi, Te Kauwhata grew around a railway station built in the late 1870s.

The first home of the New Zealand wine industry, the Viticultural Research Station was the site of an experimental farm, growing Syrah, Chardonnay, Pinot Noir, Cabernet Sauvignon and Riesling grapes. International viticulturalist Romeo Bragato took over the running of this station in 1901 and five wines produced here won gold medals.

Just south of Te Kauwhata, is the site of one of the fiercest battles of the New Zealand land wars, fought at

Rangiriri on 20 November 1863. Māori built an exceptionally strong paa there, and when the British forces attacked many men lost their lives. Part of the paa site is now a historic reserve.

The TK Domain

A site where we have young and old across the community coming together to have picnics, attend events, play sports, play with their kids and walk their dogs. It's a community meeting spot where people from all walks of life and cultural backgrounds come together as friends and whānau.

In the past, the TK Domain was the site for the original War Memorial and people used to come together to sing/ dance and attend concerts, raffles and games evenings. Rugby was originally a source of recreation in Te Kauwhata since 1907 and was played at the TK Domain from 1947 onwards. Back in those days, sheep would graze the Domain fields and keep them short.

Today the Domain plays host to a dog park, a rugby club, squash club, scouts hall, as well as a cricket pitch and training nets. In the future, the Domain will play host to Long jump and athletics club, multi-court facilities including a hockey pitch as well as netball and tennis courts, a kids playground, fitness track connecting Te Kauwhata and Lakeside, a running track and even a concert/ stage for cultural events and music festivals.

Capital Projects Update (As at 19 October 2023)

Te Kauwhata Domain Walkway and Fitness Trail

GDC is currently applying for resource consent to under the works. WDC is currently working on the procurement plan to get the contract out to tender.

Tanker Filling Stations

The draft new drinking water standards requires elimination of hydrant use except in delivering three waters operations and maintenance services and firefighting services to the community.

Waikato District Council has partnered with Watercare to establish bulk water supply points equipped with tanker filling stations across the district. This ensures the safe access and management of large water takes, exclusively for registered and accredited entities.

The implementation plan follows a staged approach and a filling station at 33 Mahi Road is now complete and operational. Line marking has also been completed, enhancing the overall appearance of the site. Temporary fencing will remain in place on the berm for a bit longer to support the regrowth of the grass and ensure its vitality.

Waikato District Council Long Term Plan (LTP)

Every three years, Council sets about developing a Long-Term Plan (LTP) in consultation with our communities. The LTP is a key strategic, planning documents that sets out the vision, financial and infrastructure strategies, key financial policies, community outcomes, levels of service, work plans and budgets for the next ten years.






March...
