Purpose

1. To conduct fair and effective hearings and make determinations on the Council's regulatory functions under legislation and other matters as referred to the Committee.

2. To recommend to the Council or relevant Council committee any matters that it considers necessary to enable the effective management of the Council's regulatory functions.

Terms of Reference:

- 1. Hear and determine any statutory or regulatory hearings under relevant legislation unless otherwise delegated or retained by the Council, including (but without limitation):
 - a. objections under the Dog Control Act 1996;
 - b. matters under the Resource Management Act 1991 and related legislation;
 - c. matters under the Impounding Act 1955;
 - d. matters regarding drainage and works on private land under the Local Government Act 1974 and Local Government Act 2002;
 - e. matters under the Gambling Act 2003, Health Act 1956 and Litter Act 1979;
 - f. matters regarding residential pools under the Building Act 2004.
- 2. Hear and determine other matters that require hearings or submissions, as referred by Council or other Committees.
- 3. To convene working groups and carry out the Terms of Reference approved and referred by Council or other Committees.

The Subcommittee is delegated the following powers to act:

- Conduct statutory hearings on regulatory matters and undertake and make decisions on those hearings that fall within the committee's Terms of Reference.
- Appoint additional members, including external members, for hearings where expert advice is required.
- Establish and amend hearings protocols relating to the general conduct of hearings and hearingsrelated matters in accordance with the applicable legislation and the principles of administrative law and natural justice.
- Approval of activities and expenses relating to working groups consistent with the terms of reference and approved working group budget.

Explanatory Note:

- 1. The Committee may request expert advice through the Chief Executive when necessary.
- 2. The General Manager Customer Support, in consultation with the Chairperson of the Regulatory Subcommittee, are delegated the power to determine:
 - a. the composition of any hearings panel to be convened under the committee's terms of reference; and
 - b. the appointment of any independent hearings commissioner within the panel of commissioners approved by the Council, to hear and determine any matter under the Resource Management Act 1991 (and related legislation). An independent commissioner can be appointed to act in his/her sole capacity, or together with appointed councillors who hold the appropriate accreditation.
- **3.** Decisions of a hearing panel shall be made by consensus although if necessary the majority view prevails

Purpose of the report Te Take moo te puurongo

To provide information to the Policy and Regulatory Subcommittee ("the Committee") to enable the Committee to hear the objection to a Menacing Classification imposed on the dog ("Marshal") belonging to Navjot Singh Sidhu ("Mr Sidhu").

2. Executive summary Whakaraapopototanga matua

Section 33A of_—the Dog Control Act 1996 ("the Act") allows Waikato District Council ("Council") to classify a dog as menacing if the dog is considered to pose a threat to a person or other animal due to observed or reported behaviour (Sections 33A and Section 33B of the Act annexed as Appendix 1).

Marshal, a black and tan male German Shepherd, aged 5 years 6 months and owned by Mr Sidhu was involved in an attack on a small Sydney Silkie aged 11 years 11 months. The attack occurred across the road from Mr Sidhu's partially fenced address at 42 Glen Ida Way, Tauwhare. As a response to the attack Senior Animal Control Officer Amanda Davis ("SACO Davis") attended the property.

After investigation, Council advised Mr Sidhu of the decision to classify Marshal as Menacing (Notice of Classification of dog as Menacing annexed as Appendix 2). In accordance with section 33B of the Act, Mr Sidhu formally objected in writing to the menacing classification within the statutory time frame (Notification of Intention to Object to Menacing Classification annexed as Appendix 3).

Council considers that Marshal poses an ongoing threat to persons or animals given the circumstances of the attack and that the attack was made on a much smaller dog.

Council understands that although Mr Sidhu has made some changes to the property fence line and that Marshal is wearing a containment collar, Council submits that for public safety reasons Marshal should remain classified as menacing, requiring Marshal to be muzzled when in public.

3. Staff recommendations Tuutohu-aa-kaimahi

THAT the Policy and Regulatory Subcommittee

- a. receives the Objection to Menacing Classification report; and
- b. the Classification of Marshal under section 33(A)(2) of the Dog Control Act 1996 be upheld.

4. Background Koorero whaimaarama

On 14 August 2023 at 13:14 hours, Council's after hours call centre received a complaint from a member of the public, Ms Fiona Snape ("Ms Snape") that her dog had been attacked by a German Shepherd (Service Request annexed as Appendix 4).

Ms Snape describes in her witness statement (Witness Statement annexed as Appendix 5) that at approximately 12:50 hours, she was walking with her two dogs, Mabel, Chocolate Labrador and Wilbur, Sydney Silkie on the grass verge across the road from 42 Glen Ida Way, Tauwhare ("the Property"), she saw Marshal inside the gate. Marshal was barking and charged at the gate with his teeth bared and his heckles up.

The gate to the Property was closed and Marshal went along the Property boundary fence and hedge line, made his way underneath the boundary hedge, and charged at Ms Snape and her dogs.

Ms Snape stated that Marshal appeared to be charging at Mabel then changed direction and attacked Wilbur, biting him on his left hip and pinning him to the ground. Ms Snape advised that Wilbur suffered a puncture wound to his left hip. (Photo of injury annexed as Appendix 6).

Ms Snape advised that a resident of the Property came out to see what was happening due to Marshal barking and Ms Snape screaming in an attempt to scare Marshal off.

Ms Snape advised that she managed to scare Marshal off Wilbur and Marshal ran back under the hedge into the Property. Ms Snape stated that she yelled at the resident of the Property telling them to "get control of their dog" and that Marshal had bitten her dog.

Ms Snape stated that she took Wilbur to the Cambridge Veterinary Services for treatment (Veterinary Treatment Notes annexed as Appendix 7).

Ms Snape has stated that the attack has had a major impact on her life, in that she has been sleeping poorly since it happened and has been anxious and tearful. Ms Snape has also stated that Mr Sidhu's actions after the incident have impacted her significantly and made her feel more unsafe as she states he has threatened her and made out that she

was the cause of the incident. Ms Snape states that she has no confidence that Mr Sidhu will take his responsibility as a dog owner seriously.

Council notes Ms Snape states Marshal has previously started barking as soon as he sees or hears her pass by the Property. Ms Snape states that Marshal is always angry, aggressive, and menacing and has been for many years.

Senior Animal Control Officer ("SACO") Davis states in her Officer Statement (SACO statement annexed as Appendix 8) that she received a call from after hours at approximately 13:15 hours in respect of this_dog attack.

As noted in the onsite time in the Service Request, at 14:00 hours SACO Davis attended the Property and, although Mr Sidhu was not present at the time of the incident, his parents were home and their level of English required them to call Mr Sidhu.

SACO Davis spoke to Mr Sidhu over the phone and after it was explained to him what had happened, Mr Sidhu instructed his parents to hand over Marshal to SACO Davis.

SACO Davis notes in the decision-making criteria that Mr Sidhu has not denied the incident happened, but he does not believe the incident was of an aggressive nature.

On 14_August 2023 Mr Sidhu came to the Ngaruawahia Waikato District Council office to claim his dog. After speaking to Mr Sidhu about what occurred, the dog was released to him.

Mr Sidhu is convinced that Marshal was only trying to play as he spends two days a week at doggy daycare. SACO Davis explained that the dog may be territorial and displays this at home. Mr Sidhu stated on that occasion that he had taken the following day off to improve his fencing and purchased materials to do so.

He has CCTV footage of the incident and he said he would supply it and that he knows the victim so will also go and apologise. Mr Sidhu also advised his dogs use a containment wire system and on his check of that system after the incident it was found to be flat due to a power fault.

Mr Sidhu has provided CCTV footage of the incident which shows Marshal barking at the Property gate then going under the hedge and running towards Ms Snape and her dogs. The footage does not show the point of contact made by Marshal on Wilbur (CCTV Footage of Attack annexed as Appendix 9)

Mr Sidhu has advised that Marshal is wearing a containment collar. SACO Davis notes in the decision-making criteria that Marshal was wearing the collar at the time of the incident but that it was not working due to a flat battery (Decision making criteria annexed as Appendix 10).

Mr Sidhu has advised that he has since amended the area of the fence where Marshal left the Property. (Photos of repaired fence annexed as Appendix 11, Appendix 12, and Appendix 13)

On 16 August 2023 SACO Davis spoke with Mr Sidhu updating him on the process. Mr Sidhu advised SACO Davis he had repaired the fence, and he said he had tested the containment collar, and it is functioning. SACO Davis discussed possible outcomes if the incident was substantiated regarding classifications/infringements.

SACO Davis discussed with the Animal Control Team Leader the attack and reasoning for issuing Mr Sidhu with the Menacing Classification (Decision making criteria annexed as Appendix 10) and on 4 September 2023, emailed Mr Sidhu with Council's decision to classify Marshal. Mr Sidhu replied that he would be filing an appeal against the classification once he had received it.

On 6 September 2023, the Menacing Classification was sent to Mr Sidhu via email and tracked post (Notice of Menacing Classification email to Mr Sidhu annexed as Appendix 14) to which Mr Sidhu replied that he would be appealing the classification (LGOIMA Request - Copy of Dog Complaint and Evidence of injury to Victim dog annexed as Appendix 15).

On 13 September 2023, Mr Sidhu was emailed Acknowledgement of his LGOIMA Request (Acknowledgement of your LGOIMA Request - Copy of Dog Complaint and Evidence of Injury to Victim annexed as Appendix 16).

Having received Mr Sidhu's objection to the menacing classification, the objection now needs to be determined in accordance with section 33B of the Act (sections 33A and 33B of the Act annexed as Appendix 1).

Discussion and analysisTaataritanga me ngaa tohutohu

Section 33B(2) of the Act (Appendix 1) provides that in determining this objection the Committee shall have regard to:

- (a) the evidence which formed the basis for the classification; and
- (b) any steps taken by the owner to prevent any threat to the safety of persons or animals; and
- (c) the matters relied on in support of the objection; and
- (d) any other relevant matters.

As a result of this analysis, the Committee will have the following options:

- A. Uphold the classification of Marshal as menacing; or
- B. Rescind the classification.

The Committee must give written notice of its decision and the reasons for it, under section 33B(3) of the Act to the objector.

The option preferred by staff is option A, and the reasons for this recommendation are discussed below.

5.1 Options

Ngaa koowhiringa

Staff recommend option A because:

 The Act states that the territorial authority may classify a dog as menacing if the territorial authority considers Marshal may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of any observed or reported behaviour of Marshal.

- Marshal was free to leave the Property and able to access a public place and exhibited behaviour which indicates he may pose a threat to any person or domestic pet. As a result of being able to leave the Property, Marshal made contact with another dog, injuring it.
- The owner was not present at the time of the incident and no one else was in attendance to control Marshal physically or verbally to prevent this situation occurring.
- A menacing classification ensures that:
 - Marshal is muzzled when in public to help mitigate the threat Marshal poses;
 - o If Marshal offends again, a menacing classification allows Animal Control to take stronger measures of enforcement such as seizure of Marshal until Mr Sidhu can demonstrate how he is going to prevent further offending;
 - Mr Sidhu takes the appropriate steps to ensure any threatening behaviour is mitigated.

5.2 Financial considerations

Whaiwhakaaro puutea

There are no material financial considerations associated with the recommendations of this report.

5.3 Legal considerations

Whaiwhakaaro-aa-ture

Staff confirm that the staff recommendation complies with the Council's legal and policy requirements. Legal Counsel will be available to assist the Committee with the matters of law as required.

5.4 Strategy and policy considerations

Whaiwhakaaro whakamaaherehere kaupapa here

The report and recommendations are consistent with the Council's policies, plans and prior decisions.

5.5 Maaori and cultural considerations

Whaiwhakaaro Maaori me oona tikanga

There are no wider Maaori or cultural considerations involved in the exercise of Council's legislative responsibilities under the Act.

5.6 Climate response and resilience considerations

Whaiwhakaaro-aa-tajao

The matters in this report have no known impact on climate change or resilience for the Council.

5.7 Risks

Tuuraru

Should the Committee uphold the classification and proceed with the staff recommendation, the classification stands with no further recourse for appeal by the objector.

Should the Committee rescind the classification, there is a risk that further breaches of the Act will occur, and members of the public could be further threatened or even harmed.

6. Significance and engagement assessment Aromatawai paahekoheko

6.1 Significance

Te Hiranga

The decisions and matters of this report are assessed as of low significance, in accordance with the Council's <u>Significance and Engagement Policy</u>.

6.2 Engagement

Te Whakatuutakitaki

This is a regulatory/operational matter concerning an individual and we do not propose to inform more broadly than necessary to give effect to the classification, if upheld.

7. Next steps Ahu whakamua

Should the classification be upheld, it will apply at a national level.

Council's role will be to update the relevant records and enforce the requirements of the classification.

Menacing dogs

Heading: inserted, on 1 December 2003, by section 21 of the Dog Control Amendment Act 2003 (2003 No 119).

33A Territorial authority may classify dog as menacing

- (1) This section applies to a dog that-
 - (a) has not been classified as a dangerous dog under section 31; but
 - a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of—
 - (i) any observed or reported behaviour of the dog; or
 - any characteristics typically associated with the dog's breed or type.
- (2) A territorial authority may, for the purposes of section 33E(1)(a), classify a dog to which this section applies as a menacing dog.
- (3) If a dog is classified as a menacing dog under subsection (2), the territorial authority must immediately give written notice in the prescribed form to the owner of—
 - (a) the classification; and
 - (b) the provisions of section 33E (which relates to the effect of classification as a menacing dog); and
 - (c) the right to object to the classification under section 33B; and
 - (d) if the territorial authority's policy is not to require the neutering of menacing dogs (or would not require the neutering of the dog concerned), the effect of sections 33EA and 33EB if the owner does not object to the classification and the dog is moved to the district of another territorial authority.

Section 33A: inserted, on 1 December 2003, by section 21 of the Dog Control Amendment Act 2003 (2003 No 119).

Section 33A(3): amended, on 1 November 2004, by section 10 of the Dog Control Amendment Act 2004 (2004 No 61).

Section 33A(3)(c): amended, on 28 June 2006, by section 13 of the Dog Control Amendment Act 2006 (2006 No 23).

Section 33A(3)(d): added, on 28 June 2006, by section 13 of the Dog Control Amendment Act 2006 (2006 No 23).

33B Objection to classification of dog under section 33A

- (1) If a dog is classified under section 33A as a menacing dog, the owner-
 - may, within 14 days of receiving notice of the classification, object in writing to the territorial authority in regard to the classification; and
 - (b) has the right to be heard in support of the objection.
- (2) The territorial authority considering an objection under subsection (1) may uphold or rescind the classification, and in making its determination must have regard to—
 - (a) the evidence which formed the basis for the classification; and
 - (b) any steps taken by the owner to prevent any threat to the safety of persons or animals; and
 - (c) the matters relied on in support of the objection; and
 - (d) any other relevant matters.
- (3) The territorial authority must, as soon as practicable, give written notice to the owner of-
 - (a) its determination of the objection; and
 - (b) the reasons for its determination.



NOTICE OF CLASSIFICATION OF DOG AS MENACING DOG

Section 33A, Dog Control Act 1996

This is to notify you that this dog has been classified as a menacing dog under section 33A(2) of the Dog Control Act 1996.

This is because reported behaviour of the dog leads us to believe that it may pose a threat to public safety; being any person, stock, poultry, domestic pet, or protected wildlife.

A summary of the effect of the classification and your right to objection is provided overleaf.

*For the purposes of the Dog Control Act 1996, you are the owner of a dog if-

- you own the dog
- you have the dog in your possession (otherwise than for a period not exceeding 72 hours for the purpose of preventing the dog causing injury, or damage, or distress, or for the sole purpose of restoring a lost dog to its owner): or
- you are the parent or guardian of a person under 16 who is the owner of the dog and who is a member of your household living with and dependant on you

Effect of classification as menacing dog

Section 33E, 33F and 36A, Dog Control Act 1996

You—

- (a) must not allow the dog to be at large or in any public place or in any private way (except when confined completely within a vehicle or cage) without being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
- (b) must, produce to Waikato District Council, within I month after receipt of notice of the classification, a certificate issued by a registered veterinary surgeon certifying—
 - (i) that the dog is or has been neutered; or
 - (ii) that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and
- (c) where a certificate under paragraph (b)(ii) is produced to Waikato District Council, produce to Waikato District Council, within I month after the date specified in that certificate, a further certificate under paragraph (b)(i).

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with all of the matters in paragraphs (a) to (c) above.

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c) above.

As from I July 2006, you are also required for the purpose of providing permanent identification of the dog, arrange for the dog to be implanted with a functioning microchip transponder. This must be confirmed by making the dog available to the Waikato District Council in accordance with reasonable instructions of the Waikato District Council for verification that the dog has been implanted with a functioning microchip transponder of the prescribed type and in the prescribed location.

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with this requirement-

within 2 months from I July 2006 if your dog is classified as menacing on or after I December 2003 but before I July 2006;

or

within 2 months after the dog has been classified as menacing if your dog is classified as menacing after 1 July 2006.,

If the dog is in the possession of another person for a period not exceeding 72 hours, you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on conviction to a fine not exceeding \$500 if you fail to comply with this requirement.

Full details of the effect of classification as a menacing dog are provided in the Dog Control Act 1996.

Right of objection to classification under Section 33A

Section 33B, Dog Control Act 1996

You may object to the classification of your dog as menacing by lodging with Waikato District Council a written objection within 14 days of receipt of this notice setting out the grounds on which you object.

You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.

wounds. I called the council to report his behaviour as he has been menacing the road for many
years and finally what I feared would happen every time I have walked my dogs past their house
had. I called the vet to ask their advice as my dog only weighs 6kg and was worried about internal
nonvisible injuries. Wilbur then started licking the area and I noticed a puncture wound so I made
an appointment for that afternoon to take him to the vet.

What impact has this event had on your mental wellbeing? This event has had a major impact on me, I have been sleeping poorly since it happened, anxious and tearful. The attack was truly terrifying, and I was expecting to see my beloved little dog die a most vicious and violent death and/or get badly injured myself. The owner's actions after the event have also impacted me significantly and made me feel more unsafe as he threatened me and made it out that I was the problem. This gave me no confidence that he would take his responsibilities as a dog owner seriously.

I have watched this dog become angrier and angrier over the years and more and more menacing whenever we walk past. I have always breathed a sigh of relief when I make it past their house without event. The night after it happened, I developed a severe migraine from the stress and spent several hours vomiting and in agony. I now have to be in the same room as my little dog and get anxious if I cannot see him. I am fearful that someone will leave a door open at home and he might wander off and get savaged. I have not walked past the house alone since it happened. I work from home several days a week and walking my dogs was normally a relaxing part of my day. Now I feel like a prisoner in my own home, unable to leave safely. I have to drive my dogs out and park at my neighbour's house if I want to walk them as I am not prepared to risk walking

past alone. I did walk out with my husband and as usual we were barked at as soon as we came near their house. I held my little dog, and we had a large umbrella with us. Even with my husband I felt unwell and shaky. On returning from our walk their gate was open, I though I was going to vomit, and my knees were shaking. Luckily the dog was not out front, but I was still terrified of him coming charging out again.

Wilbur is a truly cherished member of our family. He is almost 12 years old, weighs a mere 6kg, and has arthritis. We rescued him from an abusive and violent home 7 years ago. He was a very anxious little dog when he first joined our family, but 7 years of love and safety have made him a confident and happy dog. I made a promise to him that I would not let anything bad happened to him again and I would always protect him. I now feel like I have failed him and have brought him into a risky environment and could have seen him die in a terrible way in front of me. That is hard for me to reconcile and brings me to frequent bouts of tears.

The owner's attitude afterwards has left me feeling doubly attacked and I will detail this further below.

Are you concerned for your safety or the safety of the community because of the actions of this dog?

As detailed above I remain fearful that this dog is a major risk to our neighbourhood. Children no longer walk past the house or play out at the end of the road as they are scared of the dog. Dog owners no longer walk past the house due the menacing barking and the fact that the dog escapes, bares teeth and growls at passers-by, only retreating when shouted at. The owner's attitude that this is just normal behaviour for a German Shepherd and that dogs bite leads me to

fear that they will not take action to ensure their dog is trained and contained. The dog is very
rarely walked and when he does, he pulls the owner's son down the road and lunges as you walk
past. The dog appears untrained and very aggressive. A dangerous combination for such a large
dog.

Any further detail you would like to add?

The evening after it happened the owner came round to 'apologise'. I wish now I hadn't opened the door, or I had waited until my husband got home as I felt this was a second attack on me.

I feel that this was actually a misogynistic attack where I was told by the male owner that my interpretation of the events was all wrong and that my reaction to them had been unbecoming and too loud and too rude. After he left I felt bullied, gaslit and threatened and this has added to my anxiety as I am fearful of having a further confrontation with him or other member of the household. He told me that the dog was so lovely and friendly that animal control had let him go straight away. He told me off for shouting at his mother and said if I had caused her any health issues as I result there would be trouble. He said he did not care about dogs but his mother that was a different matter. He said he had watched the video of me shouting at her and it was terrible and totally unacceptable. I apologised and said I was in flight or fight and fully expecting to see my dog killed by his dog, but he just smiled and shook his head and said 'no, no, no'. Implying I'd got it all wrong and my dog was in no danger. He suggested bringing my dogs round for a play date to socialise them with his lovely dog.

Then as he was leaving, he said and 'you shouldn't have threatened to kill my dog' and 'I'm expecting your husband to come round with a gun and shoot him'. Now I never said that and never would. I don't know if he misheard me when I said I thought his dog was going to kill mine

or if he was trying to put words in my mouth so he could claim I was being threatening. I did
wonder afterwards if he was in fact secretly recording me. This has further led
to anxiety of being at home and I now draw the blinds as I fear they may have a video camera
directed at our home. He did release the video of the attack thinking it showed his dog coming
out to play and would put me as the aggressor. When the animal control officer told me it in fact
showed a clear attack I cried, with sadness knowing that others had seen my beloved dog being
attacked and that it was real and on video and with relief that I had been justified in reacting the
way I did and probably saved my dog's life exactly because I screamed and yelled and was
'unladylike'. The fact that he had even made me question myself, rather than apologising, asking
how my dog was or offering to pay the vet bill has been extra hard and a major concern for the
ongoing control of this dog and safety of our road.







ACO STATEMENT

I am a Senior Animal Control Officer and have been employed by the Waikato District Council for the past 11 years. On The 14th of August 2023, at approximately 13:5 hours, I received a service request for a current dog aggression. It was alleged that a German Shepherd (Marshal) residing at I had left its property and attacked another dog in a public place. I attended the property with ACO 26. I spoke to two residents at the address who are now identified as the dog owner's parents, they spoke limited English, so they contacted the dog owner (Mr Singh) whom I spoke to over the phone. I introduced myself and explained we had received a call that the German Shepherd from this address had attacked another dog. I advised Mr Singh I would be seizing Marshal while we conduct our investigation into exactly what happened. The dog owner, Mr Singh, was very cooperative and he asked his father to go and get the dog for me. The dog owners' father was also very cooperative, he took me around the rear of the property to a kennel and run area where the dog was secure. I took the dog from him as he was physically struggling to hold onto him as he is a large dog. I gave the seizure notice to the dog owners father. I spoke to the complainant, Fiona Snape, and advised we had removed the dog but further advised that did not mean the dog would not return to that property. Fiona confirmed her dog was not seriously physically injured from the attack. Marshal was impounded in the Ngaruawahia pound. On the 14th of August Mr Singh came to the Ngaruawahia Waikato District Council office to claim his dog. After speaking to Mr Singh about what occurred the dog was released to him. Mr Singh is convinced that Marshal was only trying to play as he spends 2 days a week at doggy daycare. I explained that the dog may be territorial and displays this at home. Mr Singh stated to me on that occasion that he had taken the following day off to improve his fencing and purchased materials to do so. He has CCTV footage of the incident and he said he would supply it and that he knows the victim so will also go and apologise. Mr Singh also advised his dogs use a containment wire system and on his check of that system after the incident it was found to be flat due to a power fault. On the 16th of August 2023 I called Fiona to arrange a statement, Fiona expressed concerns that the owner did not care as she has alleged he came over and was threatening towards her. I offered support and advised her that was a police matter. On the 16th of August I spoke to Mr Singh updating him on the process. Mr Singh advised me he has repaired the fence, and I also reminded him about Marshal's collar and he said he has tested it and it is functioning. We discussed possible outcomes if the incident was substantiated in regard to classifications/infringements. Mr Singh has viewed the footage. He said he will send me the clip. He stated the incident was over within about 4 seconds and he believes his mother called the dog back. We discussed aggression and territorial aggression some more in regard to Marshal's breed. Mr Singh provided the CCTV footage of the incident, references from Marshal's doggy daycare and photos of fencing improvements. Fiona provided a witness statement, vet records and photos of her dog's injury. I have reviewed the footage, and it is my opinion Marshal displayed territorial aggression towards the dog walking past his property. Decision made with Team Leader to classify Marshal as menacing based on behaviour. I have spoken to Fiona several times to reassure her as she is now afraid to leave her property by foot. Since the incident two other residents from Glen Ida Way have put in complaints regarding Marshal but they are unable to be actioned. 6/09/2023 Marshal's classification was sent via email and tracked post.

Effect of classification as menacing dog

Section 33E, 33F and 36A, Dog Control Act 1996

You—

- (a) must not allow the dog to be at large or in any public place or in any private way (except when confined completely within a vehicle or cage) without being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
- (b) must, produce to Waikato District Council, within I month after receipt of notice of the classification, a certificate issued by a registered veterinary surgeon certifying—
 - (i) that the dog is or has been neutered; or
 - (ii) that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and
- (c) where a certificate under paragraph (b)(ii) is produced to Waikato District Council, produce to Waikato District Council, within I month after the date specified in that certificate, a further certificate under paragraph (b)(i).

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with all of the matters in paragraphs (a) to (c) above.

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c) above.

As from I July 2006, you are also required for the purpose of providing permanent identification of the dog, arrange for the dog to be implanted with a functioning microchip transponder. This must be confirmed by making the dog available to the Waikato District Council in accordance with reasonable instructions of the Waikato District Council for verification that the dog has been implanted with a functioning microchip transponder of the prescribed type and in the prescribed location.

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with this requirement-

- within 2 months from I July 2006 if your dog is classified as menacing on or after I December 2003 but before I July 2006;

or

within 2 months after the dog has been classified as menacing if your dog is classified as menacing after 1 July 2006.,

If the dog is in the possession of another person for a period not exceeding 72 hours, you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on conviction to a fine not exceeding \$500 if you fail to comply with this requirement.

Full details of the effect of classification as a menacing dog are provided in the Dog Control Act 1996.

Right of objection to classification under Section 33A

Section 33B, Dog Control Act 1996

You may object to the classification of your dog as menacing by lodging with Waikato District Council a written objection within 14 days of receipt of this notice setting out the grounds on which you object.

You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.
