It has come to the attention of Ginny Bullock that there is another plan (as per Facebook announcement) to apply to WDC to use half of the playground on Mark Ball Drive for use as a community garden.

This is opposed by local residents. Reasons given are removing play area from children who use it to play football, picnic etc. There is no water to this area or toilet facilities, noise, compost and vermin would be an issue and due to bus stops, there is no parking

2. Executive summary

The update will provide an explanation and opportunity to ask questions in relation to the Proposed District Plan Appeals process.

The update will provide information about the process undertaken so far, the legal requirements, and the steps to take forward appeals to resolution or Hearing. It will be a good opportunity to talk about the size of the team working on resolving appeals and how each topic is managed.

This update will not enter into any specific appeal matters that may be confidential.

4. Background

Koorero whaimaarama

For the PCC meeting on 8th February a written update was provided on a specific appeal point being addressed by the Waikato District Council Policy Team.

The below update was provided with an offer to provide a presentation on the appeals process at a later time.

The PDP appeals are being addressed partially by meeting with appellants and s274 parties to understand the issues and discuss resolution. These meetings are confidential and involve legally privileged information.

Our Policy Planner, Emily Buckingham, is managing the appeals relating to the southern edge of Pookeno. This is her summary of steps taken so far and future engagement with appellants:

- *December 2022 – initial meeting with Havelock as the primary appellant to discuss sub-committee direction on their appeal*
- *February 2023 – expecting Havelock to propose amended provisions for their precinct to help address issues*
- *Late February 2023 – Havelock and Hynds negotiation meeting scheduled, as the primary appellants to Havelock precinct*
- *Late Feb 2023 – Hynds, Hopkins and Havelock meeting scheduled, as primary appellants on Hynds land and Hopkins land. NOTE - Any likely settlement, will need to be provided to the s274 parties for them to consider whether they would be satisfied by it or not.*
- *7 March 2023 – s274 parties meeting (which would include the Pookeno Community Committee as a s274 party) to update on where primary appellants have reached.*

For the intended meeting on 7 March, an invitation was sent to the address for service on the Community Committee appeal – Allen Grainger, ginnyb2108@gmail.com. No response has been received from this address to date.

Beyond an update in relation to the meeting, the resource management policy team would like to offer that someone attend the next Pokeno Committee meeting on February 13 to provide an overall update on the PDP appeals process, and programme. Please let me know if the Committee would like this to occur.

Pokeno Tennis Courts

HEB Construction got underway in February. The existing light post has been decommissioned and removed. The turf has been lifted. The volley wall footing is finished and inspected.



Pokeno Sports Park – Northern Fill and Carpark Construction

Pokeno Sports Park Bulk Earthworks and Carpark Contract has been awarded to McKenzie & Parma for the sum of \$2,981,856.65 excluding GST.

The contractor has established on site and works have commenced to include:

- Site setup – mobilise and establish site amenities.
- Started to form environmental controls that includes Sediment Retention Pond (SRP) and Decanting Earth Bunds (DEBs)
- The stream section bunds are all in place and completed.
- Establishment of the haul road and clay stockpile area is 80% complete.
- Temporary Traffic Management (TMP) has been established on Munro Rd.

The bulk earthworks element of the contract (Separable Portion 1) is planned to be completed by May. This is pending winter works approvals from the Regional Council and minimal inclement weather delays.

The car park construction (Separable Portion 2) is planned to be completed no later than the 31 October 2023. This is also pending a successful design and consenting phase.

Pokeno Toilet Replacement

The Pokeno toilet project is progressing within the wider District Wide Toilet project package (Pokeno, Tamahere, Te Kowhai, and Port Waikato).

The detailed design is being finalised with the site-specific consent applications to be lodged this month. The scheduled completion of the toilet block at Pokeno is July 2023.





SH1 Papakura to Drury

Project overview:

- A \$655 million project being delivered as part of the NZ Upgrade Programme.
- Includes an additional lane in each direction; wide shoulders for future bus services; a shared walking and cycling path; interchange improvements; improved access across SH1; improved safety, environmental and amenity features.
- Being consented in stages and constructed over the next 4-5 years.

Stage 1A Construction progress


- Noise Walls largely completed, grates have been installed over drains on resident side of the wall
- Southbound Pavement Widening and Stormwater works continuing
- Beach Road Southbound On-Ramp earthworks continuing, with works underway immediately off Beach Road (former haul road SAP)
- Stormwater and Pavement works by BP service centre continuing
- Retaining walls (southbound side):
 - under Beach Road largely complete
 - started two new walls associated with new ramp
- Retaining walls (northbound side):
 - north of Park Estate bridge continuing
 - south of Park Estate bridge largely completed with adjacent stormwater works continuing
- Continue building north side of Park Estate bridge and road approaches.

















NIMT Bridges

- Bridges 1 & 2: pouring concrete piles on Karaka Reserve completed; now installing falsework and formwork
- Bridges 1 & 2: piling and installing reinforcing steel cages in preparation for concrete pours on Flanagan Road (southern side of railway lines)
- Bridge 3: (night works site) – piling on southern side of railway lines, and sheet piling on northern side.








Cyclone Gabrielle



Stage 1A – coming up

- Continue southbound pavement widening behind steel barriers for full length of project extent
- Continue building Retaining Walls on both sides of SH1
- Continue building the new Beach Road southbound on-ramp
- Complete noise wall restoration works on Chichester Reserve side of wall
- Continue Park Estate Road stormwater works, and pavement works on both approaches
- Continue works on bridge deck and under the bridge
- Continue building the NIMT bridges.

Stage 1B2 update

- Notice of Requirement and consent applications lodged with EPA in late October under COVID-19 Recovery (Fast-Track Consenting) Act 2020.
- The applications were accepted for processing on 3 November.
- The EPA advised on 8 March 2023 that an expert consenting panel has been appointed to consider the applications and NORs for Stage 1B2.
- The decision is expected around June 2023.



Stages 2 & 3 (Drury to Bombay) update

- Intention to lodge Notices of Requirement for route protection in Q3/Q4 2023.
- Meetings with affected landowners to discuss design and potential property impacts ongoing but largely completed.
- Working with Te Tupu Ngātahi Supporting Growth around project interface areas (e.g. around Drury South Interchange).




Bombay Interchange update

- Nine different options modelled
- Review undertaken of the two short-listed options
- One option involved an additional west bound through-lane on Mill Road which would require widening of the southern side of the road (with earthworks, retaining walls and underground service relocation) - adding cost and risk
- Therefore we progressed the other option through to preliminary design and costing.


- Traffic impact assessment / modelling

- Preliminary Design (DRAFT Concept Design)




Bombay Interchange update
