6.2 Meremere Works and Issues Report

A verbal update at the infrastructure council meeting by the Deputy GM for Service Delivery WDC yesterday where they confirmed the next step for CCTV cameras is to gain pricing. The plan has pivoted from the previous plan of incorporating the network with Hamilton City council to having an independent CCTV network as it presented as more cost effective.

6.3 Whangamarino Action Plan

John and Liz came to speak regarding the Whangamarino Wetland Action Plan. Liz has been Contracted to undertake the community liaison for that plan.

An Action plan is being developed for the Whangamarino Wetland and Lake Waikare areas because the situation is worsening. Every year there are more and more outbreaks of avion botulism, which occurs when water is not oxygenated. Lack of Oxygen in the water is killing increasing numbers of bird and fish life across the areas. The intention of the plan of action is to reduce the death rate of wildlife moving forwards and improve the Wetland Environment. Since the 1980's the water quality at the wetland and Lake Waikare continued to decline significantly. The plan is to rehabilitate the area, And at present measures are being taken to investigate how we do that. Right now the opportunity to take action is greater than it has ever been because there is a hunger within local government and some funding is set aside to move forward, Community Support is the essential ingredient required to really drive this.

Koi-Karp are a noxious fish that also present a major problem in the Lake and local water bodies. Fishing and Killing of the Karp is strongly Encouraged, Good locations to fish the noxious fish include the most North East and most South East Sides of the Lake.

Liz and John are trying to inform the community of the issues at large, formulate an action plan to move forward and gain support for funding to action a recovery plan.

Question Asked: What research has been done to ensure there is no danger to humans from Avion Botulism

Response: Research has been done to ensure that Avion Botulism is not harmful to Humans, To date there is no evidence of cross contamination.

Group discussion was held on identifying specific projects within our primary over arching goals and assigning individual committee members to care for the over arching goals.

ASSIGNMENTS of Primary Goals: Kotahitanga - Ben Peters and Lauren Wismans Successful and Thriving – Cecilia Heta and Hayden Soloman Taiao – Jacob Calvert Inclusive – Marlene Raumati, Ben Peters, Cecilia Heta Engagement – Ben Peters, Committee Chairperson Jim Katu, Hayden Soloman Cllr. Marlene Raumati championed generating greater interaction between this committee and other key local groups such as Maniphenua and the Development committee. Marlene suggested we should look to foster stronger lines of communication and interaction.

7. General Business

• Haydn Solomon Mana Whenua representative for the Community Committee spoke to the group regarding ongoing Treaty action within the area. Hayden shared that within our backyard there are 2 significant treaty claims that effect the village, Claims wai.2035 and wai.30. The impact to the community is intended to be positive. Direct negotiations with the Crown have been entered into. What's happening in this space is a consortium of lwi and Hapuu have come together to go into direct negations. Haydn States that ultimately what's being proposed is a devolution back to Mana Whenua which will allow the community to have a direct input through the Mana Whenua.

Haydn added for interest and transparency that Waikato-Tainui are currently going through a restructuring process that allows for devolution which will be of wider benefit for the community as a whole.

Marlene Asked – Given there are marginal strips that have come back in to the Waikato Tainui portfolio, Will Mana Whenua take custodial care of those blocks after they are returned.

Hayden – Yes absolutely

Marlene Asked - What does this mean for our community?

Haydn – It's a good thing for the community. You will have contingent assists in your backyard that you have a say over through Mana Whenua. At the moment the community have these assets, but they have no control or say over them, the Aim with Settlement is to remedy that situation.

Haydn added, There will be a referendum during the elections with regards to Māori Seats. It looks like there is plenty of momentum to retain the seats, Support for Seat Retention is encouraged.

Marlene asked - With regards to Mana Whenua and the Community Committee, Is there an opportunity for a reciprocal relationship where a member from the Community Committee can attend Tainui Meetings to work together in Partnership on issues that relate to the Meremere Community.

Haydn responded – We could look to do that.

There was discussion around the Category of the lands being discussed being classed as schedule D. Land that is in schedule D is for example the local Tennis pavilions

Jacob asked – What's happening with the 'Schedule A' land where Mana Whenua have an interest or claim, are those and other classifications of land also being looked at?

Haydn Responded - That is also being negotiated as a part of ongoing treaty negotiations.

Haydn Added - Mana Whenua will look to take the lead on a local Matariki Event, They will come back to us on how to move forward with that.

- Committee Funding structure clarity to be sought from Democracy. The committee would like to know if they receive salaries which are being redirected to the discretionary fund. Kirsty Wellington and Dominique Thurlow to investigate.
- Community Day to be held for Whangamarino Wetland on May 17th at Red Shed 9:30am to 3:30pm.
- Rachel from WDC to be invited to the next meeting to present the Community resilience Aspirations.
- Kirsty to add Haydn Solemon to the official council documents for the community and also Haydns email to be added to the data base.

1. Purpose of the report Te Take moo te puurongo

2. Executive summary Whakaraapopototanga matua

The Meremere Community Committee adopted their Community Board Plan in 2024, which outlined their vision for the following two (2) years.

Following the adoption of the plan the Community Led Development Advisor continued to work with the board on the action plan which would determine the outputs for which the Board could report on and measure achievements.

The Democracy Team have worked with the Community Led Development Advisor to create a report template which would provide each of the actions and for future reports will request updates from members prior to the agenda closing to enable these to be placed against the action plan.

This report also provides an opportunity for the organisation to provide updates on activities/initiatives they are involved with that tie into the plan.

This will enable the community to see prior to the meeting whether there is something they would like to provide the board with feedback on and provide another mechanism for the community to engage with the Board at their six-weekly meetings.

4. Background Koorero whaimaarama

In June 2023, Her Worship the Mayor invited Community Board and Committee members to meet with her and Councillors to workshop how the partnership with Council could be improved and strengthened, to drive better outcomes for communities.

Follow up meetings between Board and Committee members with Council Managers from Democracy and Economic and Community Led Development agreed that Boards and Committees would focus on leadership on the 4 Wellbeing's, Economic, Social, Cultural and Environmental.

In November 2023, a dedicated Council staff resource to this work programme was identified and has been working closely with members of Boards and Committees to develop their framework and future work programme of focus.

It could also enable more regular updates from the organisation that tie in with board priorities. As a result, a number of hui have been held with the Community Committee to identify to establish its direction and priorities for the next two (2) years. To this end, it has developed a plan for a two year period that outlines its goals and aspirations that it is wanting to achieve under each of the 4 well-beings, including goals around engagement.

5. Community Committee Priorities Ngaa Whakaarotau o te Komiti Hapori

The Meremere Community Committee five (5) priorities are as follow:

- 1. Te Taiao Supporting the enhancement of our environment.
- 2. Kotahitanga (Unity) Valuing our diverse community.
- 3. Engagement Connecting our community to what matters most.
- 4. Successful and thriving Helping the community prosper.
- 5. Inclusive Advocate for community strength.

5.1 Te Taiao (Environment)

- 5.1.1 We will work with others to develop an awareness of the existing organisations, community groups and individuals working on environmental projects and initiatives.
- 5.1.2 We have a unique environment with the Whangamarino Wetland, which covers 7,000ha in the Waikato. It has major recreational, historical and economic values and has been designated an international Ramsar site in recognition of its status as an area of outstanding biodiversity. We will partner with others to understand the recovery and implications on the Whangamarino Wetland.

Council Committees May 2025

Sustainability and Well-Being

The May 2025 meeting of the Sustainability and Well-being Committee welcomed Waikato Regional Councillors, Storey, Nickel and Smith, into Chambers. Cr Jennifer Nickel presented an overview of the climate adaptation initiatives across the Waikato region. Her presentation shared insights from the Wharekawa 2120 project, emerging adaptation projects such as Hauraki Plains, Otorohanga, and Hamilton, while touching on collaborative initiatives like the Waikato-Tainui Councils Climate Alliance.

Regional Councils Manager for Environmental Science Mike Scarsbrook presented on two collaborative projects, of particular importance to our community, namely the Whangamarino Action Plan project, that at a sub-committee level is led by Te Kauwhata based Environmental Scientist and Te Kauwhata Community Committee member Liz Tupuhi, and the Motukaraka Scheme – a trial of infrastructure investment decision making, involving a community panel of landowners, DoC, Waikato-Tainui and Mana Whenua representatives.

Council Consultations

Long-Term Plan 2025-2034 Consultation

Council has recently completed its consultation process for the Long-Term Plan (LTP) 2025-2034, an essential roadmap outlining the district's strategic priorities and budget for the upcoming decade. This comprehensive plan aims to address various critical issues, including infrastructure development, environmental sustainability, community facilities, and economic growth.

During the consultation period, residents and stakeholders were encouraged to provide their feedback, on proposed projects and initiatives. Following numerous community engagement sessions, workshops and online forums, to ensure constituents voices were heard, Council received 555 written submissions. The feedback has assisted the Mayor and Councillors to shape a final document. Council aims to balance fiscal responsibility and making significant

investments while striving to ensure the plan aligns with the district's needs and aspirations. As Council moves forward, it remains committed to keeping our communities informed and engaged in the decision-making process. The finalised document will be presented for adoption at a full Council meeting Monday 30 June 2025.
