# Purpose of the report Te Take moo te puurongo

# 2. Executive summary Whakaraapopototanga matua

The Meremere Community Committee adopted their Community Board Plan in 2024, which outlined their vision for the following two (2) years.

Following the adoption of the plan the Community Led Development Advisor continued to work with the board on the action plan which would determine the outputs for which the Board could report on and measure achievements.

The Democracy Team have worked with the Community Led Development Advisor to create a report template which would provide each of the actions and for future reports will request updates from members prior to the agenda closing to enable these to be placed against the action plan.

This report also provides an opportunity for the organisation to provide updates on activities/initiatives they are involved with that tie into the plan.

This will enable the community to see prior to the meeting whether there is something they would like to provide the board with feedback on and provide another mechanism for the community to engage with the Board at their six-weekly meetings.

# 4. Background Koorero whaimaarama

In June 2023, Her Worship the Mayor invited Community Board and Committee members to meet with her and Councillors to workshop how the partnership with Council could be improved and strengthened, to drive better outcomes for communities.

Follow up meetings between Board and Committee members with Council Managers from Democracy and Economic and Community Led Development agreed that Boards and Committees would focus on leadership on the 4 Wellbeing's, Economic, Social, Cultural and Environmental.

In November 2023, a dedicated Council staff resource to this work programme was identified and has been working closely with members of Boards and Committees to develop their framework and future work programme of focus.

It could also enable more regular updates from the organisation that tie in with board priorities. As a result, a number of hui have been held with the Community Committee to identify to establish its direction and priorities for the next two (2) years. To this end, it has developed a plan for a two year period that outlines its goals and aspirations that it is wanting to achieve under each of the 4 well-beings, including goals around engagement.

# 5. Community Committee Priorities Ngaa Whakaarotau o te Komiti Hapori

The Meremere Community Committee five (5) priorities are as follow:

- 1. Te Taiao Supporting the enhancement of our environment.
- 2. Kotahitanga (Unity) Valuing our diverse community.
- 3. Engagement Connecting our community to what matters most.
- 4. Successful and thriving Helping the community prosper.
- 5. Inclusive Advocate for community strength.

- 5.1.1 We will work with others to develop an awareness of the existing organisations, community groups and individuals working on environmental projects and initiatives.
- 5.1.2 We have a unique environment with the Whangamarino Wetland, which covers 7,000ha in the Waikato. It has major recreational, historical and economic values and has been designated an international Ramsar site in recognition of its status as an area of outstanding biodiversity. We will partner with others to understand the recovery and implications on the Whangamarino Wetland.

### **July Update**

Members from the Meremere Community Committee have begun work on a community garden initiative with the aim to encourage members of the community to use and contribute to the garden – members may have further verbal updates to add.

### 5.2 Kotahitanga (Unity)

- 5.2.1 We will actively promote and celebrate local events that focus on significant cultural events in Meremere.
- 5.2.2 We will continue to build and strengthen our relationship with Mana Whenua.

### 5.3 Engagement (Tuuhononga)

5.3.1 As representatives of our community, if Council want to engage on specific matters, we will engage our community using various channels, in partnership with the Council, to increase engagement on these on matters of interest to ensure the voice of our community, including the voice of mana whenua, is well represented on matters relating to Meremere.

### **July Update**

Members from the Meremere Community Committee have made work on creating greater engagement in the community which has included the development of an engagement plan. The committee has since raised a call to action towards the community encouraging them to be more engaged both at committee meetings and with Council's consultations.

### 5.4 Successful and Thriving (Te Houkura me te Toonuitanga)

- 5.4.1 *Promote and advocate for local employment opportunities.*
- 5.4.2 Understand future planning for Meremere and advocate for economic opportunities that benefit the community.

### **Executive Summary - Whakaraapopototanga Matua**

### Council Committees June - July 2025

### Sustainability and Well-Being

Council held a workshop the allocations of funds to three of the district's museums, namely Tuakau, Huntly and Raglan. During the 2025-2034 LTP deliberations held in May 2025, Councillors agreed to increase an interim allocation to \$95,000. The interim approach uses the current 2021-2031 LTP grant allocation as a basis. The Sustainability and Wellbeing Committee, by majority, moved to increase the Taukau Museum Funding by 100% from \$10k to \$20K, increase Raglan Museum Funding by \$5k to \$25k, with no funding adjustments to the Hunty Museum Funding, which currently sits at \$50k. I was the only Councillor that was not in favour of a 100% in funding to Tuakau, on the basis that they are only open two days a week and that the museum is not a Council owned asset. I requested, moving forward, that each museum provide a report to the Sustainability and Wellbeing Committee in the interests of accountability and transparency.

The committee was presented with an update on the DIA Better Off Funding, which has yielded great outcomes in terms of project delivery, project assessments, budget utilisation and Council oversight.

Councils Rural Discretionary Fund has a current net funding of \$25,925.46. Councils Rural Discretionary Fund is available to those communities who do not have access to Community Board or Community Committee Discretionary Funding.

### Adoption of Councils Long-Term Plan 2025-2034

On Monday 30 June, Council unreservedly adopted the Long-Term Plan 2025-2034. Adoption of the long-term plan involved adopting the following:

- Local Water Done Well Adoption of Foundation Documents and the approval of the Water Services Delivery Plan as legislatively required
- Adoption of the Waste Minimisation and Management Plan (WMMP) 2025- 2031 as legislatively required for a six-year period
- Adoption of Councils Long-Term Plan 2025-2034 inclusive of, the Development Contributions Policy 2025, Fees and Charges Schedule 2025 2028, the Long-Term Plan 2025-2034 and;
- The Long-Term Plan 2025-2034, and the Rates Resolution Report

Council formally launched its new Transport Model; Higgins Contractors responsible for the Northern area and Fulton Hogan responsible for the Southern area, will now be delivering our roading services. Council's inhouse transport team will be managing all incoming service requests.

### **Local Government Elections 2025**

The Local Government Elections Campaign has kicked off with nominations for local body candidates having officially opened Friday 4 July.

Local voices, local decisions, local leadership. Everyday people with a heart for their communities are invited to stand for local elections. Whether as a local councillor candidate, mayoral candidate or community board candidate, local government seeks strong quality candidates to represent their communities.
