PUBLIC FORUM

Presentation from Pamela Storey, Chair Waikato Regional Council Kia ora Chair Allen,

Thank you for providing an opportunity to speak to your Committee on 22 April. It was a pleasure to connect with your members in person and discuss the proposals set out in the 2025/26 Annual Plan consultation document. I encourage the Committee members to share your views with Council.

Waikato Regional Council opened consultation on its Annual Plan for 2025/26 on 1 April. I have attached a copy of the consultation document for your information and review. As discussed in the meeting on 22 April, I wish to draw your attention to consultation topics that may be of interest to you.

- The Long Term Plan adopted last year indicated a rates rise of 8.2% in Year 2, and the good news is that this has been reduced to 5.9% in our draft annual plan.
- Waikato Regional Council is introducing a regional Public Transport (PT) rate to collect the rates needed to plan and deliver PT across the region. We have developed this rating approach based on principles including efficiency, transparency, fairness (those with greater access should pay more), and recognition that PT is a public good and we should all pay something even if it's not accessed by everyone. The proposed rate will fund bus services, Total Mobility services, and Community Transport in the region. We are proposing 5 different ratings categories across three areas based on the level of PT services available. The per property rates proposed within the Waikato District Council area range between \$76.69 per annum for a serviced Central Waikato property (that included Huntly, Ngaruawahia and Raglan)/\$38.35 for an unserviced Central Waikato property or \$26.84 per annum for a serviced Regional Waikato property (that includes Pokeno, Tuakau and Te Kauwhata)/\$11.50 for an unserviced property. Please see page 6-9 of the consultation document for details and please visit 2025/26 Annual Plan | Mahere ā-Tau | Waikato Regional Council for a rates calculator to determine the proposed rate for your property.

- We are also proposing a rates remission policy for the primary industry compliance rate that will give a full discount on the primary industry compliance rate for any portion of land that covered in native bush and therefore not utilised for primary industry.
- We have also included information in our consultation document regarding a new river and catchment management targeted rate proposed for the Wharekawa Coast (Kaiaua), fare increases for public transport, our prior year surplus, and changes to our fees and charges.

A discussion was held on the future of bus 44 between Pokeno and Pukekohe via Tuakau regarding the viability of this service. We were advised that 4132 passengers have used this service in the past 12 months.



Mayor Jacqui thanked WRC. She advised that Te Huia is not under this plan and the trial ends in June 2026

Regarding rivers and drainage, Noel advised that a boat has been obtained from Whangarei to start removing debris from the Waikato River. It will be moored at Meremere. Debris will be put on the riverbank and then when it has dried out a bit will be mulched to be used around the district for gardens, etc and could be sold to the public. Debris removal will be funded 50% by WRC and the rest from affected landowners/ratepayers. Work hopefully to commence in the next 6-8 weeks

COUNCILLORS' REPORTS

Cr Kandi Ngataki reported on WDC LTP meetings throughout the district. There has been a Sports Masterplan meeting at Pokeno School Anzac Parade starting at truck stop at 9.00 am on Friday. A discussion on alcohol outlets is coming up soon

Cr Vern Reeve advised there is no funding for widening the bridge on Pokeno Road near the school and ultimately it is the parents' responsibility to get their children to school safely.

However there is a chance that a bailey bridge might be obtained and installed which might mitigate the problem.

Traffic calming signs/ warnings regarding children near the bridge discussed at the meeting but there is still no funding

Vern confirmed he was continuing to work on this situation and will report back on progress at the nest meeting
