### 6.1. Te Kauwhata Community Committee Plan

### **Discussion**

- Cr Raumati noted that there is synergy between the Community Committee Plan and the Community Identity Strategy.
- Cr Raumati advised that the Community Committee Plan should use the Council's Te Reo policy. Dominique Thurlow to update the document accordingly.
- It was noted that the Whangamarino Wetland Group is a key stakeholder
- It was agreed that the tagline wording for the Taiao theme be changed to 'protection, enhancement and education of our Taonga'.

### 6.3.1. THAT the Works and Issues report be received.

#### Discussion:

### Dog park project

- Tim Hinton advised that it was not appropriate to make a submission through the Council's 2025-2034 LTP regarding the double gates for the dog park but that he has instead had a conversation with the Council's Open Spaces team who have advised that the Committee obtain a quote for the gate. The Open Spaces team and the Community Committee can then determine how to fund the double gate. It was noted that the double gate will address a key safety issue.
- Angela van de Munckhof queried the implications for parking and it was clarified that the area adjacent to the small dog park area can still be used for this purpose.
- Cr Raumati advised that we can remove Phase 1 of the dog park projects from the Works and Issues report and noted that the shade sails component of phase 2 has been completed. It was also noted that the picnic table should be removed from phase 2.

### Saleyard Road Walkway project

- John Cunninham and Tim Hinton will be meeting with Council staff from the Open Spaces, Enterprise Project Management Office and the Strategic Initiatives and Partnerships teams on 1 July 2025 to discuss this project. John and Tim will then bring the recommended way forward to the next Committee meeting for a decision.
- Cr Raumati advised that the amount allocated to the project in the Works and Issues report needs to be updated to \$100,000.00 (from \$150,000.00).
- Cr Raumati advised that the Committee needs to be mindful of how the Discretionary Fund is used.

- Community Identity Strategy project
  - The project team to start incorporating the Community Identity Strategy into the Community Committee Implementation Plan.
  - Cr Raumati advised that the blueprints did not feature in the LTP consultation process; and it would seem that they have taken a back seat.
- Te Kauwhata Domain Walkway
  - Tim Hinton indicated that he made a submission to the LTP for funding to get stage two of this project completed.
  - It was clarified that the objective of stage 2 is to create a circuit loop.
- Security cameras
  - The committee was advised that procurement and installation contracts have been finalised and awarded by the Council's Facilities team. A further update will be provided at the next meeting regarding installation timeframe.
- Te Kauwhata Domain Rongoa Garden project
  - Estelle Jonathan advised that some of the plants have arrived and that planting will start on the weekend.

- Tim Hinton advised that he made a submission to the Council's LTP including a gradual approach to using rubbish bags stickers, request for funding for the completion of the domain walkway and for a destination playground (Cr Raumati advised that there was an agreement that a masterplan for the destination playground will be required and completed between year 2 and year 3 of the LTP).
- Tim Hinton and John Cunningham will be meeting with Council staff from the Open Spaces, Enterprise Project Management Office (EMPO) and the Strategic Initiatives and Partnerships teams on 1 July 2025 to discuss the Saleyard Road Walkway project.
- Local Body Elections are taking place on 11 October 2025. Tim Hinton advised that
  if there are members who are thinking of not wanting to be considered for
  nomination on the Kauwhata Community Committee to please let the chairperson
  of the Committee know.
- Mayoral Awards nominees from the Mayor and the Ward Councillor for the ceremony taking place on Monday 9 June 2025.

#### **Discussion**

 Cr Raumati advised that if people have blue rubbish stickers to use them up and the new stickers will be coming up in July. Cr Raumati also advised that she has spoken to the Council's Democracy
Team about the need for induction of Committee members after the local
body elections in October 2025.

# 1. Purpose of the report Te Take moo te puurongo

Providing an opportunity for the Te Kauwhata Community Committee to report back on the delivery of their action plan.

To provide organisational updates that tie in with the actions/outcomes within the Te Kauwhata Community Committee Plan.

# 2. Executive summary Whakaraapopototanga matua

The Te Kauwhata Community Committee adopted their Community Board Plan in January 2025, which outlined their vision for the following two (2) years. Following the adoption of the plan, the Community Led Development Advisor continued to work with the board on the action plan which would determine the outputs for which the Board could report on and measure achievements.

The Democracy Team have worked with the Community Led Development Advisor to create a report template which would provide each of the actions and for future reports will request updates from members prior to the agenda closing to enable these to be placed against the action plan. This report also provides an opportunity for the organisation to provide updates on activities/initiatives they are involved with that tie into the plan.

This will enable the community to see prior to the meeting whether there is something they would like to provide the board with feedback on and provide another mechanism for the community to engage with the Board at their six-weekly meetings.

### 3. Staff recommendations Tuutohu-aa-kaimahi

THAT the Te Kauwhata Community Committee receives the Te Kauwhata Action Plan update for August 2025.

### 4. Background Koorero whaimaarama

In June 2023, Her Worship the Mayor invited Community Board and Committee members to meet with her and Councillors to workshop how the partnership with Council could be improved and strengthened, to drive better outcomes for communities. Follow up meetings between Board and Committee members with Council Managers from Democracy and Economic and Community Led Development agreed that Boards and Committees would focus on leadership on the 4 Wellbeing's, Economic, Social, Cultural and Environmental.

In November 2023, a dedicated Council staff resource to this work programme was identified and has been working closely with members of Boards and Committees to develop their framework and future work programme of focus.

It could also enable more regular updates from the organisation that tie in with board priorities. As a result, a number of hui have been held with the Community Board to identify to establish its direction and priorities for the next two (2) years. To this end, it has developed a plan for a two year period that outlines its goals and aspirations that it is wanting to achieve under each of the 4 well-beings, including goals around engagement.

# 5. Community Board Priorities Ngaa Whakaarotau o te Poari Hapori

The Te Kauwhata Community Committees five (5) priorities are as follows:

- 1. Taiao Protection, enhancement and education about our taonga
- 2. Prosperity (*Taurikura*) Growth, investment, and tourism are encouraged, and the dollar is spent in Te Kauwhata
- 3. Unity (Kotahitanga) Grow and strengthen our partnerships with Ngaa Muka, Ngā Muka Development Trust, Waikato District Council and the local community to build enduring relationships
- 4. Connection Improve social cohesion to ensure communities are connected and feel a sense of belonging.
- 5. Engagement (*Tuuhononga*) We are committed to citizen-led decision making

### 5.1 Taiao

5.1.1 We have a unique environment with the Whangamarino Wetland, which covers 7,000 hectares. It has major recreational, historical and economic values and has been designated an international Ramsar site in recognition of its status as an area of outstanding biodiversity. With the recent fire that destroyed over 1000 hectares of this wetland the Community Committees will gain an understanding of the role it can play in its recovery.

### 5.2 Prosperity Taurikura

- 5.2.1 A thriving economy is dependent on growth, investment and tourism and all have a considerable positive impact on Te Kauwhata. As such, the Community Committee, in partnership with others will explore opportunities to attract visitors to the village.
- 5.2.2 In partnership with others, a stocktake of existing events and visitor attractions will be undertaken. Upon completion these events and attractions will be promoted through a variety of communication channels.

- 5.3.1 As a Community Committee we are committed to deepening our connection and growing a greater awareness of our local history. To do this we will work alongside Ngaa Muka to explore and create this awareness

- 5.4.4 Development of a walkway on Saleyard Road
- 5.4.5 Develop a walkway and fitness trail in the Te Kauwhata Domain to support and enhance the health and wellbeing of our community.

### Capital Projects Update (as of 21 July 2025)

### **Stormwater Reticulation Upgrades**

The initial objective to replace the collapsed stormwater pipeline beneath the KiwiRail corridor was completed and commissioned by the end of May. This allowed upstream flows to be redirected under the railway to the new discharge outlet ahead of the heavy weather in early June, averting a potential localised flooding event and marking a key milestone for the project.

The remainder of the network upgrade, including the installation of a new chamber and 10–15 metres of additional pipeline, remains on track for completion by the end of June, with minor concrete works and reinstatement activities expected to continue through July 25.

Delivery has been challenged by a combination of adverse weather, high groundwater, and poor ground conditions. In particular:

- Significant undercutting and ground improvement works were required to provide adequate support for the new pipe.
- Excavated material was unsuitable for reuse, resulting in large volumes needing off-site disposal, which has contributed to delays.
- During the works, the existing large chamber was identified as being in poor condition and requiring full replacement. This has since been added to the scope.

Despite these challenges, the team remains focused on completing the major works as programmed, with ongoing efforts to minimise further delays.



### **Catchment Management Plans (CMP)**

The Catchment Management Plan for Te Kauwhata has been completed and will be available to the public soon.

### Stormwater Ponds performance testing and asset monitoring

Stormwater pond clearance and planting works are underway in Te Kauwhata. More planting work will be completed during the 2025 FY.

### Sustainability and Well-Being

Council held a workshop the allocations of funds to three of the district's museums, namely Tuakau, Huntly and Raglan. During the 2025-2034 LTP deliberations held in May 2025, Councillors agreed to increase an interim allocation to \$95,000. The interim approach uses the current 2021-2031 LTP grant allocation as a basis. The Sustainability and Wellbeing Committee, by majority, moved to increase the Taukau Museum Funding by 100% from \$10k to \$20K, increase Raglan Museum Funding by \$5k to \$25k, with no funding adjustments to the Hunty Museum Funding, which currently sits at \$50k. I was the only Councillor that was not in favour of a 100% in funding to Tuakau, on the basis that they are only open two days a week and that the museum is not a Council owned asset. I requested, moving forward, that each museum provide a report to the Sustainability and Wellbeing Committee in the interests of accountability and transparency.

The committee was presented with an update on the DIA Better Off Funding, which has yielded great outcomes in terms of project delivery, project assessments, budget utilisation and Council oversight.

Councils Rural Discretionary Fund has a current net funding of \$25,925.46. Councils Rural Discretionary Fund is available to those communities who do not have access to Community Board or Community Committee Discretionary Funding.

### Adoption of Councils Long-Term Plan 2025-2034

- The Long-Term Plan 2025-2034, and the Rates Resolution Report

Council formally launched its new Transport Model; Higgins Contractors responsible for the Northern area and Fulton Hogan responsible for the Southern area, will now be delivering our roading services. Council's inhouse transport team will be managing all incoming service requests.
