6.4.1. THAT the Works and Issues report be received.

Discussion:

- Dog park project
 - Ian Wrigley advised that community feedback has indicated that the agility equipment needs attention.
 - In considering an email from a member of the community (Beryl Martin) asking if any consideration has been given to a double gate system at the dog park (like what is at Pookeno) to separate groups of dogs, Tim Hinton advised that he will lodge a service request on behalf of the Committee for the double gate and for an enclosed area for small dogs with a separate access.
- Saleyard Road Walkway project
 - Council staff will have a discussion regarding cost factors related to
 potentially using the Kiwi Rail land for an extension to the walkway. The
 costs relate to the requirement to fence the land and ongoing maintenance
 of the walkway. Once Council staff have had a discussion regarding
 ownership and funding responsibility, we will contact the Chairperson of
 the Community Committee, John Cunningham, to discuss it further.
 - Cr Raumati express her concern regarding ongoing maintenance costs, once the project has been completed, which will impact rates. A wider discussion was had by the Committee that there are more efficient uses regarding the committed funds.
 - A decision on this project will be made at a subsequent Committee meeting.
- Community Identity Strategy project
 - Lauren Hughes advised that the project team has met and developed a highlevel priority action plan relating to the social, cultural, economic and environmental components of the Community Identity Strategy. The action plan was shared with the Committee.

- Cr Raumati advised that there are several actions in the priority plan that she has already addressed and provided an overview of these. Lauren Hughes will tick these off in the plan since they have already been completed.
- Cr Raumati indicated that she will be directed by the community as to whether they want the destination playground removed from the LTP because once a project is removed from an LTP, it's difficult to put it back on; and that the project has been pushed out to Year 9 of the LTP.
- Cr Raumati indicated that the Council is required to consult with Mana Whenua on matters pertinent to the Te Kauwhata Domain, as per Council reports received in the Council Chambers, as Mana Whenua has an interest in the Domain.
- Te Kauwhata Domain Walkway
 - Stage 2 of the project is dependent on funding through the Council's 2025-2034 Long Term Plan.
- Security cameras
 - The Council's Facilities Team has advised that the design work has now been completed and that they are currently working on priority locations within the relevant towns based on information provided by NZ Police and that these will also be assessed against indicative costing.
 - At this stage Te Kauwhata has four cameras identified through the design process, but due to priority and costs it is likely that only one camera per town will be installed until there are more funds available. The cameras will have 360 degrees views as per the images shown in the agenda.
 - The Te Kauwhata Community Committee resolved that the preferred location for the first camera is the Te Kauwhata Roundabout adjacent to the Waikato Expressway. However, if there is funding for a second camera the Committee resolved that the proposed location at Swan Road, Waerenga, is preferred for this.
- Te Kauwhata Domain Rongoa Garden project
 - Estelle Jonathan advised that she is continuing to work on sourcing plants and vegetables with mana whenua.

Project Summary

The Te Kauwhata dog park will be revamped to include a dog agility course and a fenced-off area for the more timid small dogs to play and exercise without fear of being encroached upon by larger dogs. Additionally, the dog park will also benefit from the development of two shaded picnic areas with picnic tables in them so members of the community can enjoy the area more with their families. Parking for overflow of the rugby club events has been fully considered.

Lauren Hughes was tasked with updating the action plan based on the feedback received and circulate it to the Committee.
Funding:	There is funding available from the Council's Blueprint budget to assist with strategy development. Discussions are underway with Kainga Ora for additional funding. It is important to note that this funding is not intended to fund individual projects that may fit within the strategy. Once the Strategy is complete additional funding will be required for initiatives within the Strategy.

Project Summary

- A subcommittee drawn from Te Kauwhata Community Committee members and invited stakeholders has formed and meets regularly to guide the development of an Identity Strategy. The purpose of the Strategy is to articulate those things that make our sub-region unique and create a tool for planning and advocacy that will focus future investment and development in Te Kauwhata and Districts in such a way that connects, protects, and celebrates those central pillars:
 - Our unique environment (wetlands, waterways, and associated wildlife)
 - Our unique culture and history (Rangiriri pa and other sites and stories of historic significance)
- The Strategy will be a guiding document stating a 50-year vision and the associated social, economic, environmental, and cultural outcomes sought for Te Kauwhata over the next 50 years. It will also include the short, medium and long-term projects and goals required to achieve that vision.
- The Strategy will broadly cover the geographic area between the five Ngaa Muka marae Hora Hora, Maurea, Waikare, Taniwha and Okarea. There is an acknowledgement that this is a soft border and important environmental and cultural features such as the Whangamarino Wetlands and the connection between Rangiriri and Meremere may require a flexible, inclusive approach.
- The Strategy will record aspirational, community-led, long-term goals for our region that will be used to:
 - Advocate and inform the planning of other stakeholders in our region including local and regional council.
 - Identify and drive key projects that will realise the goals of the Strategy and cement the Identity of the region internally and nationally.
 - Provide a strategic focus for the development of other community-led amenities.
- Prior to drafting the strategy, the Project Team will lead community and stakeholder consultation. The council has contracted an external agency "Interactionz" to facilitate the community engagement, while Kāinga Ora is funding and organising the Community Day and Community workshop as part of the community Consultation Process.
- The project team collated the community contributions, drawing out common themes and ideas to progress further with relevant stakeholders. The team has used internal resources to draft the Strategy.
- The draft strategy was sent to the Te Kauwhata Community Committee members for feedback in November 2024.
- The feedback was collated and included, and the draft strategy has been sent to the designer for proof reading, formatting and designing with the view of presenting to the Committee in February 2025.
- The final Strategy will include mechanisms for how it will be implemented, monitored, and used. The Project Team will continue to take a key role in these matters and update this document to detail Phase 2 at the proper time.





Capital Projects Update (as of 19 May 2025)

Te Kauwhata WWTP Pond

Operational upgrade - Aerdisc installation in retention ponds 1 and 2 - Late April. This sets new standards of oxygen transfer efficiency, improved maintenance, and lifespan.



Water Supply Renewals Programme (24/25) - Package 1

On Scott Road in Te Kauwhata, following the successful upgrade of the planned roundabout construction, works have progressed with the team focusing on the installation of the remaining 700m length of the pipeline.



A collapsed stormwater culvert beneath the North Island Main Trunk railway line in Te Kauwhata has triggered the need for a full network replacement and upgrade. Following KiwiRail's approval to access the rail corridor on March 31, construction of the new culvert is now underway.



The critical rail crossing is being carried out by an experienced subcontractor using highprecision technology to minimise disruption to railway operations. The Axis guided boring system, which combines laser-guided horizontal directional drilling with pipe jacking techniques, is being used to install the new culvert.

This system's pinpoint accuracy has already delivered a successful 300mm pilot bore, completed smoothly and on target.

Sustainability and Well-Being

The May 2025 meeting of the Sustainability and Well-being Committee welcomed Waikato Regional Councillors, Storey, Nickel and Smith, into Chambers. Cr Jennifer Nickel presented an overview of the climate adaptation initiatives across the Waikato region. Her presentation shared insights from the Wharekawa 2120 project, emerging adaptation projects such as Hauraki Plains, Otorohanga, and Hamilton, while touching on collaborative initiatives like the Waikato-Tainui Councils Climate Alliance.

Regional Councils Manager for Environmental Science Mike Scarsbrook presented on two collaborative projects, of particular importance to our community, namely the Whangamarino Action Plan project, that at a sub-committee level is led by our very own Environmental Scientist and committee member Liz Tupuhi, and the Motukaraka Scheme – a trial of infrastructure investment decision making, involving a community panel of landowners, DoC, Waikato-Tainui and Mana Whenua representatives.

Long-Term Plan 2025-2034 Consultation

Council has recently completed its consultation process for the Long-Term Plan (LTP) 2025-2034, an essential roadmap outlining the district's strategic priorities and budget for the upcoming decade.
