6.1 Establishing Pokeno Governance Committee in relation to Munro ports field.



Joe Wilson Youth Engagement Advisor WDC, introduced himself and reiterated that council wants to get on with the Munro Sports field development land and facilities. Collectively with a Pokeno Governance committee Councils team can begin planning towards the potential usage of the site. Earthworks should take place over the next 2 years and then usage of the land can be shaped with community involvement. Jason Marconi Sports Waikato along with Joe Wilson will foster the relationships in the sport and recreational sectors and various groups to get the best outcome for Pokeno.

COMMUNITY PROJECTS UPDATE

Parks

Munro Road Sports Park

Harrison Grierson consultants, who carried out the preliminary design, have been engaged to assist with project management of the sportspark.

The earthworks for initial phase of earthworks of the project went out to public tender in December to be awarded at the end of January:

- The stream diversion contract was advertised on Government Electronic Tender Service (GETS) from Monday 16 December 2019 – Tenders close Friday 31 January 2020.
- Tender award is scheduled for Friday 14 February 2020.
- Contract start date is scheduled for Monday 2 March 2020 target completion Thursday 30 April.
- Contract is being fast-tracked to ensure planting for vegetation establishment can start in May, to enable the stream diversion to be made live next summer. This will enable the filling of the old stream bed and ongoing earthworks next summer.

Work is underway with Community Projects, Community Development and Sport Waikato staff to promote the forming of a Pokeno Sports Forum to be made up of representatives from local sporting clubs and groups, Pokeno School, Pokeno Community Committee and other key stakeholders. The forum is intended to provide a community voice into the development of the Munro Sportspark, as well as having a holistic overview of the sports groups and recreational facilities serving Pokeno.

Wastewater

Pokeno Wastewater Reticulation Scheme, Phase 3 (expected completion March 2020).

The contract (17/224) is for the completion of the scheme-subsidised private drainage connections in Pokeno. The contract was advertised in October and closed 29 November. The contract was awarded to Pipescape NZ 16 December 2019 for a tendered sum of \$145,205. Works are expected to get underway in January and completed in March 2020.

Toilets

Pokeno

Contract 18/213 to refurbish toilet facilities at Great South Road, Pokeno and at The Point, Ngaruawahia was awarded to ESN Construction on 3 December 2019 for the tendered sum of \$280,987. The construction period is 16 weeks and all works are to be completed by end of June 2020.

Urban Upgrades

Pokeno Main St Urban Upgrade

Design for the upgrading of parking on unformed Wellington Street (west) is continuing. The approach is to provide an interim extended sealed carpark to maximise marked carparks to cater for the five year time horizon. The carpark will be constructed and marked prior to the supermarket development closing off the current carparks opposite the shops (apart from 4 parks as per the supermarket agreement for site access).

Preliminary design will be provided to the Pokeno Community Committee for review and feedback.

Cemeteries

Whangarata Cemetery Development (expected completion May 2020)

The contract for Whangarata Cemetery is currently being developed. Munro Sportspark stream diversion has been prioritised over this, due to the criticality of the stream diversion earthworks timing in order to establish plants in autumn, so the stream diversion can take place next summer.

COMMUNITY CONNECTIONS UPDATE

The Community Connections team would like to propose the planting of fruit trees in parks and reserves in Pokeno for the benefit of the community.

Benefits include access to healthy, free food that is easily accessible and the opportunity for developing relationships within the community in the planting of the trees and harvesting of the fruit.

We are proposing to initially plant between 10 and 30 fruit trees in the central wetland/reserve area in the Helenslee subdivision, in locations suited to the growing requirements of the fruit trees.






