Chair Ric Odom, welcomed Team members from Counties Power and Yashili along with members of the public.

3. DISCLOSURE OF INTEREST



There was no disclosure of interest. All Committee members were reminded of the need to complete and submit a Declaration Form.

4. PUBLIC FORUM

Counties Power ,Judy Nicholl ,Chief Executive, introduced her team responsible for the installation and programming of the new Pokeno Substation. By mid-2020 the new \$20 Million substation (including underground cabling to the Pokeno Main street) will be completed with supply to the Pokeno area. The result will be a more reliable power supply and less reliance on the current Tuakau substation.

Yashili team was represented by Dieter Krietinger and Executive Assistant Li Huang. Dieter explained that they are an Infant formula producer using cow, sheep and goat milk reconstituted into Baby infant formula destined for sale Worldwide with China as the dominant market. He explained that Yashili is very cognisant of responsible production and practices that they do not use Chlorine/Bleach for sanitising etc that they in fact use a NZ first 'Ozone' natural occurring water purification system.

Dieter has invited the Pokeno Community to an Open Day on the 29th March. This is part of Yashili's determination to be more involved with the Pokeno community.

There were no further questions from the public in attendance.

6.1. Pokeno Works and Issues Report January 2020.

Clive Morgan introduced Jim Ebenhoh Acting GM Community Growth WDC.

Clive reported in January very little had progressed due to holiday period, however.

Parks, Munro Sports block.

The contract for stream diversion is Scheduled to commence Monday 2nd March, with completion 30th April. The contract is being fast tracked so riparian planting can take place before winter.

Sport Waikato staff in conjunction with Community Projects ,Community Development staff, are working with Community groups ,schools, local sport clubs, Pokeno Community Committee and other stakeholders and is providing a collective voice to the overview of how the Sports Park should serve the various recreational needs of the community.



Wastewater

Pokeno wastewater reticulation scheme which was to commence in January has been rescheduled to commence 10th February (confirmed by Cr Church) with completion still on track for completion end of March 2020.

Toilets

Toilet refurbishment is to be undertaken before June 2020 and completed by ESN construction. Cr Church said there should be minimal disruption to public usage as the Pokeno upgrade was possible just painting and installation of a Modesty barrier! Cr Church suggested portaloos whilst the upgrade takes place.

Update on Pokeno – Pukekohe Bus Service


A planned new public bus service will be implemented between Pokeno and Pukekohe via Tuakau later in 2020. Procurement of the service has unfortunately been further delayed due to the need to respond to public transport issues arising from COVID-19. The bus market is currently in a state of major uncertainty due to COVID-19, however notwithstanding this WRC envisages it is possible to undertake a procurement exercise for a fixed route service in a 6 month period and would work with successful tenderer to establish services within a shorter timeframe if possible.

The Route 44 Pokeno to Pukekohe route is designed to connect the Pukekohe, Tuakau and Pokeno townships, including providing connections at Pukekohe train station. The service will operate on Monday to Sunday each week (excluding public holidays). The route will replace the existing service between Pukekohe and Tuakau, operated by Auckland Transport. The service is designed to integrate with arrival / departure times at Pukekohe station.

The route is part of a review of bus services in the North Waikato and is included in the Regional Public Transport Plan and Waikato District Council's Long Term Plan. The service will be funded by a combination of NZTA (51%), Waikato District Council rates and fares. Waikato District Council, in partnership with Council and NZ Transport Agency undertook a review of public transport provision in the North Waikato area in 2017. The review made a number of recommendations, including the introduction of a new regular bus service between Pokeno and Pukekohe (via Tuakau).

The service trial will run for an initial period of 2 years with and optional extension of 1 plus 1 year. Any extensions will be at the Council discretion and will be dependent on the good performance of the tenderer and satisfactory uptake of the service. If the service proves successful, it is anticipated that NZTA funding will be secured to provide the service on a permanent basis.





Proposed Route

Potential Future Demand Responsive Service

WRC has agreed to work with Waikato District Council to examine the potential for a future 'demand responsive' service, which would provide some benefits which cannot be achieved with a fixed route service. Such a service would be staged after the delivery of the fixed route service between Pokeno and Pukekohe.

The service would follow a model of operation which is being trialled in some areas of New Zealand, offering better coverage of the north Waikato area and providing access to services and facilities to areas which have limited access to public transport currently. This includes the settlements of Meremere, Mercer and Mangatawhiri. Port Waikato could also be served on a demand responsive basis. Services could connect through to Pokeno, Tuakau and Pukekohe.

Under this mode of operation, the timetable would be flexible but passengers would have well-defined and published criteria of where and when passengers can be picked up or dropped off. Passengers would share a vehicle which will be a mini-bus to midi-bus size and be low floor accessible.


DRT services allows provision of increased access and coverage of the district for a lower cost compared to a traditional fixed route service. For example, services would not operate on days when there are no pre bookings which will allow cost savings compared to a traditional fixed route service.

It is envisaged that such a service would be jointly managed by WRC and the service operator. Bookings must be made in advance using a mobile phone application (example shown below), a website or by

calling a call centre. DRT could supplement the two bus fixed route service operating every 40 minutes during the peaks, providing connections with that service where possible.

The service would be jointly promoted to medical centres, WINZ, retirement homes etc. Staff at those institutions would be able to book travel on behalf of clients. This will give customers the options of being able to book both an appointment and travel at the same time. Customers will also be able to book travel directly.




Screenshot of application running in Timaru demand responsive trial

Proposed Vehicle

Smaller vehicles typically suit this mode of operation. These are available at slightly lower cost than full size buses and are more cost effective to operate, however the trade-off is reduced seating capacity. Some examples are shown below.

Report Title | Waka Kotahi (NZTA) - Innovating Streets for People

I. EXECUTIVE SUMMARY

Waka Kotahi announced in April 2020, the availability of targeted funding for successful applications, as part of their Innovating Streets programme. Funding for the project would be 90% Waka Kotahi and 10% from the Waikato District Council Roading budget.

This presentation is to explain the purpose of the Innovating Streets funding and what tactical urbanisation involves. We are wishing to determine if there are any small place making or street transformation projects, within the Pokeno area, that would be suitable to be put forward for consideration. As these projects are trials that transform an area, community support and advocacy for change is important.

If a suitable location/project is identified, then Janette Underwood would look to work with community respresentaives to complete and submit the application. Applications close 3 July 2020 with successful applicants advised on the 31 July 2020.

Innovating Streets for People

FUNDING APPLICATION GUIDELINES

What is the Innovating Streets fund?

Waka Kotahi's Innovating Street for People Pilot funding is:

- > A Pilot Programme for projects using Tactical Urbanisation
- Funding is provided at 90% Waka Kotahi / 10% Waikato DC
- Waka Kotahi provide support for project development and monitoring
- Projects must be completed by June 2021





What is Tactical Urbanisation?

Tactical Urbanisation is a process that provides:

- Temporary, or semi-permanent, physical changes to streets
- Improvements that test a permanent fix and prototype a street design
- Activations that help communities re-imagine their streets

Why do Tactical Urbanisation?

Tactical Urbanisation gives communities a chance to get a sense of what their streets could be like in a tangible way rather than relying on their ability to interpret plans

- > Layouts can be changed in real time in response to issues
- >Gives users time/opportunity to adjust their travel patterns
- > Effects on the wider network can be observed

What Waka Kotahi is looking for....

Waka Kotahi are looking for projects that:

- ➤ Have good / clear community support
 - Co-design is an important element of the process
- ➤ Aligns with an existing plan/strategy for the area
- Tests a street layout that:
 - Improves safety by reducing vehicle speeds
 - Creates transport choice by making walking and cycling more attractive
- > Has a view to permanence

What Waka Kotahi is not looking for....

Waka Kotahi are **NOT** looking for projects that:

- Create parking areas
- ➤ Complete or mirror existing walking or cycling infrastructure
- > Are permanent installations

Example

Waka Kotahi are looking for innovative use of space not the implementation of textbook engineering features.

For example marking a standard cycle lane on each side of a road is textbook, the creation of a temporary two-way on road cycle lane on one side of the road and redistributing the road space is innovative and could lead to a permanent layout

What type of projects can be applied for?

The types of projects that could be applied for include:

- Interim intersection safety improvements (e.g. kerb build-outs / roundabouts)
- Projects to improve placemaking
- Projects that reinforce the context of the street (business/economic activity areas, school traffic calming)
- Piloting a cycleway-, pedestrian- or public transportnetwork.

Key application questions

The key questions that we need to answer in our application are:

- ➤ What is the issue you are trying to address?
 - o Is there poor connectivity to school / shops / business?
 - O Does the road sever a community?
 - o Is there a lack of space for social distancing?
- ➤ What are you testing?
 - Making users feel safer?
 - Generating an increase in number of walkers/cyclists?
 - Creating a change in travel patterns?
 - Moving vehicles away from vulnerable road users
 - Creating a mode shift
- ➤ How will you know if you are successful?

All Council is required to do is collect the Gas or Electrical certificate on completion of the work - some basic checks would be done if this work was part of a building consent, restraints, documentation and ventilation, in regards to location to openings in the building etc. However, these gas bottles need to be restrained and if more than 100kg of Gas is stored in one location then a Gas Location Test Certificate would be required also.

COMMUNITY PROJECTS UPDATE

Parks - Munro Road Sports Park

The stream diversion earthworks contract was awarded to MacKenzie and Parma Civil Construction, based out of Takanini in Auckland, with a tendered sum of \$1,054,711.69. Establishment was delayed by a combination of delay in information supplied by the contractor and the Covid-19 lockdown coming into effect. The contractor did not establish on site.

During the lockdown, a spring (October) start was negotiated with the contractor. It is expected there will be some variations claimed to cover Covid-19 delay costs such as bond and insurance costs.

Development of the Munro Sports Park was also included in the recent 'Shovel Ready' project suite provided to MBIE for possible Stimulus Funding.

Wastewater - Pokeno Wastewater Reticulation Scheme, Phase 3

Expected completion March 2020. Contract 17/224 for the completion of the scheme-subsidised private drainage connections in Pokeno is nearing completion with 13 of the 15 scheduled connections completed.

Toilets - Pokeno and The Point, Ngaruawahia

Contract 18/213 to refurbish toilet facilities at Great South Rd, Pokeno and at The Point, Ngaruawahia was advertised for tender and two tenders were received. One of the tenders was rejected due to insufficient Health and Safety systems. The contract was awarded to the remaining tenderer.

Difficulties in receiving a complying Site Specific Safety Management Plan (SSSMP) and the contractors preference not to change their health and safety procedures to meet the contract requirements, has resulted in a request by the contractor to terminate the contract.

Discussions are now underway to confirm the contract termination formally and close this off. Once resolved these works will be bundled with other similar works. By bundling, it is expected that the larger contract package will attract larger organisations with health and safety systems more compatible with Councils contract requirements.

Cemeteries - Whangarata Cemetery Development

Work is ongoing with preparations for contract documents.

The timing for the Whangarata cemetery contract to be tendered is yet to be confirmed. The contract is to be advertised in June and tenders evaluated and awarded ready for earthworks to start in spring.
