# 7.1 - SHI Papakura to Bombay Project Update

Brief outline from Jenny Wild (Waka Kotahi), Nettie Bird (Fulton Hogan) and Ash Mitchell (Fulton Hogan), regarding SHI upgrade between Papakura and Bombay, including not having ghost lines on roadway, storm water and walking/cycling track. This also involves rebuilding two bridges over SHI Papakura to BP station to be completed in two years.

#### Item I - LTP Update

- Sculptures In response to the request for clarification on the issue of the Totara Park Sculptures and netting, the committee recalled that when Colin Bottica of Dines Group addressed the committee previously, it was indicated that the intent was that Dines would commission a Maori artist to produce a set of carvings reflecting Pokeno history and that these would be installed at Totara Park.
- Playing surface At the same briefing, the committee's recollection is that the playing surface is primarily for older children along the lines of a half-court basketball court, which would be installed with appropriate netting surrounding it.

**ACTION:** Council staff to follow up on both items with Dines.

#### Item 2 - Public Transport - Hamilton to Auckland Corridor Initiative

Addressing the challenges facing bus access along the route on the Hitchen Block side of Pokeno, the committee was advised that this is being addressed and should be solved in May.

Proposed date for AGM (September/November 2021) for discussion at the next meeting.

Discussion on Avon Road connectivity, East/West Pokeno - With the upgrade of the recreation centre and potential construction of a marae on Avon Road, the committee felt that the road should be improved to allow for better connectivity.

Allen Grainger advised Doug Rowe and Community Patrol have raised \$10,000 towards new Patrol vehicle and are asking Council for funding to match this amount. 20 May is the date of the funding meeting. Local car dealer has advised he can offer a special price.

Suggested PCC have a list of public attendees at the PCC meetings. Name and phone numbers would be useful if PCC needs to contact them, subject to meeting the requirements of the Privacy Act.

Chair, Ric Odom thanked the visitors and public for their attendance and contribution. There being no further business the meeting was closed at 9.22 pm.

#### POKENO COMMUNITY COMMITTEE SUBMISSION ON THE LONG TERM PLAN

The following is the submission of the Pokeno Community Committee (PCC) on the Waikato District Council Long Term Plan.

A member of the Committee (the Chairman and/or a delegated committee member) would appreciate the opportunity to speak to this submission.

#### Matters on which comment have been specifically requested

#### **Rates**

The PCC opposes the % of increases proposed.

- Can the WDC revisit it's financial portfolio to look for opportunities to be able to subsidise and lower the proposed rate increases over the next 3 years?
- What % of the three tier rates system is actually apportioned to Pokeno as the fastest rising service centre in North Waikato. Infrastructure, traffic and public amenities are critical items to be included in the LTP for Pokeno.
- Pokeno community members on fixed incomes how do they cope with these proposed rates increases? Although their properties value up, they are still cash poor. What can WDC do to help these folk? Can the rates rebate criteria be reviewed to enable better support fixed income whanau?

#### **Pension Housing**

The recommendation of the PCC is that pensioner housing stays with WDC.

- How will a dedicated social housing provider "know" the Community and what the community's needs are?
- Housing provision is a super-hot topic. There is no time for a new housing provider to survey
  the communities/folk that need housing. This decision deserves greater consideration by
  WDC and the communities it serves, as this is people's lives that will be affected and those
  folks do not need that level of stress in their lives.

#### **Inorganic collection**

The recommendation of the PCC is that inorganic rubbish collection continues to be provided by the WDC.

How does the community, who do not have accessible/transport means, supposed to take
recycling to a refuse station? How do they manage? With the discontinuation of this
services, do our communities become overrun with inorganic rubbish piles and will this
encourage/increase illegal dumping? Our third age people (over 65's) find this service so
convenient and allows the recycling of their disposed items, to be treated in the most
environmentally appropriate way.

#### **Community Facilities**

A new Library was to be built in Pokeno for use in 2021. It was in the 2015 LTP and 2018 LTP and has not been delivered by WDC. We don't see this in the draft 2021 LTP and this is hugely disappointing, as is the non-delivery and delay of other projects: infrastructure, traffic, new CBD and other amenities our fast-growing community needs. This 'library' should be more than a repository for books. It should be a community hub which incorporates community rooms, an information centre (Pokeno is the northern gateway to the Waikato), toy library etc. Consider replacing and/or significantly upgrading the Pokeno Hall so that one well-designed and modern building could serve this function.

#### Other matters

**Roading.** Accepting that roading is a significant issue across the Waikato District, the PCC would like to see a consolidated outline of all roading projects proposed for Pokeno, including scope, start and completion dates.

**Market Square.** The Council will be aware that significant public consultation has occurred with respect to the Market Square development yet developments in and around this area appears to be proceeding which appear to be inconsistent (in some cases) with the design. The PCC would like to see the Market Square concept re-visited with a view to finalising a design that is acceptable to the residents and which is accompanied by a plan (even in outline) which shows how and when Market Square will be developed in order to achieve the desired endstate.

**Sport & Recreation.** While the Munro Sports Block is actively being progressed and the recreation area on Avon Road is similarly being upgraded, there remains a lack of sports and recreation facilities and areas which would suit the current and future requirements of Pokeno. Recent experience with developer-provided areas (such as the Totara Park area adjacent to Hillpark Drive) have not been completed to the standard residents were led to expect and the PCC would like to see greater accountability for developers and oversight/management by WDC staff to ensure that what is promised is delivered.

**Connectivity.** Connectivity – especially between the eastern and western parts of Pokeno remains an issue. In particular, the PCC recommends WDC continues Market Street W under the existing Expressway to link with Market Street E in Kowhai Downs and that improvements are made along the Dean Road/Fraser Road/Avon Road corridor to improve safety and connectivity between the West side of Pokeno and the recreation area – and potential marae – on Avon Road.

**Great South Road/Pokeno Main Street.** WDC is well aware of concerns and issues raised about the state and development (or lack thereof) along the main street of Pokeno. In particular, the PCC requests that WDC take all actions possible to further the aims of the urban design work noting that the PCC feels the continuation of the GAS fuel station and Z Truck Stop in their current locations is inconsistent with achieving these aims.

**Public Toilets.** Given the public toilets on Great South Road have always been heavily utilised and accepting that temporary toilets are currently in place, WDC should look to replacing these temporary toilets with permanent facilities which reflect the design guide for Pokeno Village.

**Public Transport.** Noting that a bus service has commenced, this service was limited from the outset as sections of roads along the bus route on the Hitchen block side of Pokeno were too narrow for the buses to navigate when cars were parked on the street. This should be addressed as a matter priority. Hard-standing (and ideally shelters) should be constructed at bus stops.

Pokeno is forecast to be the largest service centre in the North Waikato that has critical links into the Auckland region. WDC planning needs to be ahead of those projections in terms of the needs of our community. While the PCC acknowledges that WDC has limited resources and that all communities in the District also have projects they need to be completed, it should be noted that Pokeno – already more than 5,000 in size and growing rapidly - has almost none the facilities other centres have and which have come to be regarded as at least the minimum required. Moreover, the rates being charged – already high by any standard – are proposed to grow higher still. Frankly there is a growing undercurrent of discontent, if not anger, in the Pokeno community that they are being required to pay such high rates yet see very little return for those rates.

# Phase II Earthworks - Old Stream Infill and Earthworks



#### **Cemeteries - Whangarata Cemetery Development**

Pricing is being received for the repair of the watermain in Whangarata Road damaged by power cable installation. Cost recovery is being sought from the utilities company. The entranceway construction will be included in this contract works as it can't be progressed until the watermain repairs are complete.

The car park and internal roading pavement works are nearing completion with all concrete kerbing complete and basecourse construction underway.
