PUBLIC FORUM

Public Toilet presentation by Regan Powell and Moira Coutts

A presentation took place regarding installation of new toilets on Great South Road, Pokeno. Following decisions made:

Roofline: Miners Hut Gable, Cladding: Weatherboard

Colour: Lichen

Committee stated that a minimum of 10 pans, preferably 12 pans (6 units) be installed due to volume of visitor traffic to Pokeno, much more than Te Kauwhata, particularly in tourist season. As many as possible to be wheelchair accessible. This number is to future proof installation and to prevent future disruption when extra pans have to be installed Discussion to extend rooflines between units to provide weatherproof access. This might be

an issue due to storm water, but BECA to come back to the committee with options. There was a discussion re installation of the Tiny Library at the front of the structures and the extension of the roof line at the front to provide weatherproof access. Height for Tiny Library should be at street level to enable easy access to all. Helen Clotworthy to send picture of Tiny Library to BECA for them to come back to the committee with options Suggestion to install tables and chairs and possibly bike racks in the park adjacent to the toilets was tabled

Installation date March/April 2023

Existing temporary toilets will remain in place until new ones are installed.

COUNCILLOR'S REPORT

From Cr Jacqui Church

Cr Church provided printed copy of her report from last meeting She discussed the following:

Possible Railway Station in Pokeno. Submissions to be done online. All Committee members in favour

Local alcohol policy. Advised to resubmit to extend map change to sensitive areas to include area from Pokeno Hall to Munro Park

Public Places Bylaw to cover, parks, reserves, cemeteries, parking, taxi stands, bus stops, etc. Councillor will send copy to committee members

3 Waters. Copy of proposed policy for WDC emailed to all committee members. Rates are bound to increased to approximately \$6000 per annum in the next 8 years

Bus between Pokeno and Papakura. Request for 2 buses per day to/from Papakura declined at this stage. Council waiting to see how the service is patronised with single return trip daily

WORKS AND ISSUES:

Clive Morgan discussed the Central Government directive to WDC which will change the District Plan for medium density housing on smaller plots of land

He defined medium density as higher level coverage: building up to 11m high, up to 3 stories, 50% coverage of the site,

Potential rezoning of Huntly, Te Kauwhata, Pokeno, Tuakau including medium density in town centres. Clive suggested resubmissions to prevent future housing plans on Great South Road

He emphasised that the directive will not override any covenants on the land Draft Variation 3 delayed to 19 August. Notified to the public and there will be no appeals. Submissions extended to close 03 September.

Price Waterhouse recent report states that as demand increases in main centres, there will be a decrease in greenfield areas

WDC future plans for 52 hectares alongside River Waikato at Mercer. Potential transfer from Department of Conservations to local iwi. To be advised after further consultation

Contract is being written for the importing if cleanfill and construction of the Sports Park up to the final field level and also construction of the carpark.

Discussion took place regarding the building of clubhouse/skatepark etc. This will require a lot of fundraising from the community

Future of Pokeno Hall also discussed once the community Hub is completed. Left open for discussion at a future date as the Hall is used every day and is almost fully booked

Ric Odom advised he had made a submission online re new transport hub. Also that there are numerous emails regarding 274 appeals which are very important in view of the new Government directive regarding high density housing

SEPTEMBER 2022: This site is programmed to be tidied up (mow spray, trim, remove foreign material\rubbish), works should be completed by mid-September, and then this site will be added to the regular 4 weekly schedule. Pokeno Tennis Courts

Contractor pricing is being reviewed.

Pokeno Sports Park - Northern Fill and Carpark Construction

The contract development is continuing. Construction is scheduled between October 2022 to April 2023.

Pokeno Toilet Replacement

The Community Projects Team presented options for the replacement toilets and following discussion confirmed the preference being the gable roof with weatherboards. The toilet module layouts were discussed including modifications needed, such as for the Little library.

The Team would like to attend again to present a layout which is expected to provide the best function, allows for future expansion if needed, and reinstates the Little Library at the edge of the footpath

Pokeno Main Street (What has been achieved, what's happening in the future)	Community Projects, Paul McPherson	Surveyors have been commissioned to survey Pokeno Main St, Wellington St West, and Pokeno Road intersection to enable concept and detailed design for construction. Site investigations (service locating and pavement and subsoil test pitting) have been commissioned for multiple sites in Pokeno, with Pokeno Main St the priority in order to advance the design.
	Roading, Community Connections Community Growth	The replacement Pokeno Public Toilets have selected (four double units with gable roof and weatherboard cladding) and will include a small extension to re-house the Little Library. The replacements toilets will be completed and the temporary toilet block removed this summer.
Totara Park		The developer consulted with the community and requested feedback at the time the park was being developed. Unfortunately, the community's expectations were not met. Totara Park, however, meets the Council's service levels and is fully developed at this stage. If there are additional items the community want added to the park, this would need to be funded by the community.
Pokeno Sports Park/Munro Park (Still under development)	Community Projects, Paul McPherson	Stormwater catchment management calculations have been commissioned (Te Miro Waters Consultants) to enable the design of the Munro Road and the sportspark entrance, ensuring the pavement levels are in concert with the stormwater management plans. This will determine the flow requirements for the future Munro Single Lane Bridge Replacement and Munro Rd Culverts, as well as define any works needed on Pokeno Road Bridge to enable the catchment stormwater management.
		The contract for the Northern Fill and Carpark is in development and will go out to the market soon for construction this summer (2022/23). This will fill in the redundant stream channel, bring the sport fields ground level up to in the final grassing height. This contract will include the completion of the initial sealed carparking needed to service the following years planned developments.

Plan Change Variations 3 to the Proposed Waikato District Plan - Enabling Housing Supply	Keri-Davis Miller, Resource Management Policy Team Leader	Variation 3 to the Proposed Waikato District Plan - Enabling Housing Supply Clause 5 of Schedule 1 of the Resource Management Act 1991 As required by central Government legislation, we're proposing to make some changes to the Waikato District Plan that will enable more houses to be built in urban areas. Where these changes apply, more intensive housing development will be permitted in some areas within our district (subject to standards being met). These changes are in line with the latest Government direction that has been given via the Resource Management (Enabling Housing Supply and Other Matters) Amendment Act (The Act) and the National Policy Statement - Urban Development (NPS-UD). The proposed changes to our District Plan are required to comply with the legislation. The changes set out by Government are not optional - we must change our plan to implement the new rules. However, we're aiming to do this in a managed way; one that respects our environment and the features of our district that are important to us. The Government has required the Council to use a special 'fast track' process for the housing enablement variation process. This means that the usual plan development process that involves further public consultation on a draft plan before notification of the decisions will not happen. However, you will be able to make a submission once the changes to the plan have been notified. Hearings will be held next year.
