## 5. NZTA/WDC Update

### SH 21

- Funding has been secured for the SH21 underpass as part of Te Awa Cycleway.
- Construction commences in second half of 2020.
- Site is close to halfway between Regal boundary and Wiremu Tamihana (WT) Drive.
- Draft Te Awa plan has cyclists passing between the Tamahere Village public parking and WT Drive with raised platforms designating the 2.5m wide cyclepath across the 3 vehicle entranceways. TCC concerns re: safety. WDC aware and struggling with alternatives.
- At grade crossing on WT Drive 2 car lengths from Devine Rd roundabout.
- WDC considering multiple ways to slow and control traffic speed.
- Large roundabout Devine/Birchwood and smaller at Devine/WT Drive.
- WDC considering closing Devine at SH1 onramp.
- TCC asks that WDC takes a helicopter view of the area acknowledging increased school numbers, housing, changing traffic movements as new roads are opened, Southern Links impact.
- TCC requests members are part of the consultation team.

### SH1

- NZTA have requested an upgraded survey and report on the east/west connectivity.
- TCC asks that market and all school useage be included.
- TCC asks for update on survey results and to give feedback on the draft report.
- TCC Connectivity subcommittee ( Graham, Janis, Charles) will work with Hannah/Ross on both projects. 4<sup>th</sup> Year UW Engineering students may be available to prepare overview.

### Birchwood Lane

- Road is supposed to be opening next week but still isn't sealed
- Concerned with further TM disruption if sealing is done after opening
- There are trenches/holes in the footpath covered by plastic covers and this is dangerous for users
- Only one berm has been tidied up, the other side is still a mess
- Hannah following up on these.

## **6. Cr Bech Report**

- Fosters have a tenant ready to sign for block B.
- Applying for variation to remove the mezzanine therefore reducing the sqm from 876m<sup>2</sup> to 630m<sup>2</sup>
- Building height reduction from 10m to 8m. Fosters ask for a letter of support.
- TCC has concerns re. overall aesthetics of the village complex however commercial reality means this size is easier to tenant.

**Resolution;** *That TCC supports Fosters application for a variation requesting a decrease in the height and footprint of building B. TCC asks that any further changes are discussed with the committee.*

- Raglan Extreme Zero Waste initiative - discussion deferred to Feb. meeting.
- Speed Limit consultation – closes Nov.17<sup>th</sup> . Individuals asked to submit on local changes.
- Historical Acknowledgements – a list of significant people and places to be recognized with signage; includes Wiremu Tamihana, possibly Ngāti Hauā urupā, kumara pits, Narrow Bridge legend, Tamahere School, Cemetery, Pear Tree at Narrows Landing, WW1 and WW2 , Titoki, Alfred Main home.
- Temporary Toilets – monthly costs are high. Cr Bech to look into container type (similar to Hamiltons Riff Raff Square) for use until permanent toilets installed.
- Performance stage – costs and install timing to be reviewed.
- Park seating – 12 seats have been ordered. Cr Bech to get updated information sheet from Nick Johnson to present to possible seat donors.

## **Service Delivery – Tamahere Community Committee Issues Report - Jacob Quinn**

- Budget report for Tamahere Park has been circulated.
- Hall Committee – Jordy Wiggins to continue discussions with members regarding funds in hand and the concept of an events employee.
- Fundraising – Nick Johnson WDC following up on ways to support and publicise local fundraising initiatives. Funds now received for seats and drinking fountains – to be installed November.
- Tamahere Hub carpark and playground signage currently being installed.
- Bus stops at the Hub are crucial. Now some uncertainty as to their position. Jacob to follow up.
- Fitness Trail – answers needed on costs and timeframe. Subcommittee – Bevan, Shelley and Ro.
