5. NZTA Update

- Expressway opening on track for late 2021

6. Cr Bech Report WDC- circulated

Tamahere Reserve/Piazza

- Final 4 seats have either arrived or are on order. This completes the 'vehicle exclusion' row of seats between playground and car park. TCC thanks Cr Bech for his work on securing all sponsorship funding and seating to date.
- Additional seating sponsorship to be community lead from this point. TCC will coordinate with Cr Bech on advertising this via the Tamahere Forum.
- E-Charger at Hub still awaiting outcome of funding application.

7. Service Delivery Report – Jacob Quinn. Circulated, received as read.

- Gully MOU with attached health and safety plan is under review by the legal team.
- The performance stage is currently in the planning stages.
- The fitness trail will be bundled with the district wide Playground Contract for efficiency. The Playground Contract will be advertised for tender in October/November.
- Additional funding is being sought to enable completion of both stages of the trail build.
- TCC requests information on the Hub carparking redevelopment. Current planting obscures drivers view. What is the plan for buses?
