PUBLIC FORUM

Agenda Item 5

Mr Mackie gave an update on the Huntly Christmas Parade and the 3 options he was thinking about moving forward. A meeting has been had with the War Memorial Hall and they have an event on the same day. Discussion about sharing resources. They've have talked about having Traffic Safety People in place.

- 3 Options:
- I) Circuit around the Domain (already approved)
- 2) Down onto Onslow Street back up onto Hakanoa

• 3) Hakanoa Street but that would block access to War Memorial Hall and their event Stage is going to be where the Tennis Courts are. Parking at the school where it will be \$2 for a park.

Discussion around the options and Cr Lynch advised that a lot of small children take part so need to take that into consideration. Ms Bredenbeck gave feedback that the Domain was always the best option as it's out of the way and business friendly.

Ms Wawatai asked if the West side of Huntly had been taken into consideration to show clear equity with both sides of the river. Mr Mackie would like to hold additions to the event to incorporate both sides of the river and everyone can take part. Need to have conversations with the schools to hold ideas and even have workshops.

NZ Police Update Agenda Item 6.1

The report was received [HCB2209/02 refers]. Constable MacFarlane was not present for the meeting. Mr Whyte confirmed that Constable MacFarlane has moved onto Hamilton and a new person will be employed.

- Key Point: Mr Whyte advised that police are being caught up in non-policing events (mental health call-outs etc....).
- Mr Wootton advised that there are only 3x staff on from Mercer down to the South End of the District.
- Issues around the CCTV Cameras some cameras haven't been installed where they were originally supposed to be nor do some appear to be working. Cameras don't appear to be maintained (cobwebs blocking cameras etc....). Police need to indicate when cameras need maintenance/cleaning as council staff don't have access to them.
- Mr Cork asked if there was any discussion around Youth staff have been lost or redistributed for Covid reasons.
