- f. the Chief Executive be delegated authority to execute all relevant documentation to give effect to this resolution.

Zero Harm Update

Agenda Item 6.1

The report was received [WDC2209/10 refers] and the following discussion was held:

- It was noted that since the report was circulated the response rate to the survey outline in the executive summary of the report had increased to 75%.
- It was noted at the Audit & Risk Committee earlier that day a Situational Safety training session for Councillors would be held as part of the induction.
- Engagement conversations an analysis of the data would occur around non categorised safety conversations which would be provided to the new Council.
- It was noted that the Zero Harm report was an exemplar report that should be utilised as a training tool for other report writers.

Approval for Consultation on General Policies Reserve Management Plan Agenda Item 6.2

The report was received [WDC2209/10 refers] and the following discussion was held:

- Amount of consultation seems to be excessive, however it was noted that this is required under legislation.
- Smoking signage is referred to, however we do not refer to drug/alcohol free. It was noted that these matters sit within the Public Places By-law which is due for review.

Resolved: (Crs Smith/Patterson)

That the Waikato District Council:

a. approves public consultation be undertaken on the draft General Policies Reserves Management Plan (attachment 1 of the staff report) for a period of no less than 2 months, as required under Section 41 of the Reserves Act 1977.

<u>Three Waters Reform - Better Off Funding Assessment Panel Recommendations</u> Agenda Item 6.3

The report was received [WDC2209/10 refers] and the following discussion was held:

- It should be noted in the cover letter to DIA that the CCTV information came through submissions, for which Council determined it should be included in the prioritised list even though it had not been prioritised by the panel.
- It was noted that Council were not the decision makers, which is why both the recommended list as well as contingency list were being provided to the DIA.
- Contingency projects if not funded in Tranche I would the contingency list be automatically considered as part of Tranche 2? It was noted no direction had been provided for Tranche 2 as yet and they would possibly have to reapply.
- Concern was raised regarding the issue recently highlighted that this funding was not 100% crown funded, therefore we would be relying on urban ratepayers covering the cost of rural areas indirectly through Entity B. It was noted that some rural areas also paid a targeted rate for water and wastewater services.
- Risk analysis funding recipients may find it hard to adhere to best practice and perhaps struggle to deliver on projects. It was noted that the EPMO would be able to identify this quickly and that is why the contingency list was provided so that if there were any issues projects on the contingency list could be implemented in their place.
- Upon approval by DIA Council receive 10% and are provided with incremental payments on a monthly basis.
- Some Councillors did not support the contingency list due to private benefit.
- Three waters distasteful from the start, find it difficult to support, but there is an air of inevitability about it.

Resolved: (His Worship the Mayor, Mr AM Sanson/Cr Sedgwick)

That the Waikato District Council:

- accepts Option I that the recommended shortlist and contingency projects from the better off funding assessment panel, with the addition of CCTV to the program of works, be put forward for funding from the DIA via the Three Waters Reform – Better Off Package (Tranche One Funding) Funding Agreement;
- b. acknowledges that all of the better off funding applications have been assessed and evaluated by the better off funding panel and the shortlisted submissions provided to Council have ranked highest against the DIA evaluation criteria as well as Waikato District Council's strategic vision;
- c. notes that, under the agreed Terms of Reference with iwi, Council has the right to select and approve any project submitted for better off funding that meets the DIA better off funding criteria;
- d. approves Council entering into the Three Waters Reform Better Off Package (Tranche One Funding) Funding Agreement with the Department of Internal Affairs.
- e. delegates to the Chief Executive, authority to sign the Three Waters Reform Better Off Package (Tranche One Funding) Funding Agreement with the Department of Internal Affairs on behalf of Council;
- f. recommends that the approved better off funding projects are allocated to Council's Project Management Office (PMO) to enable Council to either deliver internally or provide project management oversight to community groups self-delivering for the purpose of ensuring projects are delivered within scope and DIA reporting criteria;
- g. notes that, where approved projects are community delivered, appropriate contracts are signed with those community groups ensuring projects outcomes and deliverables are aligned with Council's obligations under the Funding Agreement with the DIA; and
- h. notes that a lessons learned report will be prepared to reflect the learnings from the novel process developed for tranche one and utilize it for improvements for tranche two.

The report was received [WDC2209/10 refers] and the following discussion was held:

- It was noted that there was an error in the report referring to Mr Smedts as a Commissioner of the DLC, it should be noted that he is a member of the DLC not a Commissioner. It was further clarified that Commissioner could be appointed as a Chairperson for hearings.
- It was recommended that the transition arrangements also included the Deputy Mayorelect – this was incorporated into the resolutions below.

Resolved: (His Worship the Mayor, Mr AM Sanson/Cr Smith)

That the Waikato District Council:

a. except as otherwise recorded in this recommendation, the Council extends the Chief Executive's current delegations (detailed in the Council's Delegations Register) to include all of Council's responsibilities, duties, and powers currently retained by the Council or delegated to the Council's standing Committees (except the District Licensing Committee and Waters Governance Board), subject to the following conditions:

- i. the extended delegations will have effect only for the period from 8 October 2022 until the swearing in of the new Council, which is proposed to be 20 October 2022;
- the extended delegations do not include a delegation of any Council responsibilities, duties or powers which are prohibited by law from delegation - including, without limitation, those set out in clause 32(1) of Schedule 7 to the Local Government Act;
- iii. the Chief Executive may only exercise the extended delegations for those matters that cannot reasonably wait until the first meeting of the new Council;
- iv. where reasonably practicable, the Chief Executive must, before exercising an extended delegation responsibility, duty or power, first consult with the Mayor-elect, Deputy Mayor-elect and Councillor Eyre (being the only current Councillor who will be re-elected unopposed in the 2022 local authority elections); and
- v. the Chief Executive must report all matters relating to the exercise of an extended delegation to the incoming Council at the first business meeting following the local authority elections;
- b. in accordance with section 34A of the Resource Management Act 1991, the Council delegates to the General Manager Customer Support the responsibility, duty and power to appoint independent commissioner(s) for the purpose of a hearing of an application under the Resource Management Act, subject to the following conditions:
 - i. this delegation will have effect only for the period from the date after the day that the local authority election results are declared by public notice (scheduled for 20 October 2022) until such time as this function is formally delegated by the newly-elected Council; and
 - ii. the General Manager Customer Support must report any appointments made under this delegation to the incoming Council at its first formal meeting after the inaugural meeting of Council following the local authority elections; and
- c. in accordance with clause 30(7), Schedule 7 of the Local Government Act 2002, the Council resolves that the following committees, subcommittees and subordinate decision-making bodies continue (and are not deemed to be discharged) on the coming into office of the members of the Council elected at the 2022 local authority elections:
