Application for Trading in Public Places Licence

Waikato District Council Public Bylaw 2023

Use this form to apply for a permit to trade in a public place.

Check you qualify to apply first

- You need a permit to trade in a public place for private gain within the district. This includes roadsides, laybys, parks and reserves. When choosing your trading locations, please think about road safety as well as business potential.
- If you are trading at an event or on private property, you do not need a permit to operate.
- Permits will not be issued for age-restricted goods or services such as tobacco, alcohol, or firearms.
- This application is subject to the Public Places 2023 bylaw and any other applicable **Council bylaws** regarding registration and licensing requirements.

What to include

- Application completed and signed.
- Location of proposed places of trade. Proposed times of trade.
- Copy of Registration Certificate issued under the Food Act (if trading in food or beverages).
- Make and registration number of the trading vehicle(s).
- List of goods/services to be traded.
- Details of any signage.
- Evidence of good character.

How to submit your application

Conditions of licence

The following standard conditions will apply to all licences issued under the Public Places Bylaw 2023.

- Trading is prohibited within 50 metres of an intersection or curve of a road, vehicle crossing, traffic signor traffic signal that would reduce visibility.
- Trading shall not cause or potentially pose, a traffic hazard or distract unduly or be likely to distract unduly the attention of road users.
- Trading is not permitted from any fixed position on any reserve vested in the control of the Waikato District Council unless approval is gained by means of a concession licence.
- Trading shall not occur within 150 metres of any business or operation selling like goods (including other traders in public places).
- The vehicle must be removed from the public place if it is not trading.
- Operators must sell and display goods directly from the mobile shop.
- Mobile shops are only permitted to trade from sunrise to sunset, unless permission from Council is granted to trade outside this period.
- Operators must comply with all relevant statutes, regulations, bylaws and policies and the Waikato District district plan.
- Operators must remove any litter from the surrounding area of the mobile shop which has been generated by the activities of its operation that day.
- Mobile shops must not cause damage to the roadway, footpath or road berm.
- Operators must display their trading licence in the mobile shop so that it is visible at all times.
- The trader is required to move on following a request from a Council officer.
