Leak remission for a undetected water leak against metered water use charges for domestic customers

## Important Information

We offer a one-off leak remission for undetected leaks that are repaired within 20 working days of the leak being detected, and an application for leak remission received within six months of the leak being detected. This is to encourage water efficiency and the timely repair of undetected leaks.

This form must be completed by the property owner. In order for Council to consider leak remission the undetected water leak must be verified, and the loss must be greater than 50% of normal consumption bill.

Remission will be 50% of the excess charge (measured by consumption caused by loss versus consumption during normal usage measured over the past two bills). Council approves leak remission at its discretion. If we accept your application, you will receive a remission on your next six-monthly bill.
