Annual application fee and a charge per cubic metre used will apply and are listed in the Councils schedule of fees and charges. These can be viewed on Council website.

- Currently registered with the Taumata Arowai as a water carrier
- The Carrier to take water from the Filling Station and key to be provided by Council. The usage will be monitored for billing purposes. The key or electronic access key remains Waikato District Council property
- Comply with the following legal and regulatory requirements:
 - Taumata Arowai
 - Waters Services Bill 2021
 - o Health Act 1956
 - Waikato District Council Water Supply Bylaw 2014 (amended 2021)
- Ensure tanks are suitable for conveying drinking-water
- Not use tanks for purposes other than conveying drinking-water
- Take reasonable care when accessing or using the Filling Station to avoid:
 - Damage to the Filling Station (any damage must be reported immediately to Waikato District Council)
 - Contamination of the water (any contamination must be reported immediately to Waikato District Council)
 - Damage to other vehicles or property belonging to another person using the Filling Station
 - o Damage to vehicles or other property belonging to any member of the public.
- Behave in a professional and courteous manner to Waikato District Council representatives, other users of the Filling Station and any member of the public
- Notify Waikato District Council of other users of the Filling Station who might be breaching the terms and conditions of this contract. Encourage all Carriers to gain authorised access to the Filling Station
- Take all practicable steps to ensure noise levels from the Carrier's vehicles are kept to a minimum while using the Filling Station
- Take reasonable care of the access key and notify Waikato District Council immediately if the access key is lost or stolen

Your access key may be revoked at any time if it is found that the holder does not abide by Council's regulations and bylaws controlling water supplies.
