- Tuakau Proteins Ltd (TPL), appeals against part of a decision of Waikato District Council on the Proposed Waikato District Plan (PWDP).
- 2 TPL made a submission on the PWDP.
- 3 TPL is not a trade competitor for the purposes of section 308D of the Act.
- 4 TPL received notice of the decision on 17 January 2022.
- 5 The decision was made by Waikato District Council.
- 6 The part of the decision that TPL is appealing against is:
 - (a) The decision not to retain the industrial zoning of the TPL site including 22, 24 and 26 Lapwood Road, Tuakau as notified.
- 7 The reasons for the appeal are as follows:
 - (a) TPL has used its site for an industrial activity for many decades;
 - (b) TPL's site is suitably serviced for industrial usage;
 - (c) The existing industrial activities nearby on River Road have been provided with industrial zoning. Like TPL their sites are adjacent to rural zoned land, but they are also considerably closer to residential zoned land;
 - (d) Similarly, a large area around Whangarata Road, Bollard Road and Saleyard Road has been provided with industrial zoning despite being considerably closer to, and in some cases adjacent to, residential zoned land;
 - (e) The decision does not have sufficient regard to the efficient use of natural and physical resources at TPL's site; and
 - (f) The decision does not accord with the purpose of the Resource Management Act 1991.
- 8 TPL seeks the following relief:
 - (a) Reinstate the industrial zoning of the TPL site including 22, 24 and 26 Lapwood Road, Tuakau as notified.

- 9 TPL attaches the following documents to this notice:
 - (a) a copy of its submission;
 - (b) a copy of its further submissions;
 - (c) a copy of the relevant part of the decision;
 - (d) a list of names and addresses of persons to be served with a copy of this notice.

 and the appellant; and
- within 20 working days after the period for lodging a notice of appeal ends, serve copies of your notice on all other parties.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in section 274(1) and Part 11A of the Act.

You may apply to the Environment Court under section 281 of the Act for a waiver of the above timing or service requirements (see form 38).
