CDL LAND NZ LIMITED ("CDL") gives notice under section 274 of the Resource Management Act 1991 ("**RMA**") that it wishes to be a party to the appeal ("**Appeal**") by The Surveying Company against the decision of the Respondent ("**Decision**") on the proposed Waikato District Plan ("**PDP**").

- 1. CDL made submissions about the subject matter of the proceedings, being the provisions of the PDP relating to rural subdivision.
- CDL is not a trade competitor for the purposes of section 308C or 308CA of the RMA.
- CDL is interested in the aspects of the appeal relief that relate to rural subdivision.
- 4. CDL has filed a separate appeal on the PDP (ENV-2022-AKL-000050) which also challenges SUB-R40 and SUB-R41 and SUB-46 as included in the Decision.
- 5. CDL supports the relief sought in respect of SUB-R40, SUB-R41 and SUB-46 insofar as it relates to the Urban Expansion Area. This is on the basis that it is unjustified and inappropriate to constrain the subdivision of land due to the presence of high class soils, when that land has already been identified as appropriate for future urbanisation.
