The Issue:

Firstly I would like to note that the Waikato District Council Website link to the Original Submissions to the Proposed Waikato District Plan has been 'down' so far today so I have been unable to view the actual original submissions and or confirm who was the original submitter with the exception of the one detailed below. I am aware however that there has been some issues with the summary of submissions incorrectly identifying submitters versus contact person, an example being submission 341, made by Tainui Group Holdings Ltd (TGHL), but which the summary of submissions has registered under the name of Brian Croad as submitter.

With regard to Paragraphs 10 & 11 of the Commissioners first directions, and using the above submission as an example, I note that the Chair of the Commissioners (Dr Phil Mitchell) has reported on his relationship with TGHL - but that Commissioner Linda Te Aho has not, but instead referenced her relationship to the organisation that 'owns' TGHL being Te Whakakitenga o Waikato Inc (who I have not been able to find a submission from within the summarised submissions) as well as Waikato Tainui (who have also made several submissions by different agents). I am not suggesting anything untoward, just perhaps a lack of consistency regarding reporting and/or knowledge/transparency of the original submitter details which can lead to confusion with service and or the Commissioners relationships with submitters.

Actions:

- Ensure that submitters have access to the list of original submissions via the Council Website and that the summarised submissions accurately reflects original submitter details and contact person/s
- Ensure that the table of 'Relationships with Submitter Parties and Actions Proposed' accurately reflects original Submitter name and the relationship that the Commissioners have with the Submitter, and add another column if there is a further, or other relationship with the Submitters agent or contact person/s.

Re: the reason for our late submission

Our immediate neighbors along our back boundary (the Matangi Factory) advised us in writing after the submission closing date of their intentions to change the zoning and the land use to the back part of their property which is currently zoned Rural to Industrial . Upon calling the council and after numerous phone conversations with the council between my-self (Andrew de Langen) and Susan Chibnall , also Sandra Kelly regarding my concerns about these changes and how they would adversely affect our outlook and property use etc , we were advised by Sandra we could put forward our own late submission to the council regarding potential to change our property zoning .
