REQUEST FOR RAGLAN TOPIC TO BE HEARD IN RAGLAN

- Rangitahi Limited (Rangitahi) has made submissions to the Proposed Waikato
 District Plan in respect of the Rezoning topic. We understand that the hearings
 will be organised by geographic area. We consider there will be immense value
 in the hearing in respect of the Raglan submissions being heard locally in the
 community.
- 2. The evidence filed by Rangitahi seeks a hierarchy of Council led, area-wide spatial planning followed by site specific landowner led structure planning / masterplanning to achieve live zones and resource consent. We have prepared evidence ¹ in support of this nested approach to place-based planning for growth. This approach rather than generic growth planning is important to the future character of Raglan and the retention of its special attributes.
- 3. Holding the hearings locally will support the participation of the community, and it will also enable the Commissioners the opportunity to engage with the important landscape and urban design issues raised through the submissions. We appreciate the Commissioners will have a level of awareness of the Raglan settlement and its wider landscape context. However, we consider that the landscape of Raglan is subtle and complex and the decision making process will benefit from the Commissioners having the opportunity to directly observe and refresh their memory in respect of the landscape of Raglan and the settlement's particular urban design qualities.
- 4. The need for a quality spatial planning process for Raglan has long been recognised. Council previously initiated and then withdrew from such a process. In the subsequent years, development has continued in Raglan, some with positive and others with less positive results. The proposed plan provides an opportunity to reconsider how growth can be appropriately enabled.
