TABLED STATEMENT OF EVIDENCE OF CAROLYN ANNE MCALLEY FOR AND ON BEHALF OF HERITAGE NEW ZEALAND POUHERE TAONGA

1. INTRODUCTION

- 1.1 My name is Carolyn Anne McAlley. I hold the qualification of a Bachelor of Planning degree from Auckland University. I have over 20 years planning experience in local and regional government, in consenting, implementation and policy based roles.
- 1.2 I have been employed by Heritage New Zealand Pouhere Taonga (HNZPT) since August 2012, where part of my role includes providing statutory planning advice in relation to proposals under the Resource Management Act, including District Plans, Plan Changes and Resource Consent proposals.
- 1.3 Although this evidence is not prepared for an Environment Court hearing I have read the Environment Court Code of Conduct for Expert Witnesses Practice Note 2014 and have complied with it when preparing this evidence. In preparing this statement I have obtained specialised technical advice from HNZPT Senior Conservation Architect Robin Byron and HNZPT Senior Listing Advisor Martin Jones and this has been directly quoted as referenced throughout the document.
- 1.4 Otherwise I confirm that the topics and opinions addressed in this statement are within my area of expertise. I have not omitted to consider materials or facts known to me that might alter or detract from the opinions that I have expressed.

2. SCOPE OF EVIDENCE

- 2.1 HNZPT is New Zealand's lead heritage agency and operates under the Heritage New Zealand Pouhere Taonga Act 2014 (HNZPTA). Included as the purpose of the HNZPTA is: "To promote the identification, protection, preservation and conservation of the historical and cultural heritage of New Zealand." HNZPT meets this purpose in a number of ways, including advocacy and active involvement in Resource Management Act 1991 (RMA) processes for heritage.
- 2.2 With regard to the submissions of Harry Mowbray Group Limited (the submitter) (404.1 /404.2 /404.3/404.4 /404.5) HNZPT made further submission/s in opposition. These points and a response to the submitter's evidence are discussed in section 4.

3. LEGISLATIVE FRAMEWORK

3.1 The purpose of the RMA is to "promote the sustainable management of natural and physical resources". Section 5 of the Act states:

"In this Act, sustainable management means managing the use, development and protection of natural and physical resources in a way, or at a rate which enables people and communities to provide for their social, economic, and cultural well being and for their health and safety.

- 3.2 Section 6 of the RMA requires "all persons exercising functions and powers under it, in relation to managing the use, development and protection of natural and physical resources to recognise and provide for:
 - ...6(e) the relationship of Māori and their culture and traditions with their ancestral lands, water, sites, wahi tapu and other taonga, and
 - ... 6(f) the protection of historic heritage from inappropriate subdivision use and development" (historic heritage includes sites of significance to Māori).
- 3.3 In terms of Part 2 RMA matters, historic heritage is part of the environment. Therefore adverse effects on historic heritage must be avoided, remedied or mitigated (as required by section 5).
- 3.4 The RMA defines historic heritage as:
 - (a) means those natural and physical resources that contribute to an understanding and appreciation of New Zealand's history and cultures, deriving from any of the following qualities:
 - (i) archaeological:
 - (ii) architectural:
 - (iii) cultural:
 - (iv) historic:
 - (v) scientific:
 - (vi) technological; and
 - (b) includes—
 - (i) historic sites, structures, places, and areas; and

- (ii) archaeological sites; and
- (iii) sites of significance to Māori, including wāhi tapu; and
- (iv) surroundings associated with the natural and physical resources.

4. HNZPT RESPONSE TO EVIDENCE FOR HARRY MOWBRAY GROUP LIMITED SUBMISSION POINTS

4.1 Background

- (i) The submitter made a suite of submission points (404.1 /404.2 /404.3/404.4 /404.5) seeking various rule changes to 425B Tauwhare Road, Matangi and surrounds to accommodate the addition of historic railway cottages and other relocatable buildings, the development of a Business Town Centre/ Zoning, the amendment of height controls, and allowing for the development of an historic town centre zone.
- (ii) As the submission/s did not contain any objectives, policies or rules HNZPT was concerned at the unintended consequences that these amendments may have on the existing HNZPT listed NZ Co-operative Dairy Company Limited Factory (Former) List No. 4935 located at 452 Matangi Road (the Matangi Dairy Factory) and indicated through the further submission process they would need to see the suite of rules to confirm their stance. HNZPT sought that the changes were declined.
- (iii) In the interim the submitter (as discussed in his evidence at page 8, para 6.4) has nominated another part of the site for listing with HNZPT as a historic place. This nomination was accepted in June 2020. All nominations are evaluated annually for consideration to include in HNZPT's work programme for full research and assessment in the following financial year. The Highlander Condensed Milk Factory building, the subject of the recent nomination, sits further into the subject site than the existing listed historic place, the Matangi Dairy Factory.
- (iv) "Both the currently listed and nominated places are closely interrelated parts of a wider historical complex at the site that collectively forms an integral aspect of their physical and historical context and setting. Taking into account the greater amount of information that is currently to hand, HNZPT is of a view that this wider context can itself be considered to have significant heritage value. Incorporating elements from the

1890s onwards and connected to associated rail and other transport networks for distribution, the complex demonstrates several notable phases in the historical and physical development of the dairying industry in New Zealand - itself a fundamental aspect of the country's economic prosperity between the 1890s and late 20th century, in which the Waikato played an especially important role. The complex particularly reflects the increasing variety and scale of production that occurred during this period, and technological advances such as condensation, evaporation and spray drying - as well as canning, power production and apparently innovative tanker distribution - that enabled such shifts to take place. The complex also reflects the New Zealand dairy industry's important connections with the globalised British imperial trading network throughout much of this period, facilitated by its production of a variety of dairy products for overseas markets, and connections via New Zealand's rail network to export centres such as Auckland. As stated in the history provided by submitter (p.31)¹, the complex as a whole 'has played an extraordinary role in New Zealand's dairying history'."²

(v) With regard to the proposed Waikato District plan's generic suite of historic heritage (HH) rules HNZPT has participated in those hearings as a submitter and further submitter. Of particular interest in relation to this rezoning hearing was the "site development rule". At the time of the HH hearing this rule allowed a new building on the site of a scheduled heritage building as permitted if it was further than 10m from the scheduled item and not located between the building and the street frontage. (The submitter has proposed a similar rule, through the planning evidence of Mr. Fraser McNutt, that any new building on the site is to be permitted if it was further than 10m from the scheduled item and not located between the outer edge of the building forward 30m). However in the Closing Statement for the HH hearing, the reporting planner has advised that a revised approach was to be taken with regard development on the site of a heritage item, with the setting to be regarded as either the relevant Lot and DP, or for other sites, as specified i.e. the Matangi Dairy Factory, a setting diagram will become part of the schedule. At the time of writing the setting diagrams are still to be made available for consideration.

- (vi) HNZPT is generally supportive of the revised approach to the HH site development rule now being taken by Waikato District Council as this has the potential to offer a more nuanced approach to the consideration of new development in the setting of a scheduled heritage item. With regard to the Matangi Dairy Factory (Former) listing entry, "the current List boundary, Appendix 1, is simply the extent of the listed historic place (created in the days when historic place listings were generally confined to individual buildings) rather than its setting and doesn't assume that heritage values stop at its boundary. Indeed one of the criteria for current listing (Criteria (66(3) (k))³ is the extent to which a place forms part of a wider historical and cultural area. The implications of this, in general, are that if that wider historical and cultural area is particularly adversely affected, then so is the associated Listing."⁴
- 4.2 HNZPT response to the proposed Mixed use zone
- (vii) At the time of writing HNZPT has taken part in several meetings on a without prejudice basis with the submitter's planner, regarding the proposed suite of objectives, policies and rules for the new mixed use zone.
- (viii) With regard the objective, policy and rule framework proposed by the submitter (Appendix 2 and 3 of their evidence), HNZPT has particular interest in and concerns about the enablement of a high level of permitted activity on site, which includes new buildings including relocated buildings, which we understand many of which the submitter has already obtained or is in the process of obtaining. HNZPT has expressed an interest at these meetings that the proposed relocatable buildings being located as far away as possible from the buildings and intervening spaces on site that form authentic surviving parts of the Matangi Dairy Factory complex; ⁵ and expressed an interest in a layout similar to that contained as part of Mr. Mowbray's evidence, and explained at para 2.4 of the Mowbray evidence as follows "The rear of the factory will contain small cottages that will be used for visitors accommodation". HNZPT has sought that a revised diagram, as contained at Appendix 2 to this evidence, become part mixed use zoning framework with regard the relocatable buildings and that should

the relocatable buildings be located within the identified areas that this would be a permitted activity from a historic heritage perspective. "This proposed layout would serve to create a situation that maintains a clear spatial and visual separation between the genuine complex buildings and relocated structures with no historical connection to the site". The submitter's planner has advised that this approach would be too restrictive and has expressed a preference for their site development control to be retained as proposed in his planning evidence. Further to the proposal for the site diagram HNZPT also realized that consideration must be given to the management of new buildings other than the relocatable buildings and considered that these should be managed through a restricted discretionary activity site development control for any other new building in the "setting" of the Matangi Dairy factory, with similar assessment criteria to that in R70, page 18 of 20, Appendix 3 of Mr. Fraser Mcnutt's Evidence.

- (ix) Given the pending work by the Waikato District Council on settings as part of the HH site development control, HNZPT reserves any further comment on the matter of the management of new buildings on the site, until such time as the settings information is made available for their consideration and review.
- (x) With regard to other concerns relating to the submitters evidence, HNZPT seeks that the historic heritage rules are amended as required to align with the generic suite of historic heritage rules, including references to both A and B buildings as HNZPT seeks to anticipate the inclusion of other heritage buildings on the site.
- (xi) With regard to the objectives and policies for the zone, HNZPT seeks that the following amendments (Underline <u>addition</u> and deletion <u>strikethrough</u>) to the submitters proposed policies "
 - 1. Policies-Range of activities

"(f) Maintain the heritage values of the buildings and surrounds through the appropriate repurposing and reusing of existing buildings. where possible."

- 5. Policies-High quality urban form
- c. Development <u>is sympathetic and</u> restrained, and does not detract from the addresses, responds and is sympathetic to the heritage values and overall historical authenticity

and integrity of the site, <u>in particular the buildings</u>, <u>structures and spaces associated</u> with the history of dairy manufacture in New Zealand.

(xii) In conclusion HNZPT looks forward to continuing to work with the Waikato District

Council and the submitter to develop an appropriate rule framework for this important heritage site.

5. CONCLUSIONS

- 5.1 The RMA requires that the protection of historic heritage as a Matter of National Importance. As subdivision, use and development have the potential to significantly detract from Māori heritage and historic heritage, it is important that the Plan limit the potential for adverse effects to occur.
- 5.2 I seek that the amendments as sought by HNZPT in this statement be retained at the time of the decision making.
- 5.3 I am able to answer any questions that you have relating to this statement.



Summary:

The New Zealand Co-operative Dairy Company Limited Factory (Former) located in Matangi, the heart of the Waikato dairy country, was opened in 1919. Designed by the well-known Hamilton architect Frederick Charles Daniell (1879-1953), the building is architecturally significant for its use of new materials and techniques of construction in reinforced concrete. Grand in its scale and attention to detail, the factory stood as a symbol of the growth and investment in the dairy industry and the production of new products like milk powder that would become an important commodity for New Zealand's export market in the wake of World War One.

The factory was built by the New Zealand Co-operative Dairy Company Limited (NZCDC) and leased to Joseph Nathan and Company for the production of 'Glaxo' milk powder products.¹ NZCDC had been formed through the amalgamation of the New Zealand Dairy Association, the Waikato Co-operative Dairy Company and the Waihou Valley Co-operative Dairy Company.² At the head of the NZCDC was Sir William Goodfellow (1880-1974).³ Goodfellow was managing director of the NZCDC from 1919 to 1932 and under his management the company continued subsume most of the smaller cooperatives of the region. By 1920 the company was the largest cooperative in New Zealand.⁴ NZCDC would go on to merge with 'Kiwi' which merged with other companies to form Fonterra Co-operative Group in 2001 - the world's largest dairy exporter.

The Matangi factory was regarded as a model factory and showplace to overseas visitors, and it had extensive gardens. Architecturally designed and purpose-built for milk powder production, the plan also included a number of workers' houses and single-men's accommodation located on Matangi Road. Construction of the factory began in 1917 and was overseen by the builder R. Sanders. The factory was officially opened by the Prime Minister, William Massey, on 12 November 1919. It was reported at the time that the factory was 'to handle the largest quantity of milk under one roof in the world.' Its construction represented a major investment; the factory and employee accommodation cost £40,000 and the machinery £45,000.

Architect Frederick Charles Daniell had a practice in Hamilton for 27 years and designed many buildings in concrete. He experimented with different methods, including the use of 'Camerated Concrete' and the design of reinforced concrete. 8 The design of the Matangi factory

includes reinforced concrete 'column and beam construction with concrete panel walls and timber trussed roofs…'. Daniell was engaged by the NZCDC to design a number of dairy factories and conversions to milk powder production. The Matangi dairy factory is by far the largest and best example of his work. ¹⁰

The contract between Glaxo and the NZCDC ceased in 1936 and the factory reverted back to the NZCDC.¹¹ A number of milk products continued to be produced in the factory and were sold under the brand *Anchor*.¹² Mowbray and Mowbray note that 'Matangi was an extraordinarily versatile site' with its ability to produce a range of products from canned evaporated milk, technical rennet caseinates (soluble salts of milk proteins), and whey powder to baby milk powder.¹³ This versatility also led Matangi to become one of the key research and development laboratories for the NZCDC.¹⁴ The New Zealand Co-operative Dairy Company Limited Factory (Former) ceased operations on 31 May 1987. Since 2004 the site has been home to a number of small businesses.¹⁵










New Zealand Co-operative Dairy Company Limited Factory, NZHPT, 6 June 1985 [image appended to NZHPT Buildings Record Form].
