MINUTE FROM HEARING COMMISSIONERS

22 July 2019

Introduction

- 1. This minute deals with:
 - "Late submissions";
 - Other matters raised in correspondence received by the Panel; and
 - Updates to the Commissioners' Register of Interests document.

Late Submissions

- 2. In our Second Directions of 26 June 2019 invite the following submitters to advise us, in writing, of the reasons why their respective submissions were filed so late, and why they consider that it should be accepted:
 - **a.** Amy & Andrew de Langen;
 - **b.** Andrew Wilson;
 - c. Hynds Pipes Limited; and
 - d. Turangawaewae Trust Board.
- 3. We have received written responses from all these parties, and having considered them and the statutory criteria, we have determined as follows:
 - The late submission of Hynds Pipes Limited is accepted;
 - Although we are unsure of the reasons for the technical difficulties encountered by **Mr Wilson and Turangawaewae Trust Board** in lodging their submissions, we accept that their submissions should be **accepted**.

• Mr and Mrs de Langen's submission is a response to a neighbour's rezoning. As such, it will be accepted as being a "further submission" on that neighbour's submission.

Memorandum from A, C and B Kosoof (Rimu Buildings Ltd)

- 4. We received a memorandum from the Kosoof family (Rimu Buildings Limited) regarding their property at 40 Main Street, Huntly. They sought that the submission of Heritage New Zealand (which sought that a Heritage Protection Order be applied to the property) be rejected on the basis that:
 - It was not an oversight that there was no Heritage Protection Order proposed for this property in the notified version of the Proposed District Plan; and
 - There was a prior agreement between themselves and the Council that no such Order would be sought by the Council
- 5. We have determined that we should not make a preliminary decision on this matter and that the appropriate course of action is for the issue to be addressed at hearing. In that regard, the Kosoof memorandum referred to above will be treated as if it were a "further submission" on the Heritage New Zealand submission.
