- 1. These Directions address our decisions on whether or not to accept a number of late further submissions on the Proposed Waikato District Plan ("**proposed plan**").
- 2. The period for lodging further submissions on the proposed plan ended at 9am on 16 July 2019.
- 3. The Council's report on late submissions, dated 14 June 2019, identified 15 further submissions that were received after this date, as summarised in Table 1 below.

- 4. Having evaluated each late submission against the requirements of sections 37 and 37A of the Resource Management Act 2019 ("RMA"), Council staff:
 - a. Observed that 13 of the 15 late further submissions were received on the day that the further submission period ended, but after the 9 am deadline included in the public notice, and the remaining 2 late further submissions were received 1 and 2 days late, respectively;
 - b. Considered that there was no prejudice to any person directly affected by the late further submissions being accepted; and
 - c. Recommended that each of the late submissions be allowed.
- 5. We are satisfied that late further submissions should be accepted, for the reasons outlined by Council staff.
- 6. Submitters and further submitters should note that the Chairperson has included Riverdale Group Ltd and Tuakau Proteins Ltd on the Commissioners' Register of Interests (see the Council's website for the latest version of the Register) and is taking no part in the consideration of their submissions or further submissions by the proposed plan. Thus, although the Chairperson has signed these Directions on the hearing panel's behalf, the decision to allow these two late further submissions has been made by the Deputy Chairperson, Mr Cooney.
