1 INTRODUCTION

- 1.1 My name is Brett Titchmarsh. I live at 11 Coles Road in Tuakau. I lodged a submission on Variation 3 to the proposed Waikato District Plan (PDP) dated 25/10/2022 asking that all the areas identified to accommodate residential growth in the Tuakau Structure Plan (Structure Plan) and Waikato 2070 be rezoned residential, with the medium density residential standards adopted for all residential areas within Tuakau unless a valid qualifying matter applies.
- 1.2 This further submission should be read together with my original submission.

2 FURTHER SUBMISSION

- 2.1 I support the submission by Kāinga Ora to apply medium density residential standards to Tuakau and remove the "urban fringe" qualifying matter. As set out in my submission, growth and urbanisation in Tuakau has been long envisaged and should not be limited.
- 2.2 The community and Council, supported by technical analysis, have identified these areas as appropriate for residential growth, as have recent changes to the Resource Management Act in favour of intensification. Kāinga Ora is correct that the "urban fringe" qualifying matter is not an appropriate reason to limit development in Tuakau, and seeks zoning in line with the Structure Plan. I agree with the approach proposed by Kāinga Ora.
