INTRODUCTION

- 1. This memorandum relates to:
 - (a) Timetabling for stormwater information and conferencing, in response to the memoranda from Synlait and Ms Noakes; and
 - (b) Proposed conferencing date for wastewater and water matters.

STORMWATER

2. In our memorandum of 3 May 2023, we advised that investigations relating to stormwater for the four towns included in Variation 3 were taking longer than anticipated. We stated that:

The stormwater work will not be available to circulate to submitters prior to the Council's section 42A report. We are therefore proposing to include conferencing on stormwater matters after the exchange of evidence in chief from all parties but prior to rebuttal evidence. Conferencing after the exchange of evidence is not an uncommon practice and can result in the conferencing being more focused and efficient.

- 3. It was the intent of the Council that the expert report on stormwater would be attached to the Council's Section 42A report on 13 June 2023, and that one of the authors of the report would provide a statement of evidence on 20 June. This would have allowed the submitters three weeks to consider the information before their evidence was due to be circulated on 4 July.
- 4. We received the Synlait memorandum from the Hearings Administrator on Wednesday 10 May, without any advanced notice. With respect, the Synlait memorandum incorrectly interpreted that the stormwater information would not be available to submitters until 20 June when the Council's evidence is due. The memorandum from Ms Noakes agrees

with the Synlait memorandum and notes that two weeks between

receiving information and producing evidence is not sufficient.

5. As a result of the concerns raised by the submitters, we have spoken to

Council's stormwater experts, and the Council will now be in a position to

circulate the stormwater information to the submitters on 6 June 2023.

6. While the Council will be busy preparing the Section 42A report and

evidence at this time, it may be possible to have informal meetings with

submitters after 6 June to discuss any technical issues that might arise

from the stormwater information, prior to the more formal conferencing

occurring after the exchange of evidence. The Council has already asked

the submitters to identify whether they have technical stormwater

experts, to enable earlier engagement.

7. The Council does not consider any other changes to the timetable are

necessary. Submitters will have the stormwater information for a month

before preparing their evidence and for nearly two months before the

start of the hearing.

WASTEWATER AND WATER CONFERENCING

8. The conferencing on wastewater and water matters was timetabled for

the week of 22 May 2023. The Council has engaged Marlene Oliver to

facilitate the conferencing, however she is unavailable in the week of

22 May. Conferencing on wastewater and water is now scheduled for

30 May 2023.
