

Additional summary of decisions requested for the Proposed Waikato District Plan Stage 1

We have now fixed the various issues that we had with our initial notification of the summary of decisions requested. These issues included:

- 1. Five submissions were omitted from the summary of decisions requested;*
- 2. There was a very small number of errors in the summary of decisions requested that needed to be corrected; and*
- 3. Some of the original submission documents were unavailable due to technical issues (although the decisions requested were summarised).*

*Consequently, the timeframe for receiving all further submissions on the Proposed District Plan – Stage 1 is extended to 9am on **16 July 2019**.*

To make it easier for submitters, we have listed each of the submissions affected and the nature of the corrections made to each summary in the tables below. We have listed the submissions affected both numerically by submitter number and alphabetically by submitter name.

The submissions affected have the following colour coding:
