The Waikato District Council Local Alcohol Policy 2017 (LAP) has the effect of:

- Reflecting the views of local communities as to the appropriate location, number, hours and conditions that should be applied to licensed premises within their communities;
- Balancing the views of local communities regarding the sale, supply and consumption of alcohol, while addressing the statutory requirements of the Sale and Supply of Alcohol Act 2012, including the object of the Act, to minimise the harm caused by excessive or inappropriate consumption of alcohol;
- Providing certainty and clarity for applicants and the public as to whether a proposed licence application will meet the criteria of the LAP; and

- Providing effective guidance to the District Licensing Committee and Alcohol Regulatory and Licensing Authority when making decisions.

- 11. Please comment on the manner in which Covid-19 has impacted on DLC operations.

During the COVID-19 pandemic some hearings were delayed until it was safe for them to be held. Hearings now take place with appropriate personal protective equipment available to all participants and with restrictions such as social distancing in place in accordance with the applicable COVID alert level. During this period there was a decrease in the number of special licence applications received, reflecting the restrictions on gatherings imposed by Central Government.

The timeframe for completing the process was also extended with the extended Police and Ministry of Health timeframes for reporting to the DLC.

The Committee had noticed a reduction on overseas nationals on visas renewing their manager's certificates, although these numbers are now starting to increase.


- 12. Please comment on the ways in which you believe the Sale and Supply of Alcohol Act 2012 is achieving its object. Note: the object of the Sale and Supply of Alcohol Act 2012 is that:
  - a) the sale, supply, and consumption of alcohol should be undertaken safely and responsibly; and
  - b) the harm caused by the excessive or inappropriate consumption of alcohol should be minimised.
  - c) to what extent, if any, do you consider that achievement of the object of the Act may have been affected by the Covid-19 pandemic?

The Act enabled Council to develop a local alcohol policy (LAP) to guide expectations for the development of alcohol licensing. This statutory recognition allows our DLC in consultation with their communities and stakeholders, to have greater influence over the local licensed environment.

- The Act strengthens the rules around the types of stores eligible to sell alcohol.
- The Act provides clarity for objections to alcohol licence applications.
- The Act allows reporting agencies to consider new criteria for renewal of licences; such as regard for the objective of the Act; design and layout of premises and impact on amenity and good order.
- There are tighter controls on sale and promotion of alcohol.
- There are better enforcement powers and penalties.

# Liaison

The Council continues to work closely with the Police and the Medical Officer of Health (MoH) representative from the Waikato District Health Board, holding liaison group meetings during the year.
