

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by Glam Camping at Castaways Limited for the renewal and variation of an on-licence pursuant to s.120 and s. 127 of the Act in respect of premises situated at 685 A Karioitahi Road WAIUKU known as "Glam Camping at Castaways".

DECISION

[1] I have before me an application by Glam Camping at Castaways Limited for the variation and renewal of an on licence in respect of premises situated at 685 A Karioitahi Road WAIUKU known as "Glam Camping at Castaways".

[2] The general nature of the business is that of a function centre.

[3] The variation sought relates to the applicant wishing to increase the licensed area as defined within the site plan submitted with the application date stamped as received by the Waikato District Licensing Committee on 3 April 2023.

[3] Reports on the application were received from an Inspector, the Medical Officer of Health and the Police and offer no opposition.

[4] The application was duly advertised and did not attract any public objection.

[5] I am satisfied as to the matters which I must have regard as set out in s.105 of the Act, and I am satisfied that the application meets the purpose and object of the Act. Accordingly, I grant the applicant the variation and the renewal of the underlying on licence.

[6] The following conditions apply:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold under the licence only on the following days and during the following hours:

On such days and during such hours as the premises or part of the premises is hosting a private reception, function, or other social gathering but not other than on the following days and hours:

Monday to Sunday

12.00midday to 1.00am the following day

- (c) Food must be available for consumption on the premises when the premises are open for the sale of alcohol in accordance with the menu submitted with the application for the licence, or variations of that menu of a similar range and standard.
- (d) The licensee must have available for consumption on the premises, always when alcohol may be sold under the licence, a reasonable range of non-alcoholic and low-alcohol beverages. Drinking water must be freely available at the bar service area or on all occupied tables.
- (e) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
 - (i) Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (f) The whole of the premises is designated as a supervised area.
- (g) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
 - (i) All staff will be trained in their responsibilities under the Act.
 - (ii) A sign shall be prominently displayed inside the premises, which identifies by name the manager on duty or of the person responsible for the management of the sale and supply of alcohol under the licence.
- (h) The sale, supply and consumption of alcohol is authorised on the premises generally. The premises situated at 685A Karioitahi Road, Waiuku are more precisely identified in a plan date stamped as received by the Waikato District Licensing Committee on 3 April 2023.

[7] The licence may issue for a period of three (3) years upon payment of any outstanding fee.

[8] I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.
