

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**AND**

**IN THE MATTER** of an application by Omkaar Groups Limited for renewal of an off-licence pursuant to s.127 of the Act in respect of premises situated at 61 Devine Road TAMAHERE known as “Tamahere Four Square”.

**DECISION**

[1] I have before me an application by Omkaar Groups Limited for a renewal of an off licence in respect of premises situated at 61 Devine Road TAMAHERE known as “Tamahere Four Square”.

[2] The general nature of the business to be undertaken for the premises is that of a grocery store.

[3] Reports on the application were received from an Inspector, Medical Officer of Health and the Police and offer no opposition.

[4] The application was duly advertised and did not attract any public objection.

[5] I am satisfied as to the matters which I must have regard as set out in s.105 of the Act, and I am satisfied that the application meets the purpose and object of the Act. Accordingly, I grant the applicant a renewal of the underlying on licence with the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
- (b) No alcohol may be sold other than-
  - (i) beer that complies with the appropriate New Zealand food standard for beer; or
  - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - (iv) grape wine that that complies with the appropriate New Zealand food standard for grape wine; or
  - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (c) Alcohol may be sold while the premises are operating as a grocery store, but only on the following days and during the following hours:  
**Monday to Sunday 7.00am to 8.30pm**
- (d) The area delineated on the attached plan, dated 13 March 2019, is the only area permitted for the display and promotion of alcohol.

- (e) Drinking water must be freely available to customers at the following places while alcohol is being supplied free as a sample on the premises.  
Within the designated single alcohol area and immediately adjacent to where the samples are being provided.
- (f) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
- (i) Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (g) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
- (i) All staff will be trained in their responsibilities under the Act.
  - (ii) A sign shall be prominently displayed inside the premises, which identifies by name the manager on duty responsible for the management of the sale and supply of alcohol under the licence.
- (h) The sale or delivery of alcohol is authorised on the premises generally. The premises situated at 61 Devine Road, Tamahere, are more precisely identified in a plan date stamped as received by the Waikato District Licensing Committee on 13 March 2019.

[6] The licence may issue for a period of three (3) years upon payment of any outstanding fee.

[7] I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.
