

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**IN THE MATTER** of an application by Ngaruawahia Golf Club Incorporated pursuant to s.138 of the Act for a special licence in respect of premises situated at 5925 Great South Road NGARUAWAHIA known as "Ngaruawahia Golf Club".

**DECISION**

[1] I have before me an application by Ngaruawahia Golf Club Incorporated for a special licence in respect of premises situated at 5925 Great South Road NGARUAWAHIA known as "Ngaruawahia Golf Club".

**Fonterra Corporate Golf Day - Presidents Cup 2/6/2023**

[2] The inspector has filed a report on the application and does not oppose the granting of the special licence. The Police and the Medical Officer of Health have offered no opposition to the granting of the special licence.

[3] The application is for a golf event.

[4] For the purpose of this licence the licensed area (premises) is as defined within the site plan submitted with the application.

[5] The following conditions will apply to the licence:

- a) Alcohol may be sold under the licence only on the following days and during the following hours: **Friday, 2 June 2023 from 9.00am to 4.00pm**
- b) A reasonable range of food appropriate to the event shall be available during the hours of this licence.
- c) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold and supplied under the licence, a reasonable range of non-alcoholic refreshments and low alcoholic beverages.
- d) Drinking water is to be freely available to attendees at the bar and kitchen servery and from the BBQ station on the 10th tee.
- e) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - i. Ensure that no intoxicated persons are allowed to enter or to remain on the premises.

- ii. Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons adjacent to every point of sale.
- iii. Ensure that appropriate signs are prominently displayed detailing information about alternative forms of transport from the premises including provision of a courtesy vehicle to transport patrons from the premises.
- f) A minimum of one certificate holding manager is required to be on site and on duty to manage the conduct of the sale and supply of alcohol during the hours of this licence.
- g) The whole of the premises is undesignated.
- h) (k) For the purposes of the event, and for clarity, the licensed premises for the event includes all levels of the 'clubhouse', the outside alfresco area, and the Spig Bar area. The plans submitted and received by the Committee on 23 February 2023 outline the licensed premises in more detail.

[6] I am satisfied as to the matters to which I must have regard in s.142 of the Act, and I am satisfied that this application meets the purpose and object of the Act. Accordingly, I grant the special licence which may issue immediately.

[7] A copy of the licence is to be publicly displayed at the bar.
