**DECISION**

- 1) I have before me an application by Saints Public House Limited for the renewal and variation of an on licence in respect of premises situated at 571 Horotiu Road TE KOWHAI known as "Saints Public House".
- 2) The general nature of the business undertaken is that of a restaurant and function centre.
- 3) The variation relates to enable the premises to be licensed as a restaurant and function centre.
- 4) The application was duly advertised and did not attract any public objection.
- 5) Reports on the application were received from an Inspector, Medical Officer of Health and the Police and offer no opposition.
- 6) I am satisfied as to the matters which I must have regard as set out in s.105 of the Act, and I am satisfied that the application meets the purpose and object of the Act. Accordingly, I grant the applicant a variation and renewal of the underlying on licence with the following conditions:
  - (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
  - (b) Alcohol may be sold only while the premises are being operated as a restaurant, and only during the following days and hours:  
**Sunday to Wednesday 8.00am to 10.00pm**  
**Thursday to Saturday 8.00am to 11.00pm**

**AND**

On such days and during such hours as the premises or part of the premises is hosting a private reception, function, or other social gathering but not other than on the following days and hours:

**Sunday to Wednesday 8.00am to 10.00pm**

**Thursday to Saturday 8.00am to 11.00pm**

- (c) Food must be available for consumption on the premises at all times when the premises are open for the sale of alcohol in accordance with the menu submitted with the application for the licence, or variations of that menu of a similar range and standard.
- (d) The licensee must have available for consumption on the premises, at all times when alcohol may be sold under the licence, a reasonable range of non-alcoholic and low-alcohol beverages.
- (e) Drinking water must be freely available on all occupied tables
- (f) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
  - i. Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (g) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
  - i. All staff will be trained in their responsibilities under the Act.
  - ii. A sign shall be prominently displayed inside the premises, which identifies by name the manager on duty or of the person responsible for the management of the sale and supply of alcohol under the licence.
- (h) The licensee and staff shall adhere to the Noise Management Plan submitted with the application on 21 September 2021. Any proposed significant changes to the Plan shall be submitted to and approved by the Committee prior to implementation
  - (i) The sale, supply and consumption of alcohol is authorised on the premises generally. The premises situated at 571 Horotiu Road, Te Kowhai, are more precisely identified
- (j) in a plan date stamped as received by the Waikato District Licensing Committee on 1 September 2021.
- j) The whole of the premises shall be undesignated.

6) The renewal to the underlying licence may issue immediately upon payment of any outstanding fee.

7) I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.
