DECISION

[1] I have before me an application by Harrier Springs Distillery Limited for an off licence in respect of premises situated at 66B Jericho Road, Pukekohe East known as "Harrier Springs Distillery Limited".

[2] The general nature of the business to be undertaken for the premises is that of remote sales.

[3] The premise is as defined within the site plan submitted with the application and most recently date stamped received by the Waikato District Council on 21 November 2025.

[4] Reports on the application were received from an Inspector, the Medical Officer of Health and the Police and offer no opposition.

[5] The application was duly advertised and did not attract any public objection.

[6] I am satisfied as to all matters which I must have regard as set out in s.105 of the Act, and I am satisfied that the application meets the purpose and object of the Act. Accordingly, I grant the applicant an off licence with the following conditions:

- (a) Section 49 of the Act provides that a remote sale of alcohol may be made at any time on any day.
- (b) No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1:00 pm on Anzac Day.
- (c) Alcohol may be delivered under the licence only on the following days and during the following hours: **Monday to Sunday 7:00 am to 7:00 pm**
- (d) The sale of alcohol is restricted to premium spirits manufactured on the premises situated at 66B Jericho Road, Pukekohe East, and associated premium spirit gift packs.
- (e) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:

- (i) Request age declaration from all customers before orders are placed and after the sale is completed in accordance with Regulation 14 of the Sale and Supply of Alcohol Regulations 2013.
- (f) The following information must be displayed on the internet site in a prominent place, in any catalogue used by the licence holder and on every receipt issued for any alcohol sold via the internet site:
 - (i) The licence holder's name
 - (ii) The licence number, and
 - (iii) The date on which the licence expires.
- (g) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
 - (i) All staff will be trained in their responsibilities under the Act.
- (h) The sale or delivery of alcohol is authorised on the premises generally. The premises situated at 66B Jericho Road, Pukekohe East, are more precisely identified in a plan dated and stamped as received by the Waikato District Licensing Committee on 21 November 2025.

[7] The licence may issue upon payment of any outstanding fee.

[8] I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.
